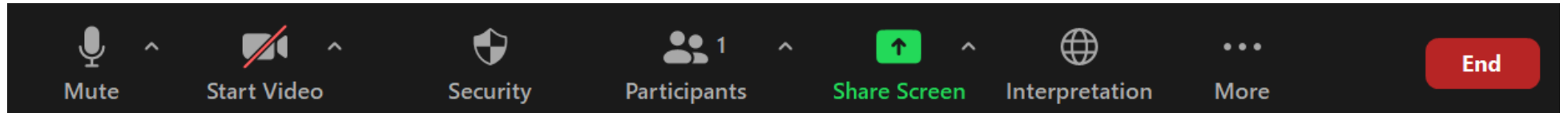

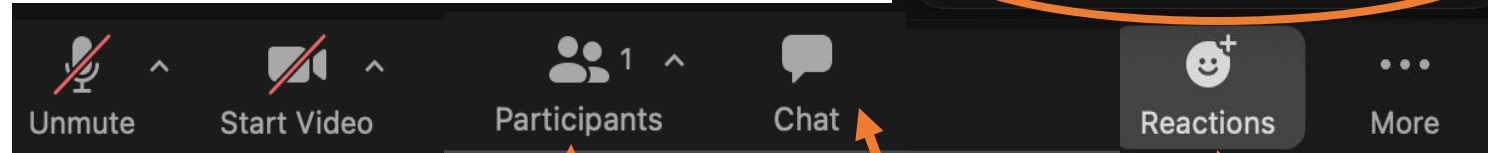

Air District Overview and Background

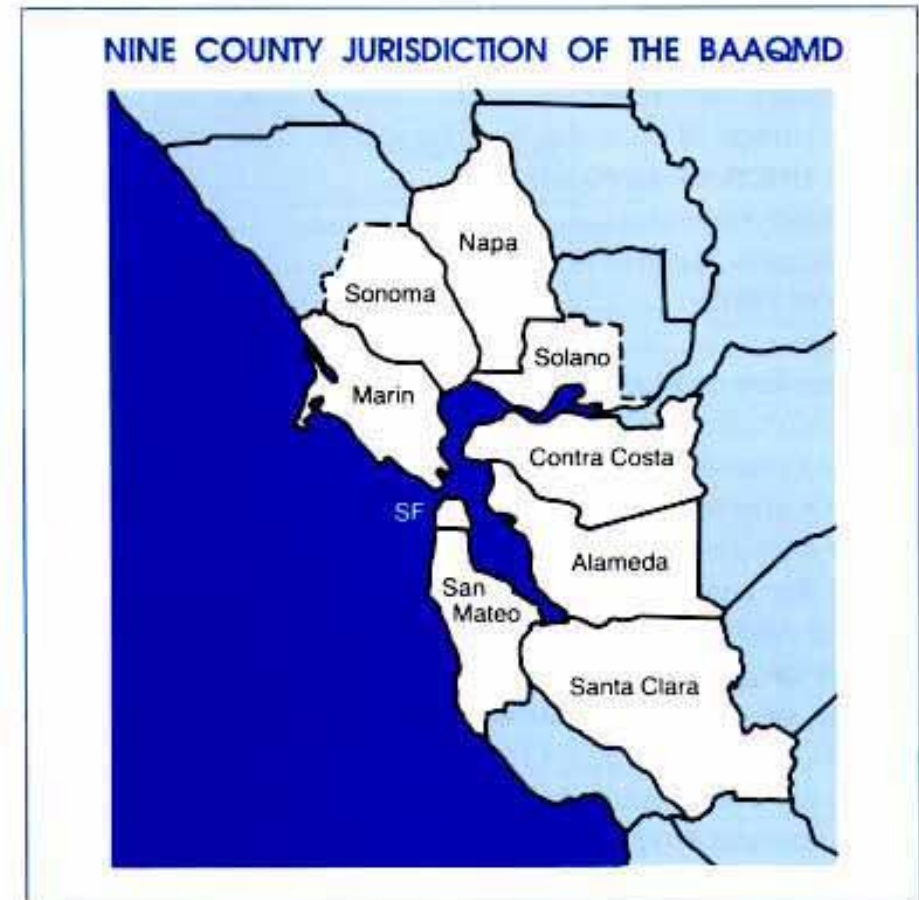


The California Legislature created the Air District in 1955 as the first regional air pollution control agency in the country.

The Air District is tasked with regulating stationary sources of air pollution in the nine counties that surround San Francisco Bay

The Air District is governed by a 24-member Board of Directors composed of locally elected officials from each of the nine Bay Area counties. The

The Air District aims to create a healthy breathing environment for every Bay Area resident while protecting and improving public health, air quality, and the global climate.



What is the Community Air Protection Program (AB 617)



- Originated in negotiations regarding the extension of Cap & Trade program (AB 398)
- AB 617 signed into law in 2017

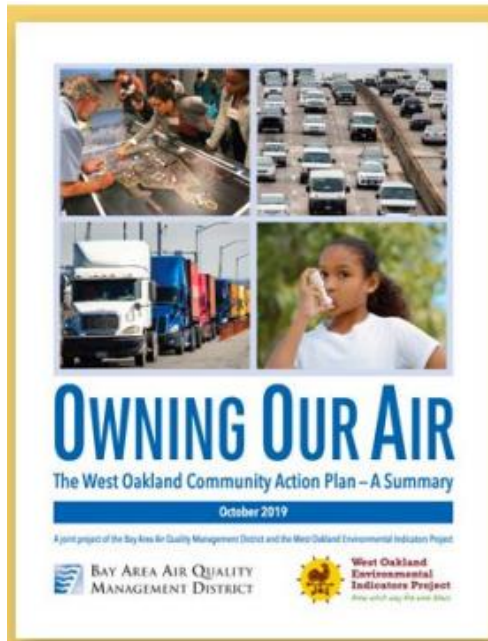
Main purpose - reduce emissions beyond what is required by existing law

- Responds to advocates' concerns for high levels of air pollution in historically disadvantaged communities
- Directly addresses toxics and criteria pollutants in these most impacted communities
- Initial communities serve as statewide models



AB 617 Efforts in Our Region

- 9 communities were identified as potential AB617 communities
- 3 communities selected for Community emission reduction Planning (on-going)
- Focus on community-driven plans, public engagement and education



What is a Community Emissions Reduction Plan (CERP)?

- ✓ **Improves** understanding of air pollution concerns by partnering with community, building shared knowledge & completing technical analyses
- ✓ **Sets** specific & quantifiable goals to reduce air pollution emissions and exposure
- ✓ **Accelerates** action through solutions that address underlying causes of injustice & inequities
- ✓ **Commits** to implementation & measuring progress

A CERP Involves Multiple Partners Working Together...

- **CERP Co-leads** – Work directly with Air District to coordinate CERP process including bringing in technical analyses, data & research, & admin. Support
- **Community Steering Committee (CSC)** – Sets vision, identifies key issues, designs strategies & oversees process to develop the CERP
- **Community Members** – Bring lived experience & wisdom to CSC to identify community concerns, develop vision & strategies
- **Local Government Agencies** – Includes City, County, Ports that can contribute expertise, guidance & have local land-use authority for implementation of plan strategies
- **California Air Resources Board (State)** – Provides technical support and resources for AB617

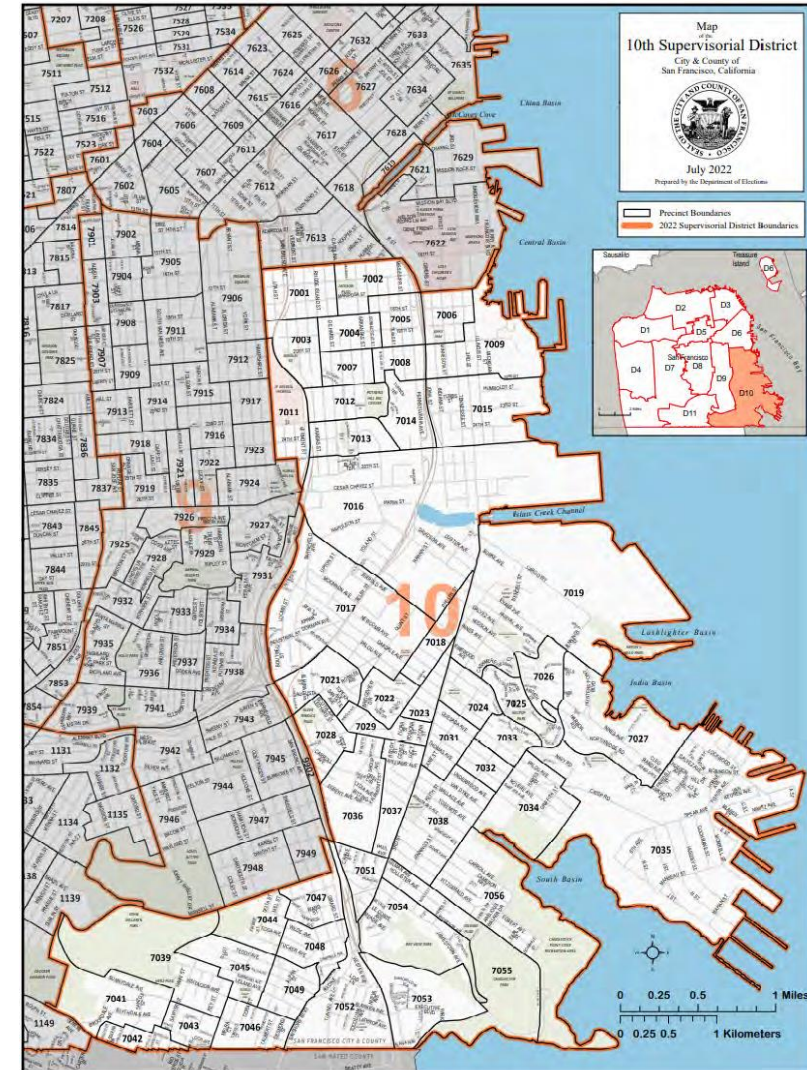

Proposed Area and Selection Timeline



- **August 2022** - Co-leads present SE Council on proposal to get feedback
- **August 31 and September 15, 2022** - Co-leads hold BVHP community meetings on proposed self-nomination.
- **October 6, 2022** - Presentation to the Community, Equity, Health and Justice Committee on recommendation to select BVHP
- **October 27, 2022** – Public Workshop on AB 617 and Bayview Hunters Point Nomination
- **November 2, 2022** – Board of Directors consider resolution for selection of Bayview Hunters Point for development of a CERP
- **February 22, 2023** - Air Resources Board votes on nomination

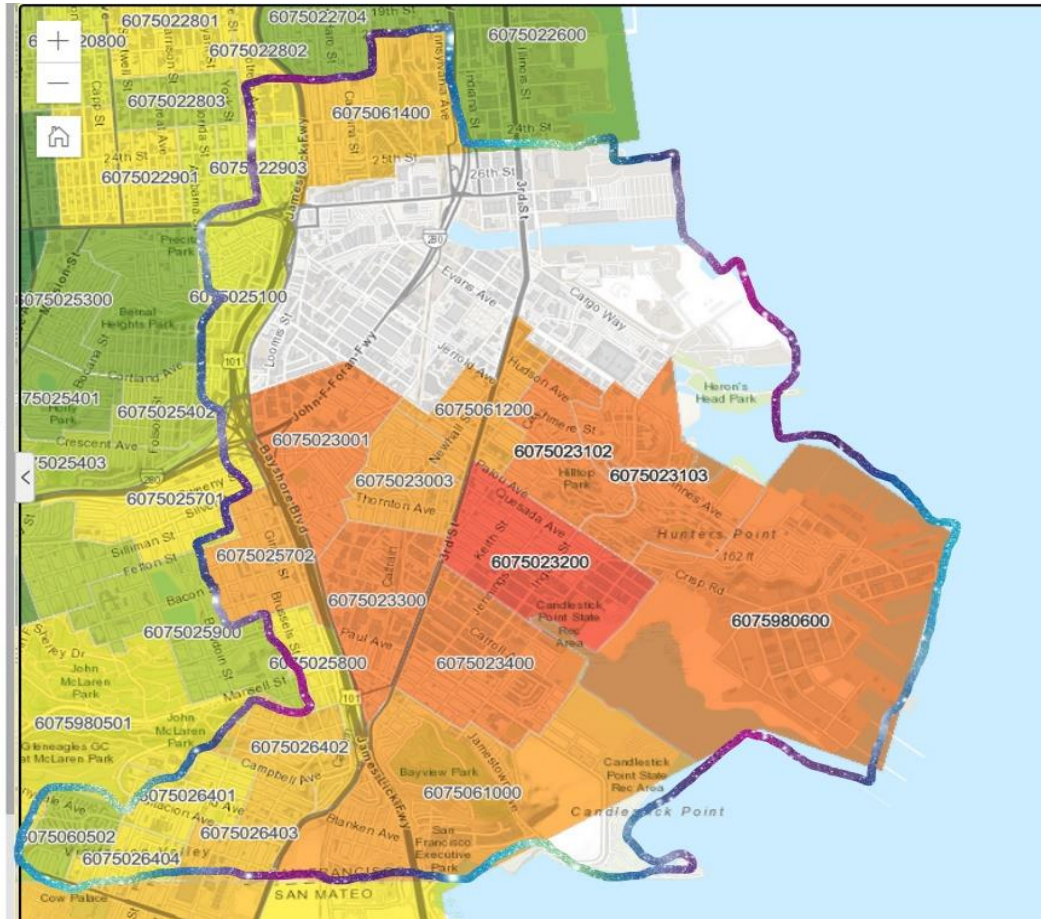

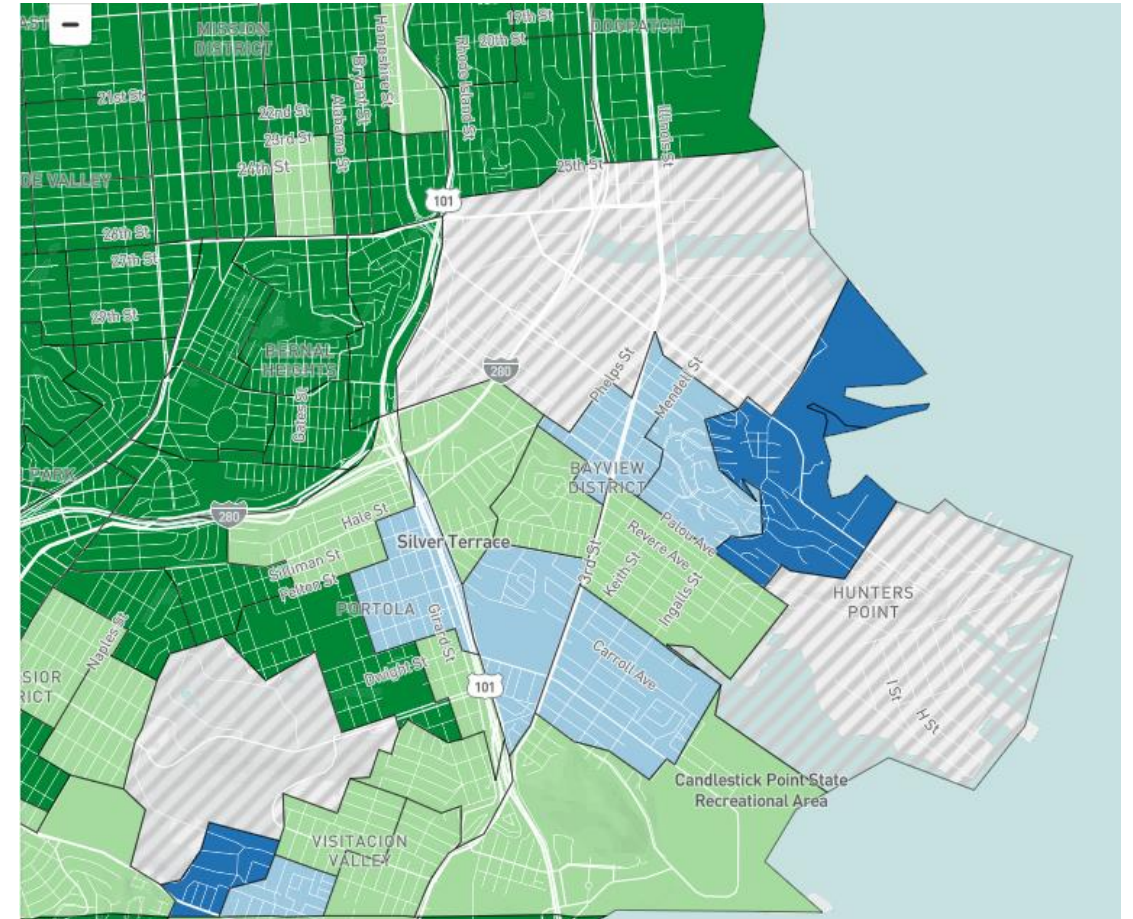

CalEnviroScreen (CES) 4.0 Map of disadvantaged census tracts

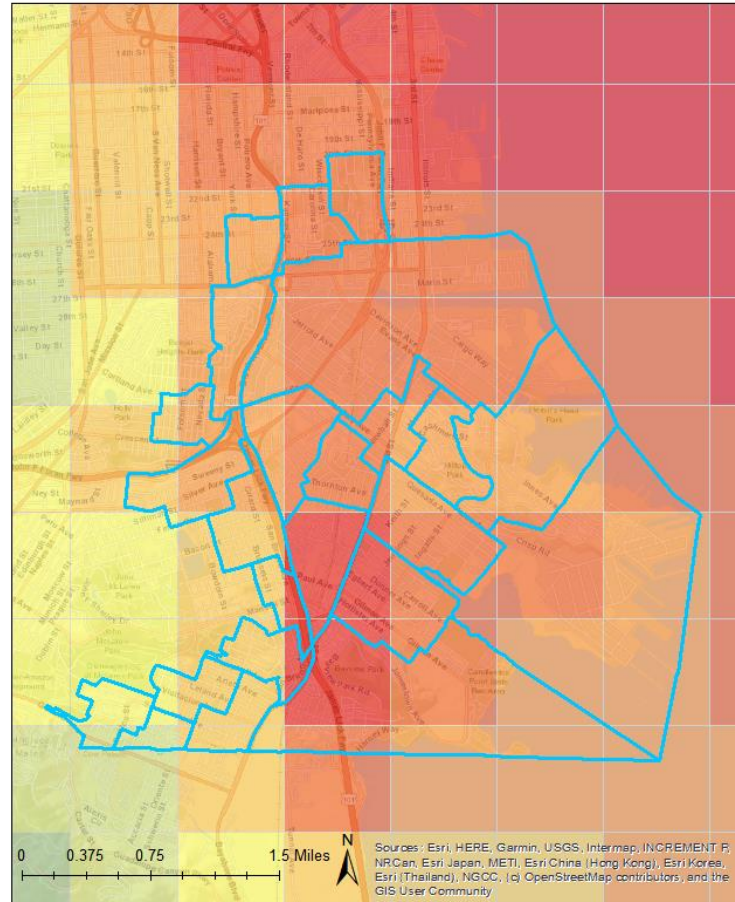
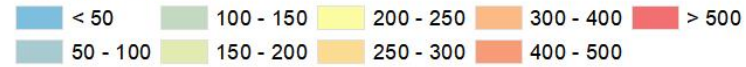


Calif. Healthy Places Index (HPI) 3.0 of cumulative health indicators by census tract
