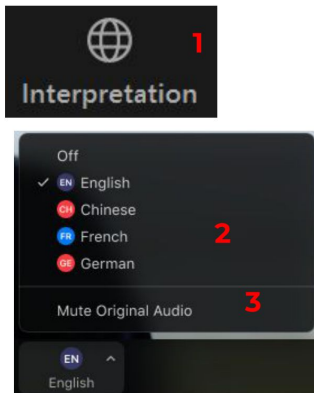

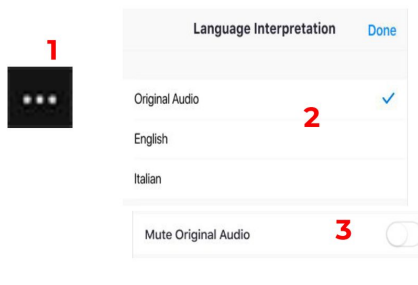

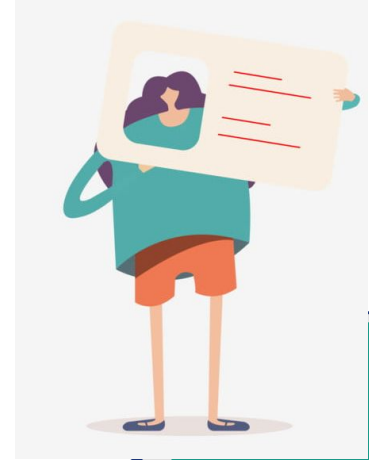

# APPROVED by the CSC: Roles & Responsibilities of Steering Committee Co-Chairs

- Provide CSC leadership and guidance along with CBE staff
  - 1-2 orientation meetings with Air District & CBE staff & Just Cities
- Help plan CSC agendas, facilitate breakout sessions and discussions
  - Meet multiple times per month with Air District & CBE staff to prepare for CSC meetings (including agendas) (about 5 hours of meetings per month *in addition* to monthly CSC meetings)
- Provide direction for Air District & CBE to develop Community Emissions Reduction Plan
- If you miss 2 consecutive Co-Chair meetings, another Co-Chair will be selected.



Additional stipend of \$75 per/hr for each Co-chair to compensate for participation in meetings

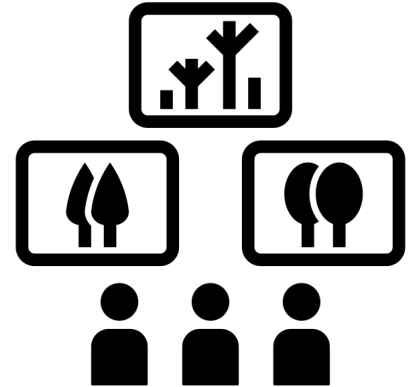

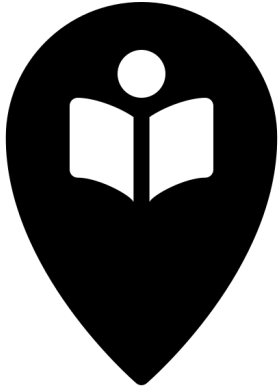

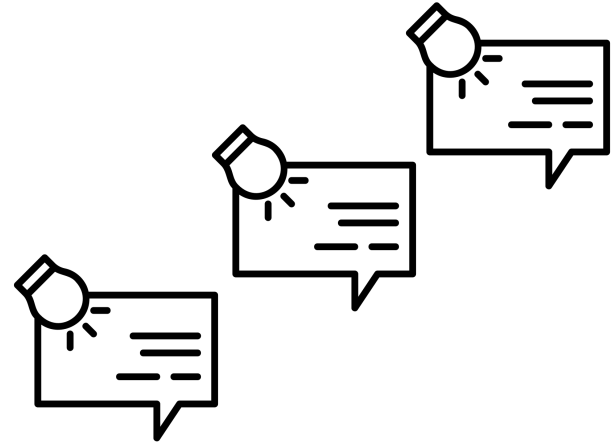

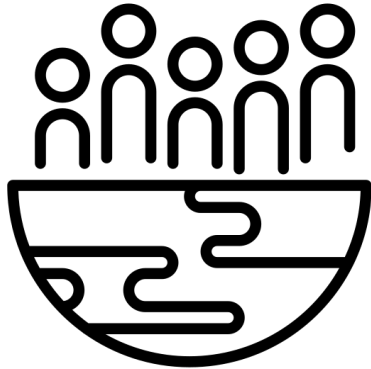

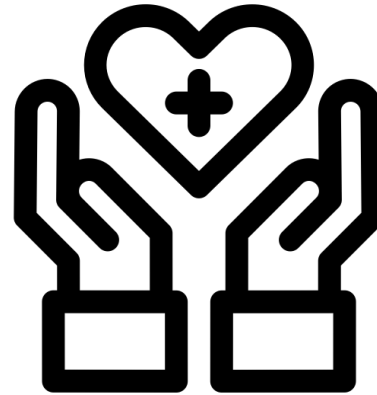

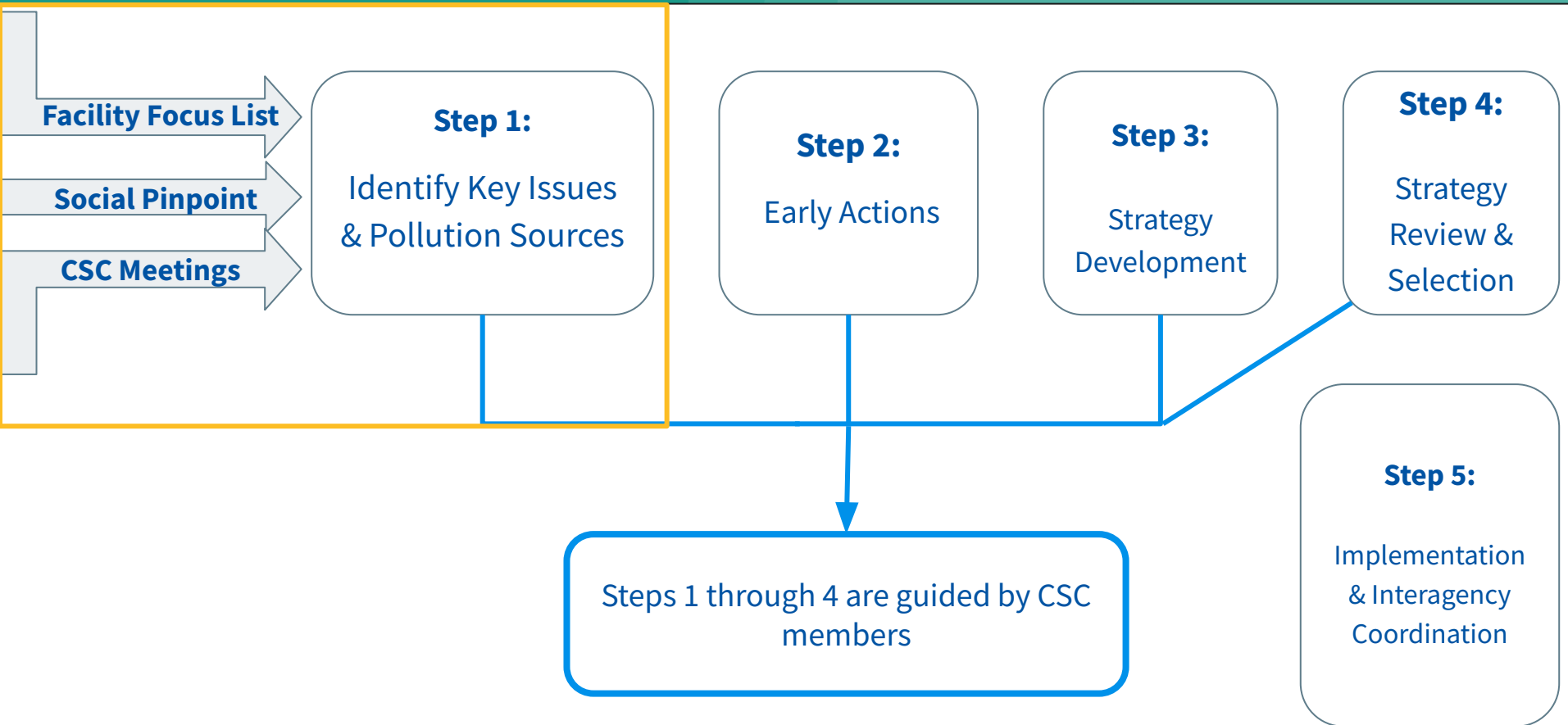
- Community-informed through several different community inputs
- Aims to address long-standing, local community issues
- Deliver Early Actions, when possible
- Develop strong, actionable strategies in the CERP with clear and measurable targets

# Step 1) Facility Focus List

- **Overview**
  - Developed based on CBE member input, campaigns & research
  - Not intended to be a comprehensive list of pollution sources
    - Will grow with input from CSC and Social Pinpoint
- **Problem Statements** identify specific pollution concerns about a facility
- **Early Actions** directly address a problem statement

# Step 1) Facility Focus List

- Examples
  - **AB&I Foundry** (proposed warehouse redevelopment)
  - **Argent Materials** (concrete and asphalt recycling)
  - **East Bay Crematory** (98th Avenue)
  - **Gallagher & Burk** (asphalt manufacturing plant)
  - **Sterling Environmental** (asbestos abatement & hazardous waste transporter)
  - **Oakland Airport** (specifically the proposed expansion)
  - **R&A Trucking** (logistics and transportation)

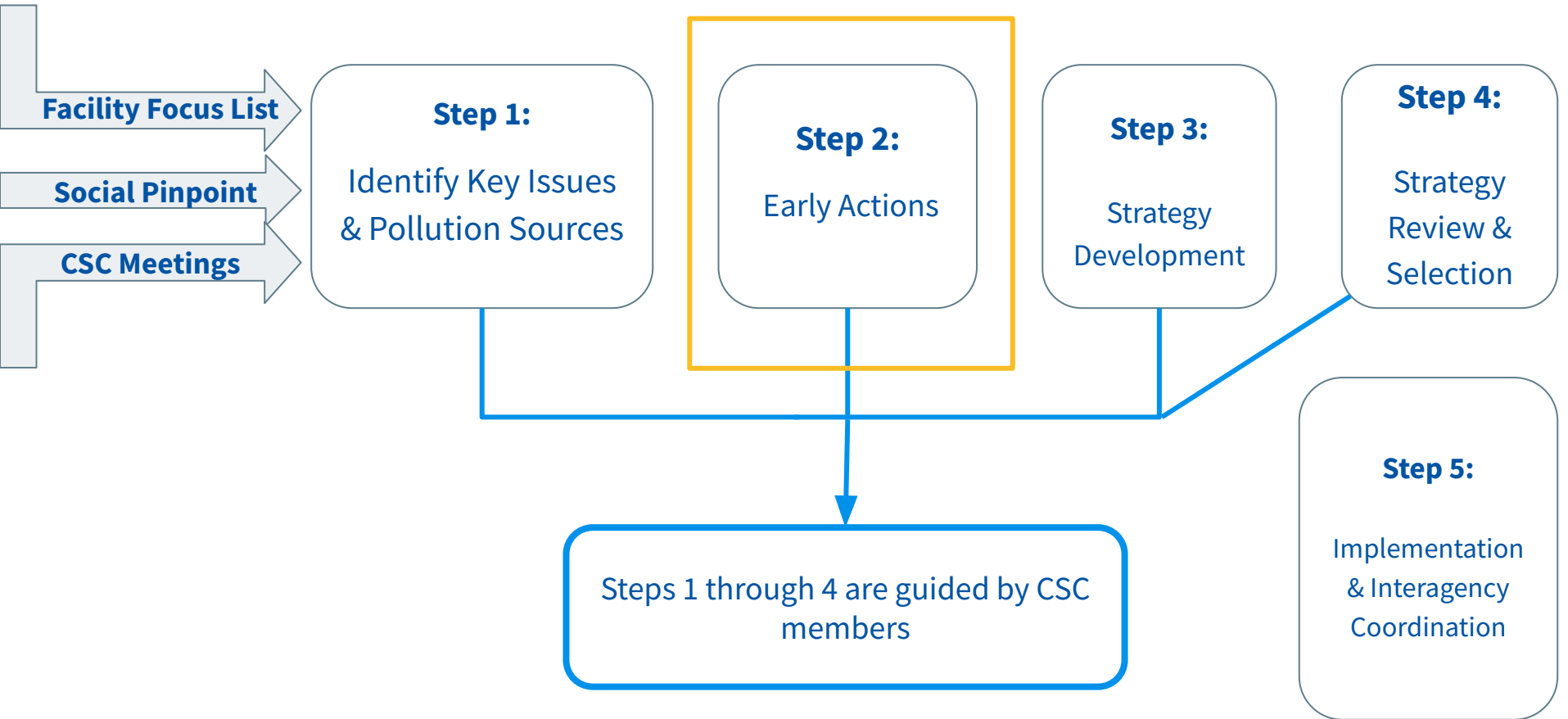
# Step 1) Social Pinpoint

- **Expanding opportunities** for East Oakland community members to engage in the CERP development by mapping and commenting about points of value and concern
- Map inputs will be used to:
  - Help inform early actions & strategy development
  - Check for any major gaps in CERP strategies
- More information to be shared at the August CSC meeting

# Step 1) CSC Meetings

- **Information gathering** from CSC meetings:
  - Topical presentations
    - E.g. Emissions inventory results, Health Inequities presentation from Alameda County
  - CSC discussion
- **CSC prioritizing** community concerns for strategy development

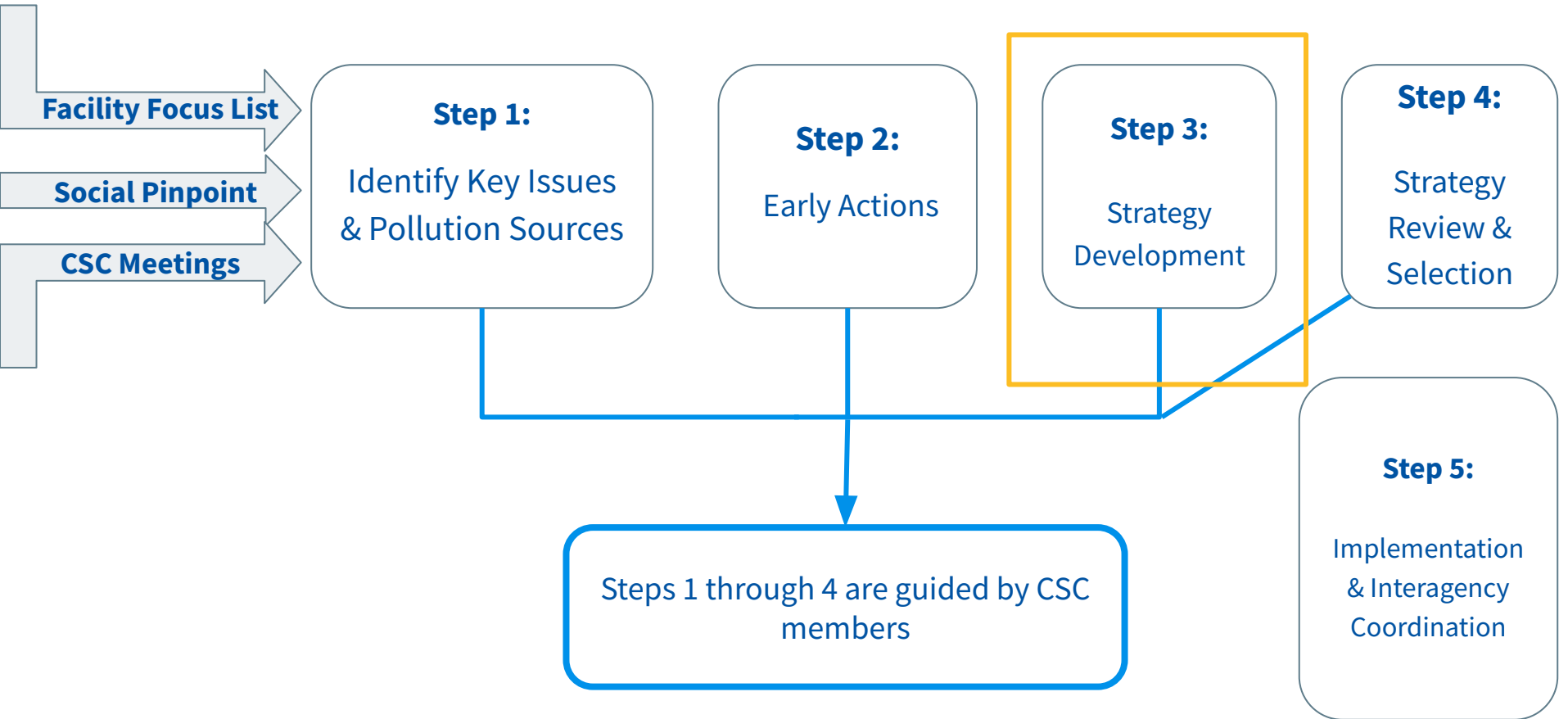
## Step 2) Early Actions

- **Early Actions** are actions that could be taken right away to address a community concern rather than waiting for an emissions reduction strategy to be implemented
- Gathered from the Facility Focus list, CSC input, & Social Pinpoint
- Evaluated by CSC and co-leads to determine which to prioritize & focus on

  - Asking to hear your concerns about pollution to develop additional Early Actions

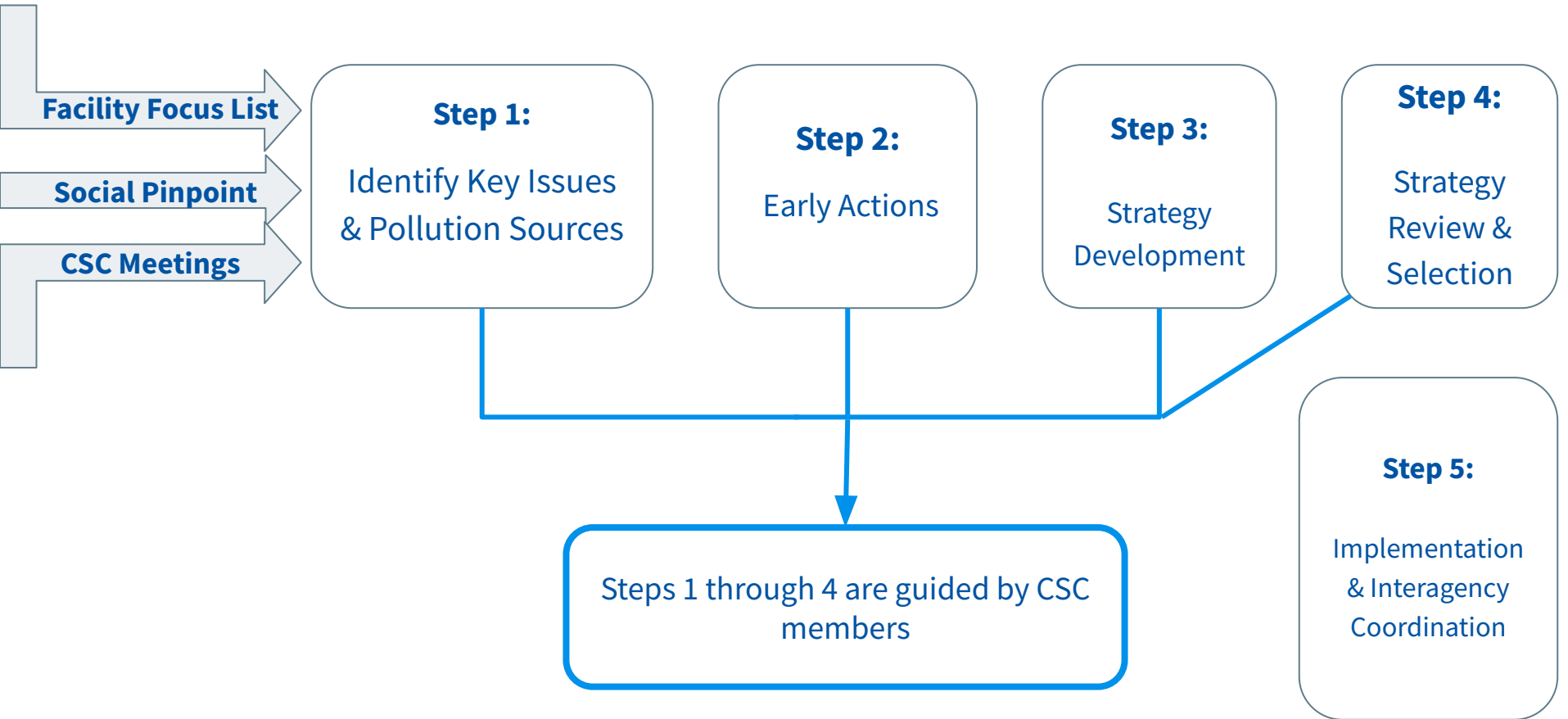

# Step 3) Strategy Development

- CSC will be deeply involved in prioritizing which pollution sources to focus on for strategy development
- Strategies may either be
  - a. Drafted newly by the CSC
  - b. Adapted from other existing AB 617 strategies, community planning documents (e.g. Oakland General Plan)
- **Goal is to develop strong, actionable strategies with measurable targets**

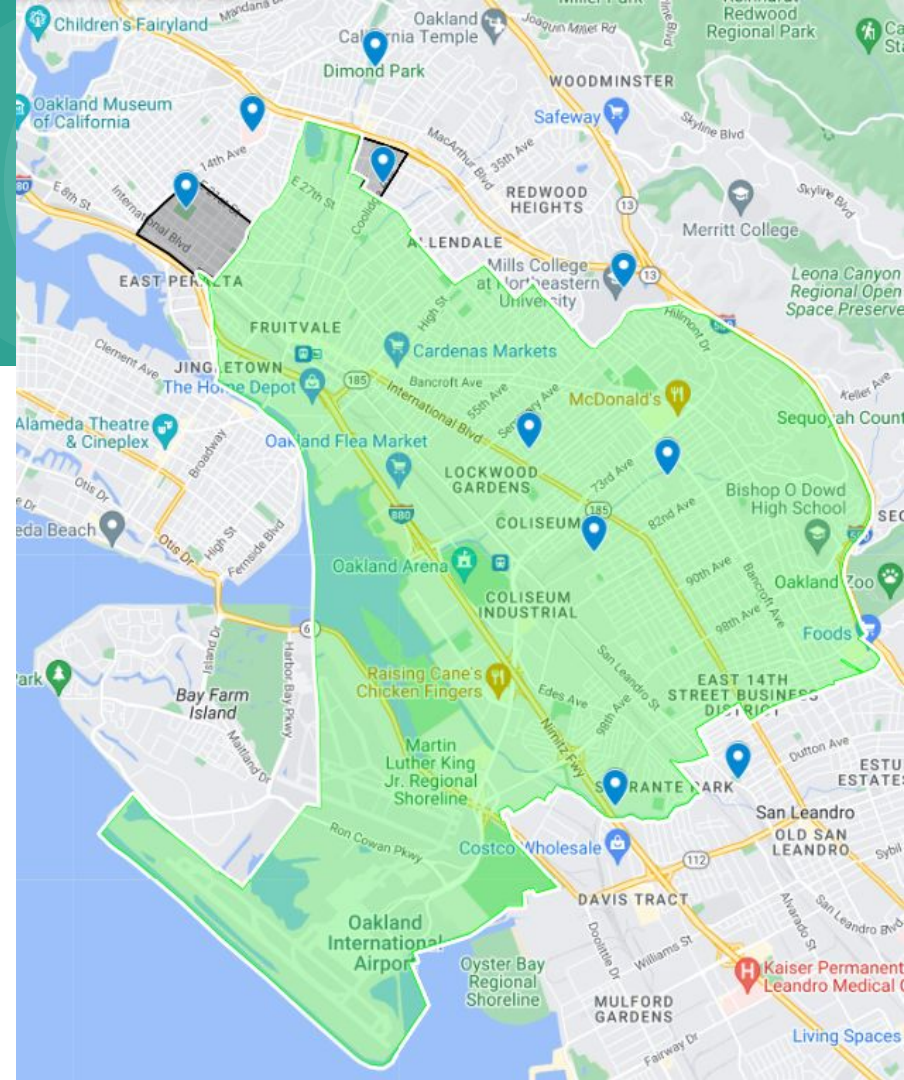
# CERP Community Boundary and Feedback Recap

  - May's #8 and June's #9 Steering Committee Meetings and by email.



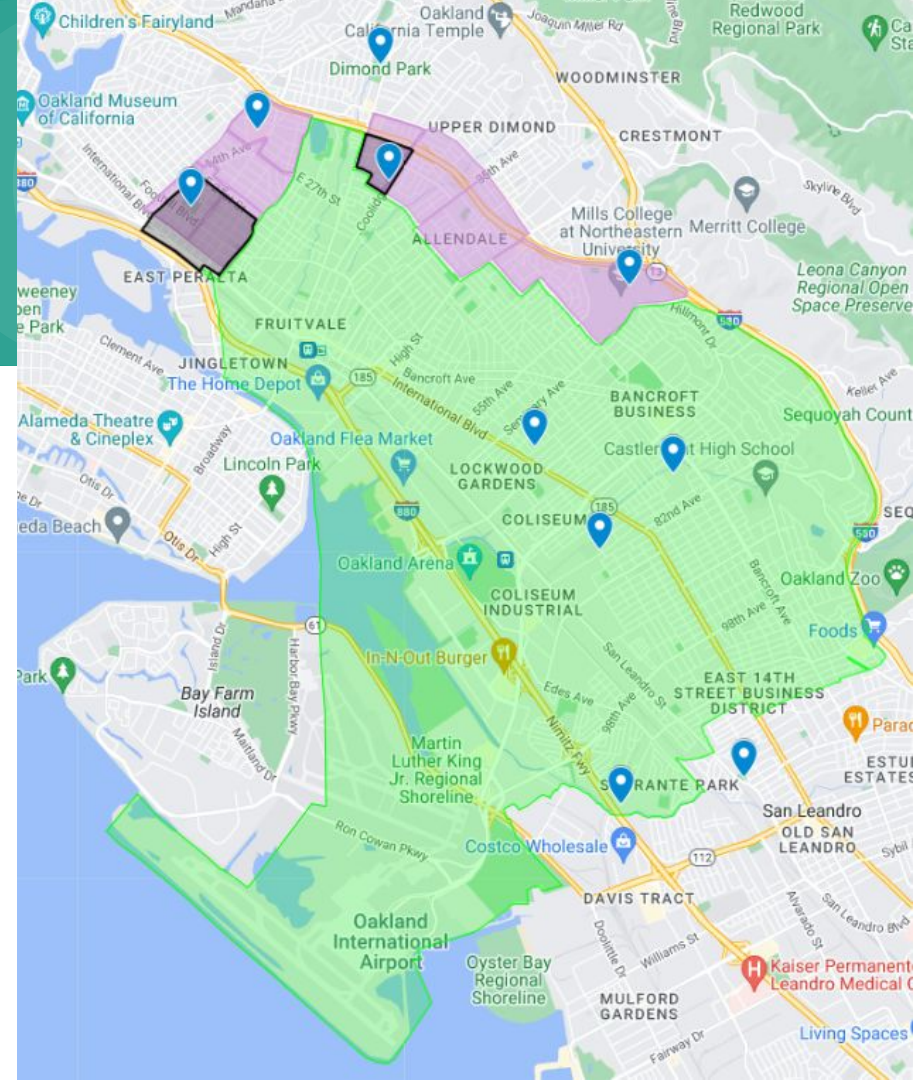
# Steering Committee Feedback on the CERP Community Boundary

  - Dimond Park
  - Mills College

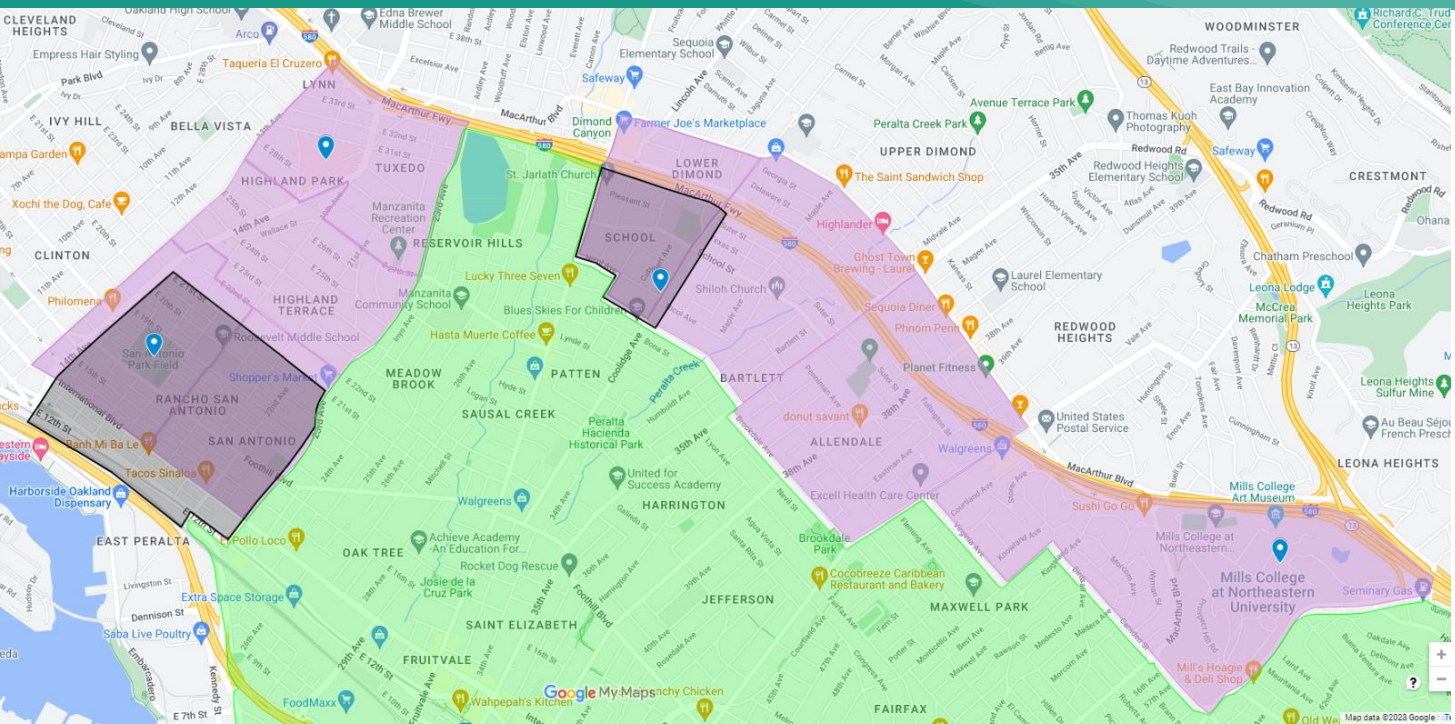


# Revisions made to the CERP Community Boundary

- Started with CERP Community Boundary (in green).
- Updates made (in purple):
  - Incorporated Steering Committee-identified community assets and areas and aligned to census tracts.
  - Aligned to adjacent census tracts to fill in gaps along the I-580 corridor.

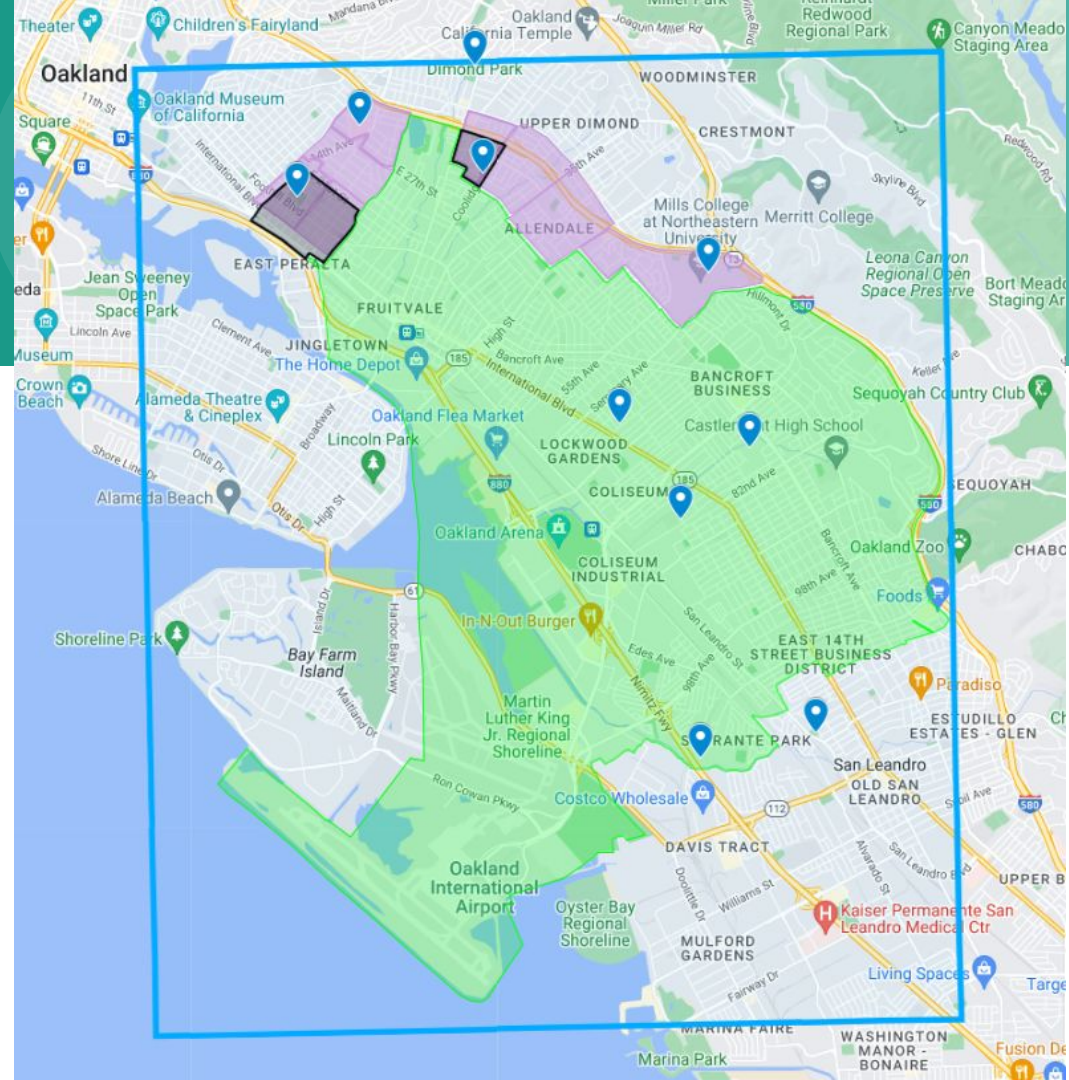

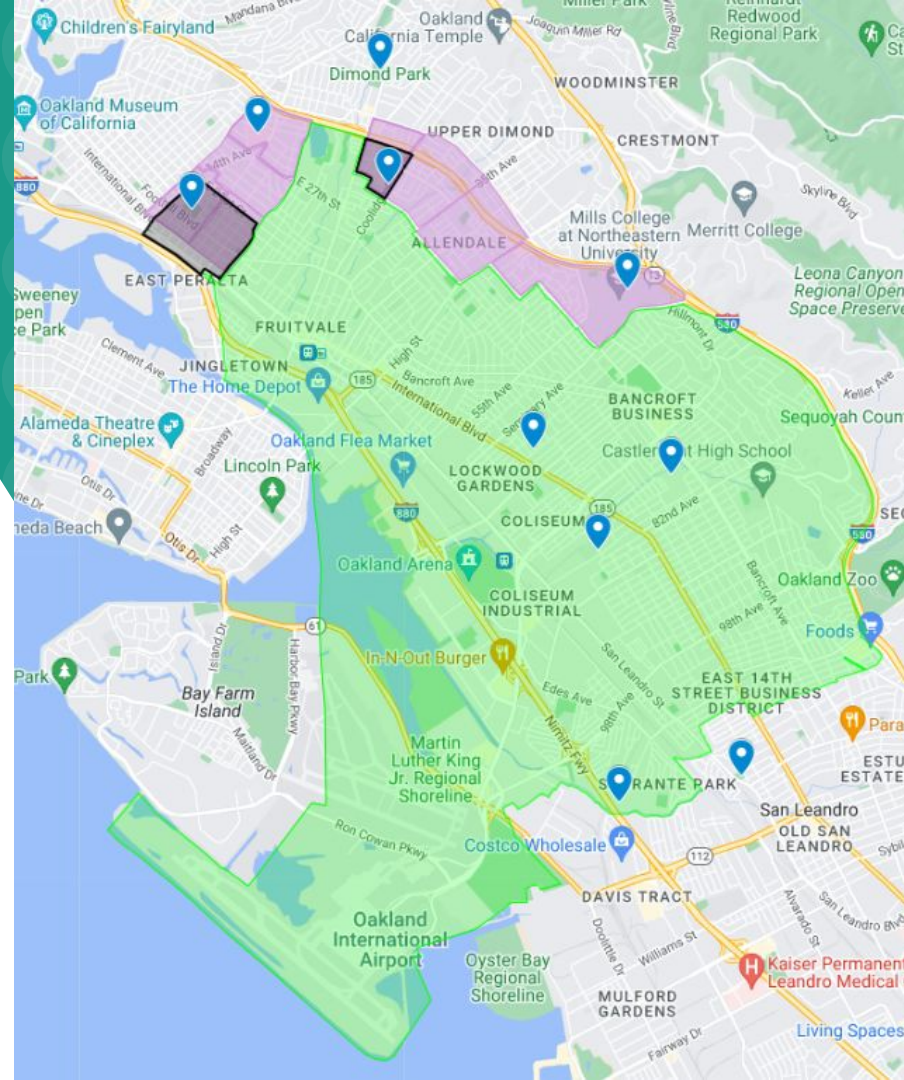
# CERP Boundaries and Emission Inventory
