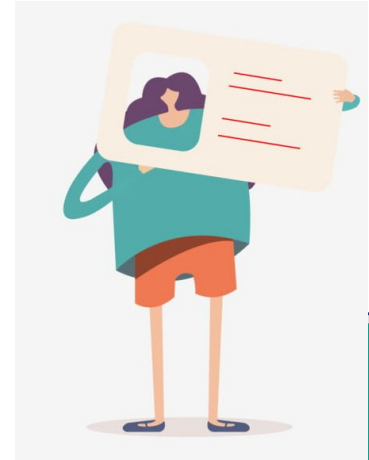

# Purpose of the CERP

Assembly Bill 617 (C. Garcia, Chapter 136, Statutes of 2017) requires the development of a Community Emissions Reduction Plan (CERP) to reduce the emissions of toxic air contaminants and criteria pollutants in the most heavily burdened communities.

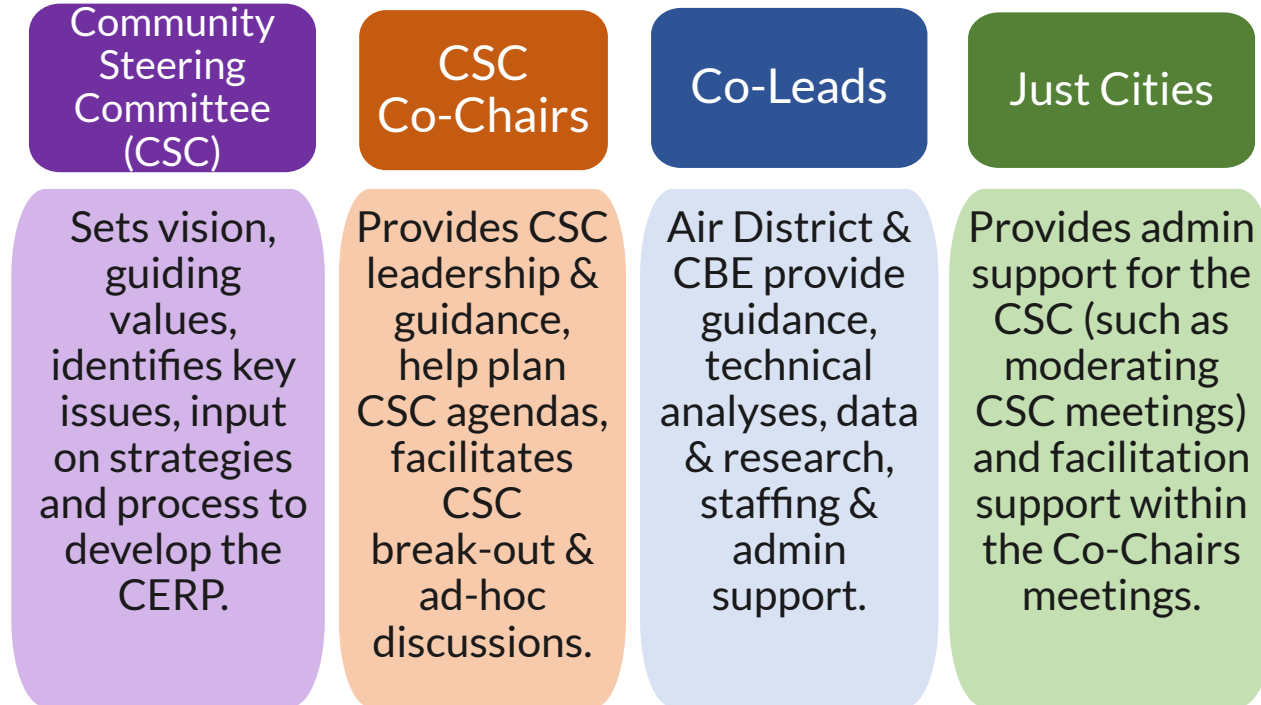
The purpose of the East Oakland CERP is to develop a 5-year plan including strategies to address long standing air quality challenges in East Oakland.

  - a. For instance, the Air District can hold a meeting to answer CSC members' questions & keep a Google Doc of questions & answers
2. How can we improve facilitation/presentations?
  - a. How do you think timing can be improved with presentations?
3. How do CSC members want to give feedback?
  - a. Is the Google Form for feedback useful?
  - b. Is calling preferred for feedback from members?
    - i. If you would like to be called and followed up with, how often?
4. Do we want to have some meetings hybrid and some remote?
  - a. Note: hybrid meetings would be technologically difficult to execute with many different breakout rooms
