Objectives of June CSC #20's Commercial & Industrial Sources Presentation & Activity

- To understand sections of the Permitted Emissions Inventory Report Document: categories of pollutants, breakdown of East Oakland's Top Permitted Polluters and where they are located.
- To understand what Communities for a Better Environment (CBE) is currently doing to address pollution from Commercial & Industrial Sources as well as learning about how community organizing can make an impact on these polluting industries such as AB&I Foundry.

What is the Built Environment and Land Use?

- The Built Environment is everything we build or modify to create places where we live, work, and play.
- Land Use describes how people use land for different purposes or activities.
 - Cities and counties regulate land use through zoning. They issue permits based on the activities and facilities allowed under these regulations.
- The Built Environment has a direct impact on air quality and our overall health and well-being.

What is the General Plan?

- "Constitution" for development and conservation.
- Establishes **citywide vision** with supporting goals, policies, and implementation measures
- **Engages** Oakland community in the planning and decision-making process.
- Requires chapters or "Elements" on Land Use, Circulation, Housing,
 Conservation, Open Space, Noise, Safety, and Environmental Justice.



EJ Element Implementation in GPU, Phase 2


- EJ-1.1 Reduce the public's exposure to toxic air contaminants through appropriate land use and transportation strategies, identified through the Land Use and Transportation Element (LUTE) update in Phase 2.
- EJ-A.7 As part of the LUTE update in Phase 2, **evaluate** residential/industrial conflicts...ensuring adequate buffering between industrial and residential land uses through land use designations.
- EJ-A.8 As part of the LUTE update in Phase 2, explore modifications to truck routes and truck management in partnership with the Port of Oakland and West Oakland Environmental Indicators Project (WOEIP) and Communities for a Better Environment (CBE).

Environmental Justice (EJ) Element

- Adopted September 2023
- Includes goals, policies, and actions for reducing environmental burdens on Oakland's most vulnerable communities
- Identify EJ communities
- Reduce health risks in EJ communities
- Promote community engagement
- Prioritize improvements for EJ communities



EJ Element Goals



1. **Reduce pollution**, mitigate the impacts of pollution on existing sensitive land uses, and eliminate associated public health disparities.



2. Protect oakland water supplies from contamination.



3. Prevent, reduce and clean up **illegal dumping**.



4. Coordinate resources to improve housing quality and habitability.



Note: Other important housing policies addressing renter protections/anti-displacement, affordable housing production, homelessness, and other topics are included in the Housing Element



5. Support a **food system** that provides nutritious, affordable, culturally relevant, and affordable food to all oaklanders.

EJ Element Goals (Continued)



6. Support a network of **well-maintained community facilities** that are easily accessible, culturally supportive, and responsive to community needs.



7. Create environments that support **physical activity**, **recreation**, **and healthy lifestyles** through safe and comfortable and ADA-compliant walkable, bikeable neighborhoods, with **access to green space**, **trees**, **paths**, **and parks**.




8. Foster **meaningful civic engagement** and support community power- and capacity-building.



9. Expand **economic development**, income equality, and opportunity for all Oaklanders.



10. Prioritize improvements and programs that **meet the needs of environmental justice communities.**



Community Concern: Healthy Housing - Reducing air pollution at home

- Levels of indoor air pollution can be as high,
 and sometimes higher, than outdoor levels.
- Indoor air pollutants can include:
 - Secondhand smoke from cigarettes
 - Carbon monoxide from fireplaces and leaking chimneys, gas stoves and other household appliances.
- Outdoor air, including fine particles from wildfire smoke, can enter homes through windows, doors, kitchen fans, or other ventilation systems.

Community Concern: Land Use & Proximity to Pollution

- Sensitive Receptors in Proximity to Pollution Sources: The proximity of pollution sources to sensitive receptors, such as senior centers, schools, and community gardens, can have significant health and environmental impacts.
- Past Land Use Decisions & Incompatible Zoning: Environmental justice impacts of previous land use decisions. Previous land use decisions, based on outdated zoning rules, now conflict with current regulations or community priorities.

Community Concern: Urban Greening

- Creating more **green spaces** such as park and gardens.
- Building green infrastructure projects, such as green roofs, urban forests, and vegetative barriers planted near freeways.
- Improve air quality by filtering pollutants from the air, reducing particulate matter and other harmful contaminants.
- Plants also helps reduce greenhouse gas levels in the atmosphere.






