

CSC #24 (Nov Mtg) Recap

Recap of November's CSC #24 Introduction to Illegal Dumping, Trash & Odors Focus Area

- From the Social Pinpoint Project, there were 235 out of 398 comments from East Oakland residents who cited illegal dumping as an Air Pollution Concern
- The City of Oakland has authority to address illegal dumping
- There is 1 Air District regulation that is indirectly connected to illegal dumping. Regulation 5-301 prohibits burning (backyard burning, burning trash)
- The Air District can help address illegal dumping through:
 - Assisting the CSC in writing to the City of Oakland Public Works
 - Facilitating relationships & communication between government agencies
 - Reviewing what other AB617 communities have been able to accomplish with related issues

Recap of November's CSC #24 Built Environment & Land Use, Urban Greening and Transportation & Mobile Sources Presentation & Activity

- Air District staff reviewed how our Focus Area example actions were developed
- Air District staff went over examples of actions from other Community Emissions Reduction Plans (CERPs)
- CSC members completed an activity where they self-selected into two breakout rooms, two virtual and two in-person, to discuss example actions from 2 Focus Areas, Built Environment & Land Use and Transportation & Mobile Sources as well as 1 of our Cross-Cutting Themes, Urban Greening
 - CSC members reviewed example actions how they work, how they relate to strategy objectives and discussed prompted questions

Illegal Dumping: Public Health Research, City of Oakland Programs and Best Practices

Public Health Impacts of Illegal Dumping

- Contaminates soil, water and air
- Provides habitat for rodents and insects which often carry pathogens and disease
- Causes health and safety risks (toxic substances, sharp objects, etc.)
- Affects birds, animals, and plants through contamination and harmful bacteria in trash
- Link between higher rates of **depression** and related symptoms and garbage in neglected public spaces

Additional Impacts of Illegal Dumping

- Neighborhood disinvestment including the lack of proper waste management related to the rise in violent crime
- Prevents stormwater drainage and cause flooding
- Illegally dumped items can be fire hazards
- Diminishes property value and affects tourism
- Costs taxpayers a lot of money to clean up

- Public Works Illegal Dumping WebPage Contains an Overview of Oakland's Tools:
 - Oaktown PROUD education community campaign
 - Proactive monitoring and clean up of hot spots and illegal dumping corridors
 - Environmental Enforcement Officers officers that monitor communities to prevent and deter illegal dumping
 - Hotline and Website to report illegal dumping
 - Surveillance cameras for illegal dumping
 - Bulky pick up program (monthly free drop off day and annual free bulky waste pick up)
 - List of licensed haulers and list of permitted construction and demolition haulers
 - Penalties for illegal dumping

- Oakland Beautification Council
 - Non-profit established in 2014 by Ken Houston to address illegal dumping, graffiti vandalism & homelessness
- Keep Oakland Beautiful
 - A national non-profit organization, affiliate of Keep America Beautiful (KAB), built to engage community members taking responsibility for improving their environments. They receive grant money and donations from community members to (for example):
 - transform utility boxes into pieces of art
 - sponsor events to weed, mulch and water newly planted trees at several parks
 - build planter boxes along streets to beautify and prevent littering and reduce crime
 - create community gardens, and parklets
 - install murals around vacant property

- City of Oakland Programs to Address Illegal Dumping
 - Adopt-a-Spot
 - Allows Oaklanders to "adopt" an area to cleanup year-round intersections, parks, creeks, shorelines, streets, storm drains, trails, etc.
 - Adopt-a-Drain
 - Allows Oaklanders to "adopt" a storm drain year-round & clear it of debris
 - Neighborhood Bulk Block Party
 - Created in 2022 to establish community group partnerships to clean up areas with high levels of illegal dumping & to support community members who want to keep their neighborhood clean

- City of Oakland Programs to Address Illegal Dumping (continued)
 - Waste Collection & Education Pilot Program
 - Oakland Public Works created this pilot program to lessen illegal dumping by providing residents & business owners with larger trash containers and increased education, outreach & enforcement of mandatory requirements for commercial trash
 - Environmental Stewardship Team Program
 - This team supports civic engagement through programs, events, & collaboration, to bring community members together & provides resources for a sustainable Oakland

Statistics from the City of Oakland's Interactive Data Map Tool

- In 2022, only 32,720 (roughly 17.5%) of Oakland households took advantage of their free annual bulky junk pick-up. This means Oaklanders could have had an additional 617,005 cubic yards of material (imagine 56 Goodyear blimps full of junk) picked up for free at their doorsteps
- Bulky Junk Self Haul Service Use in 2022 In 2022, Oaklanders completed 1,559 bulky junk drop-offs, also called self-haul appointments. That's just 9% of the total available appointment slots. This means Oaklanders could have dropped off an additional 66,564 cubic yards of material (imagine 6 Goodyear blimps full of junk) for *free*

Illegal Dumping Resources Toolbox

- The Illegal Dumping Resources Toolbox is a joint effort by CalRecycle and the Illegal Dumping Technical Advisory Committee (IDTAC) and is a resource for strategies and best practices
- The Toolbox is structured around four essential elements that help combat illegal dumping, known as PACE, and other important topics
 - **Prevention**
 - Abatement
 - Cleanup
 - Enforcement

Examples of Best Practices

- Illegal dumping enforcement officers (Los Angeles)
- Surveillance; motion-detector cameras at various sites to catch illegal dumping; random remote video surveillance along with patrol (San Bernardino, Vallejo, Sonoma)
- Illegal dumping sting operations (Sacramento County)
- Tip line the public can call to report illegal dumping (Los Angeles County)
- Events: "Tour de Trash" where bicyclists located and recorded illegal dumping sites during rides (Sonoma)
- Free bulky item pick-up, hot-spot deterrents; enhanced homeless encampment clean-up (City of Richmond)

Examples of Best Practices

- The more money Texan cities spent on education and outreach for illegal dumping, the less they paid in abatement costs (Texans for Clean Water, 2017)
- California's Environmental Protection Agency initiated their Environmental Justice Task Force in the City of Stockton to address illegal dumping along with and federal and local partners. After several month of community meetings the Task Force identified the following actions:
 - Revise existing ordinances to update penalties for illegal dumping
 - Agreement between City and County to share funds to develop a unit dedicated to illegal dumping
 - Launch a local advertising campaign aimed at reducing illegal dumping and promoting its no-cost collection network



Recap of East Oakland Health Information



East Oakland experiences **disproportionately higher rates of health conditions** linked to air pollution, including higher rates of asthma, cancer, heart disease, and stroke.



Average life expectancy in East Oakland is among the shortest compared to other communities in Alameda County.



The East Oakland community faces barriers in the social and economic environment resulting in **barriers to income and wealth, and consequently health**.




Long-standing disinvestment has resulted in **fewer resources and weaker infrastructure to support health**.

Focus Area: Health Programs

Strategy Objective: Help the community access health services and educate the community about health risks, treatment, and prevention.

Draft Action #82: Advocate for expanded basic research on health impacts of Particulate Matter (PM)2.5 exposure and add basic research on Nitrogen Oxides (NOx), Sulfur Oxides (SOx), and Toxic Air Contaminants (TACs). Notify Air District and the WOCAP CSC when there are open calls for suggesting new research topics and help the CSC with understanding the research concept solicitation process. Provide updates, as requested by the CSC, on future research projects that address cumulative impacts.



Focus Area: Public Health and Reducing Exposure

<u>Strategy Objective</u>: Increase community members' access to relevant and accessible information so they can understand local air pollution problems, pollution reduction opportunities, health improvement goals, and the air pollution improvement initiatives currently planned or in development.

Action # H 5.1: Work with County Health Services to create a dashboard for health data and air pollution education materials.

<u>Action # H 5.2</u>: Work with health workers to deliver information on air pollution, health impacts, and mitigation opportunities.
