#### 4. **AD HOC UPDATES**

The Path to Clean Air Steering Committee and the public received updates on the active Ad Hoc working groups.

#### **Committee Comments**

Co-Chair Alfredo Angulo; Shared an update on the Problems to Solutions Ad Hoc. More than half the Ad Hoc has presented draft key issue statements and strategies to the Steering Committee and has incorporated their feedback. The next Steering Committee will hear from Industrial and Commercial Sources and Fuel Refining. The Ad Hoc is looking to further understand solutions that address cross-cutting themes. He shared ideas about how to foster community discussion outside of upcoming Steering Committee meetings such as restarting coffee chats.

Community Member Marisol Cantó; Reported an update on the Fuel Refining, Storage, and Distribution Ad Hoc meeting. The first collaborative meeting with steering committee members, community members, and BAAQMD staff was on October 5<sup>th</sup>. Twenty-three people signed up and ten people attended. The next meeting will be November 2<sup>nd</sup> focused on flaring events. She gave a shout out to Jeffrey Kilbreth, Lizbeth Ibarra, Michelle Gomez-Garcia, and Heidi Swillinger who attended the meeting and were able to voice concerns about the process not moving forward with the timeline planned and wanting to look at new strategies about how to reduce emissions. Anybody who is interested is encouraged to attend the next meeting.

BAAQMD Staff Kevin Olp; Confirmed that November 2<sup>nd</sup> meeting focused on flaring will be coled by five or six different Air District divisions. The Compliance Enforcement Division will primarily lead the November 9<sup>th</sup> focusing on "Accountability for the Fuel Refining Industry." Both meetings are 5:30-7:00pm.

# Committee Comments Segment 2

Committee Member Heidi Swillinger; Reported on Marine and Rail discussion and recommendations. She commented that CARB staff were helpful in providing good information.

Co-chair Alfredo Rafael Angulo; suggested creating working groups to meet with CARB to get a better understanding of the marine and rail regulations.

Committee Member Francisco Avila; suggested meeting with marine and rail operators to brainstorm and build relationships with them.

Committee Member Suzanne; suggested creating an outreach campaign to the community to share when there have been violations to put public pressure on the polluters. Other suggestions included reaching out to other cities in the area to advocate on regulations together and the creation of schools near marine and mail hubs.

Committee Member Dr. Omoniyi Omotoso; Reported on Addressing Public Health and Reducing Exposures discussion and recommendations. He shared that a cross-cutting theme was how to focus strategic planning on the most highly impacted groups or on the highest impact polluters. An example included leveraging existing programs with the City, County, or in the community that work to address food deserts and child asthma. He shared that there were ideas to move the electrification of facilities forward while also ensuring these efforts do not negatively impact small businesses and landlords. There was also a discussion about having a better real-time alert system to alert residents of air quality or pollution changes and how to raise awareness and access to the system.

Committee Member Jeff Kilbreth; Reported on Addressing Public Health and Reducing Exposures discussion and recommendations. He shared that the importance of having health goals was confirmed as central to the Committee's mission, now it is a matter of determining what those specific health goals are. Regarding food deserts, there was a discussion of how to strengthen our neighborhood markets since there is uncertainty about attracting new grocery stores offering fresh food. The concept of a data dashboard was an interesting discussion and will be a significant design task. There needs to be more discussion regarding whether it is intended for smartphones, tablets, or laptops.

Committee Member Francisco Avila; Commented on the polling function used in the breakout rooms and complimented how seamless and effective this tool was. He shared that going forward using a dashboard or mailer to collect community feedback will be important.

Committee Member Heidi Swillinger; Reiterated Francisco's comment about the polling function to allow all participants to weigh in.

Co-Chair Y'Anad Burrell; Commented on engaging community members and organizations in this process. For organizations that host large events, the Committee should think about whether there are opportunities to present or distribute information. At upcoming parades and convenings, the committee should consider how can we be a part of existing events to get people involved.

BAAQMD staff member Wendy Goodfriend; shared that the Board had an active discussion about Prop 30 and took the position of support in a recent Board or Committee meeting. Kevin Olp will find the meeting recording/minutes and will send to Nancy.

Co-Chair Alfredo Angulo; Shared that the APEN (Asian Pacific Environmental Network) has been hosting a series of workshops around the transition from the refinery. The next workshop will be held Thursday at 6pm and will focus on successful and unsuccessful case studies of cities economically reliant on refineries.
