## **Draft Plan Production and Dissemination Update**

- All Chapters have been translated into Spanish
- All Chapters and Appendices have been copy edited and formatted
- An Executive Summary explaining the draft Plan and how to request translation has been written and translated into Spanish, Chinese, Vietnamese, and Tagalog
- The PTCA web pages are being updated in advance of the public comment period
- The draft Plan will be shared with CSC members in advance of the public comment period
- The Air District will send a Press Release to local media outlets, an E-Blast (email), and post on Nextdoor to announce the public comment period



### **Public Comment Period**

- The public comment period is expected to:
  - Start the week of December 11th
  - Close on January 19th
- The public comment period could be extended if there are many requests, this will be decided by the Co-chairs and Air District staff
- Comments will be accepted in writing, e.g. via email, letters or other written documents
- Air District staff will:
  - Compiled and organize the public comments by theme
  - Review comment summaries and themes with CSC
- Publish all comments and make them available to decision makers
- Any proposed substantive revisions or updates to the draft Plan will be shared with the CSC for input and discussion



## **Public Workshop**

- A virtual public workshop is planned to coincide with the public comment period
- The workshop will likely be week of January 8th, most likely Tuesday, January 9th or or Thursday, January 11th
- Air District staff will develop the workshop agenda and materials in consultation with the Co-chairs
- Objectives of the public workshop are that participants will:
  - Understand the AB 617 program and the activities in the PTCA
  - Acquire knowledge of air quality concerns in the PTCA area
  - Learn about the core elements of the PTCA Plan



## **CSC Approval**

- The CSC regular meeting on February 19th is a holiday, propose moving the meeting to February 26th
- At the February meeting the CSC can either
  - Discuss updates/revisions to the draft Plan and vote to Adopt, or
  - Discuss updates/revisions to the draft Plan and <u>wait until March to vote to Adopt</u>
- March 18th CSC meeting
  - Discuss and adopt draft Plan, or
  - Start the pivot to implementation

**Note:** there time between close of public comment and finalizing CSC meeting materials for February 26 is <u>short</u>. Depending on the number and type of comments, staff and the CSC may need more time to finalize the Draft Plan

- February 23 publish public comment summary and revised draft Plan in English only
- February 26 hold CSC meeting to discuss and potentially adopt draft Plan
- March 18 hold CSC meeting, second option for draft Plan adoption
- April / May CEHJ meeting to discuss recommending Plan adoption to the Board
- May / June Board of Directors public hearing to consider Plan adoption
