

March Subcommittee Report Back

Health & Living Buffers



- Identified numerous new actions to implement #86 Green Building Approaches.
- A lot of interest in:
 - The creation and expansion of remediation and weatherization vocational training programs for West Oakland residents
 - Supporting residents / landlords in replacing gas appliances with electric ones and retrofitting older housing to include cooktop ventilation / exhaust fans.
 - Finding grant funds to install filtration in West Oakland homes (esp in the hot spots and/or with sensitive residents).
 - Ensure city building / permit staff are well trained in residential indoor filtration





- Reviewed next steps for our priority strategies
 - Eliminated some actions that are no longer relevant
- Connecting with City around Howard Terminal (esp shuttle service and other improvements)
 - TWB members will collaborate with BAAQMD on EIR comment letter
- Colin will bring monthly updates to group re Grand Ave streetscape project process
- Advocate for West Oakland to be a study site for Caltrans Road
 Dust study



Port & Freight



- Presentation from the Port (Laura) on the 2020 and Beyond
 Seaport Air Quality Plan
 - While writing 2020 and Beyond, Port staff reviewed the WOCAP strategies to try an align the plans.
 - Discussions from group around
 - Desire for Port to participate in City decarbonization process
 - Port utilities and electricity rate
- Discussed group's priority strategies and created next steps for Project 800 and ZE Truck Parking work



Land Use



- At Feb meeting, LU committee decided to focus on #83 Healthy Development Guidelines for March meeting
 - Guidelines address topics that are of interest to other subcommittees as well:
 - Env. Health; Econ Opportunity; Community, Culture, and Safety; Healthy Food; Transportation; Housing; and Recreation and Active Design.
 - Need to best identify how to align these too efforts and figure out other actions for existing development
- Discussions around the linkage between clean up and who benefits from it. That is why we need a strong anti-displacement strategy
