Take this award letter to any dealership listed on the Clean Cars for All [Authorized Dealership List](#) on our website to purchase or lease your vehicle. The replacement vehicle must meet the requirements in the program’s Terms and Conditions and are summarized in the Clean Vehicle Checklist on page 2.

Authorized dealerships allow a minimum three-day decision-making window for used vehicles, where you can decide to keep or return the vehicle. Dealerships may have restrictions that void the return period. After you have purchased your vehicle, you must complete a Post-inspection to retire your old vehicle within 14 days after the return period for your replacement vehicle has expired. You must return to the same dismantler where you had your Pre-inspection performed.
