Dealership Checklist

Before you sell a vehicle, review this checklist to ensure the Vehicle and sale meets the Program Requirements. If you answer **Yes** to all of the questions below, then you can proceed with the sale.

Clean Vehicle Checklist	
	Check Award Letter and Fluxx (<u>baaqmd.fluxx.io</u>) to ensure grantee is eligible. Do not sell a vehicle to grantee if you are unable to confirm they are in Fluxx.
	Vehicle sold must match the <i>Clean Transportation Option</i> listed on the Award Letter. The Clean Transportation Option will list one of the following:
	• Hybrid Electric Vehicle 35+; or
	 Plug-in Hybrid Electric Vehicle or Battery Electric Vehicle; or
	o Fuel Cell Electric Vehicle
	 Must be a new or used hybrid electric vehicle, plug-in hybrid electric vehicle, or battery electric vehicle (leased vehicles must be new). Hybrid vehicles must have a minimum 35 MPG combined rating or better (MPG can be found here: www.fueleconomy.gov) Hybrid electric vehicles may not be leased Leased vehicles must be eligible for the California State rebate (Clean Vehicle Rebate Program)
	 Used Vehicles: must be 8 model years old and newer (2022 = 2015 or newer, 2023 = 2016 or newer) have less than 75,000 miles on the odometer, unless approved by Air District cannot have modifications to vehicles emissions control systems, hardware, software calibrations, or hybrid system must not have a salvaged title (as defined in California Vehicle Code, Section 544) must have a CARFAX, or similar report (uploaded onto Fluxx) must come with a 3-day return policy
	Vehicle must not have any open recalls (open recalls require proof of repair)
	Must register new vehicle in California
	If the participant needs financing, the interest rate must be less than 16%
	Negotiated prices must be honored. Dealership may not increase the price of vehicle due to Clean Cars for All grant
	Direct participant to California Low Cost Auto Program if necessary (www.mylowcostauto.com)
	 Sales Contract must: separate out the grant amount from other cash payments or rebates have Participant's name and address must match address listed on the Award Letter
	Dealership must submit a request for payment on the day a vehicle is sold (don't forget to click Request Payment in Fluxx)

Funding from Clean Cars for All cannot be combined with the <u>Clean Vehicle Assistance Program</u>, <u>Driving</u> <u>Clean Assistance Program</u>, <u>Replace your Ride</u>, Tune-in-Tune-up/<u>Drive Clean San Joaquin</u>, or the <u>Sacramento Clean Cars 4 All Program</u>.
