#### **Bay Area Clean Air Foundation**

#### 2013 Annual Report

#### 1. Background

On July 9, 2008, the Bay Area Air Quality Management District (Air District) Board of Directors approved the establishment of an Air District foundation. As a result of that action, the Bay Area Clean Air Foundation ("Foundation") was established in September 2008. The purposes of the Foundation are:

- To *provide* financial, administrative, programmatic and other forms of support to the Air District; and
- To engage in activities that further such purposes.

As part of this charter, the Foundation will serve to fund various air quality emissions reduction, educational and service programs to support the mission of the Air District:

"To protect and improve public health, air quality, and the global climate"

#### **Directors and Officers**

#### 2. Report on the Foundation's Activities

As part of this report, the Foundation Directors will receive an informational update on the activities related to funds received for three separate projects.

#### Project 1: City CarShare - Reformulated Gasoline (RFG) Settlement Fund Grant

On August 4, 2010, the Foundation, in partnership with City CarShare, submitted a grant application to the Reformulated Gasoline (RFG) Settlement Fund's Open

Grants Program for a project to 1) convert 10 hybrid electric vehicles to plug-in hybrid electric vehicles, 2) deploy the vehicles as part of City CarShare's fleet to promote car sharing, 3) evaluate deployment of plug-in electric vehicles in a car share environment, and 4) compile lessons learned and disseminate a best-practices guide for Carsharing.

On November 29, 2010, the U.S. District Court approved a \$546,097 grant to the Foundation for this project. The funding agreement between the CyPres Administrators (for the RFG Settlement Fund) and the Foundation was executed on April 7, 2011, and a first installment in the amount of \$500,000 was received from CyPres on August 31, 2011. The Foundation executed a funding agreement to award City CarShare \$505,137 on October 26, 2011.

City CarShare completed the purchase of the 10 Toyota hybrid vehicles by February 29, 2012. As a next step, the vehicles were sent to a third-party vendor to be converted into plug-in hybrids. The first Prius conversion was delivered to City CarShare and placed into service on January 31, 2012. The last of the 10 vehicles was converted and placed into service on July 30, 2012. All of the plug-in hybrids are currently available for use by City CarShare customers in San Francisco (five locations) and Berkeley (one location). In addition, as part of the project City CarShare installed 10 Level 2 charging stations at each of the 6 locations to support fueling (charging) of the converted vehicles. A photograph of one of the project vehicles and charging stations is found below in Figure 1. Preliminary data show that the vehicles are achieving a fuel efficiency of 100 miles per gallon (mpg) on trips that are 40 miles or fewer; this is more than twice the efficiency of a standard (non-plug-in) Toyota Prius.

#### Milestones

- **January 28 July 30, 2012:** 10 Toyota hybrid vehicles are converted to plug-in hybrid electric and placed into car-share service.
- March, April, July, August, September, & October 2012: City CarShare announces in its newsletters the availability of Plug-In Electric Vehicles in the San Francisco CarShare Fleet.
- **January 31, 2012 Present:** City CarShare collects project usage data and reports results to the Air District.

#### **Results: Project Usage Data**

The following is a summary of key project results from January 31, 2012 – Present:

- Total reservations/number of times a vehicle is checked out 4,177
- Total Miles Driven 103,017
- Electricity Used 10,019 kWh

#### **Driver Education:**

In the previous reporting period, City CarShare undertook a program to educate its members about the importance of refueling and properly plugging the vehicle in after use. Customer response to this educational program has greatly reduced the incidence of vehicles being not being properly plugged-in. City CarShare continues to monitor this important requirement and to notify members when they have forgotten to plug-in the vehicle. A sample brochure that was created for his purpose is found below in Figure 2.

Figure 2 – Education material

#### CHARGING

- Park and make sure front of car is close to charging station. Turn off car.
- Grab ChargePoint card located in visor pocket.

  Hold ChargePoint card in front of payment icon on charge station display screen to activate. Display will say AUTHORIZING.
- Charging station will unlock charging connector with audible click. Remove connector from holster.
- Swing open charge port door (Toyota emblem) and plug connector into charging port. Listen for a click to ensure charge.



- 5. Return ChargePoint card to visor pocket.
- Check the charging station display it should say CHARGING. If not, go back to step 2.

NOTE: Remember to plug car back in when you return to Pod. You may be fined for not plugging in.

#### WHERE TO CHARGE

- > A charge station at home Pod or commercial stations throughout the Bay Area. To find a charging station, visit plugshare.com or chargepoint.com
- > Each charging hour provides ~12 miles of range and 3-4 hours will fully charge a depleted battery.

#### **Issues Identified**

City CarShare has continued to experience technical problems with its PHEV conversation system, and several vehicles have reported problems that required removing them from service for repair. It was discovered that the on-board charging system on each of the converted vehicles

can cause the main traction battery to fully discharge in certain situations. Typically, this happens when the vehicle has been unplugged for an extended period of time (6-8 days). This design flaw has been reported to the company that developed and manufactured the charging system and they have been working to develop a retrofit to remedy the situation.

#### **Next Steps**

• **Final Report:** City CarShare continues to gather and compile project data and will be preparing a White Paper and Best-Practices Guide to facilitate the transfer of knowledge gained form this project to other air districts and fleet operators (car-sharing, municipal, and corporate fleets). The final report is due to the Foundation on June 1, 2014.

#### Project 2: Oakley Generating Station Emissions Mitigation

Contra Costa Generating Station, LLC (CCGS)/ Radback Energy, Inc., is developing a 624 megawatt power facility/ generating station in Oakley, California. CCGS filed Application for Certification 09-AFC-4 with the California Energy Commission (CEC) on June 30, 2009 to obtain a license to construct, operate and maintain the Oakley Generating Station. The CEC approved CCGS's Application on May 18, 2011 subject to conditions, including permit condition AQ-SC8, which requires that CCGS mitigate 63.88 tons per year (tpy) of particulate matter (PM) 10/PM2.5 and 12.55 tpy of sulfur oxides (SOx) emissions from the Oakley Generating Station.

The CEC further required CCGS to enter into an agreement with the Foundation in which CCGS would contribute \$32,750 per tpy (inclusive of a 20% administration fee) for PM10/PM2.5 and SOx emissions to be mitigated by projects funded by the Foundation with funds from CCGS. The CEC further required that the funds contributed by CCGS be used to fund emissions reductions projects based on the proximity of the emissions reduction project to the Oakley Generating Station and the relative health benefit to the local community surrounding the Oakley Generating Station by including the following project specific conditions:

Diesel emission reduction projects funded by the Foundation with the funds contributed by the project owner shall be weighted for evaluation, qualification, and selection, in accordance with the California Air Resources Board's Carl Moyer Program Guidelines. Other emission reduction projects with the cost-effectiveness of \$32,750 per tpy may be selected by the Foundation.

Funding shall initially be made available to qualified projects located preferentially within the boundaries of the City of Oakley, City of Antioch, City of Brentwood, and City of Pittsburg. After twelve (12) months from the date on which the administration funding has been provided to the Foundation, the program shall expand to include qualified projects located in Contra Costa

County and Alameda County, with priority given to those projects located within areas designated by the Air District as "priority communities" in the Community Air Risk Evaluation (CARE) program.

At all times, identified qualifying emission reduction projects located within the City of Oakley will be given the highest priority.

CCGS provided \$500,000 initial funding for emission reduction projects and administrative fees to the Foundation in August 2011. CCGS shall provide additional funding to the Foundation on a monthly basis as necessary to fund the qualifying emission reduction projects selected for that month. These requests will total (inclusive of a 20% administration fee) no more than \$2,003,083.00 over the term of the project.

The Foundation and CCGS agreed to enter into this Agreement to assist CCGS in satisfying the requirements of Condition of Certification AQ-SC8, and to ensure the proper funding and management of an emissions reduction program. Program implementation is anticipated to commence in spring 2012.

During 2012 and 2013 staff has conducted outreach regarding the availability of grant funding in the following areas: City of Oakley, City of Antioch, City of Brentwood, and City of Pittsburg. There has been limited interest in the funding in these areas; no project expenses have been incurred to date. As a result, and in accordance with the contract with CCGS, Staff has expanded the focus area for these funds to include Contra Costa and Alameda Counties. Staff will also be looking into using these funds to supplement the Air District's recently re-started Vehicle Buyback Program in these communities. The Vehicle Buyback program pays vehicle owners \$1,000 to dismantle their older, high-polluting light-duty vehicles. This program is administered in accordance with the Carl Moyer Program guidelines.

In February 2014, CCGS informed the Foundation that The Utility Reform Network has appealed the California Public Utility Commission's approval of the generating station. This appeal (the second appeal for this project) has delayed construction, and put a temporary hold on project financing. The distribution of additional grant funding is also on hold until a decision is issued on the appeal of the project. Staff will not proceed with the expenditure of existing project funds until this issue is resolved. Additional information is expected in early 2014.

#### Project 3: Shore Terminals Plea Agreement Funding

In June 2009, the Air District received \$250,000 pursuant to a plea agreement entered in a Federal criminal prosecution of Shore Terminals LLC related to its operation of a bulk petroleum terminal in Selby, Contra Costa County. Under the terms of the plea agreement, the money

deposit with the Foundation may be used for Air District projects designed to improve air quality in Contra Costa and Alameda Counties.

Air District Staff is currently working on a regulation for stationary diesel powered back-up generators and it is anticipated that this funding will be used to provide for the retrofit and replacement of equipment for cities and counties at the conclusion of that effort in 2014.
