Construction Update

- 1) Framing of offices and installation of utilities work began in July, 2014
 - Continuing on Levels 1, 2, and 6
 - Suspension Stairs on Levels 6 8 have been installed
 - Atrium glass is being put in place
- 2) A Move Coordinator Request for Proposals issued in June, 2014:
 - Air District, MTC, and ABAG staff jointly participated on the evaluation panel
 - Unanimous panel recommendation and BAHA approval of Relocation Connection Inc.,
 - Kickoff Meeting Held Tuesday, December 9, 2014
- 3) Master Project Schedule
 - Created to assist with the coordination of project elements across agencies on shared needs, dependent systems and on critical path items



Construction Schedule

- 1) It's Official Target Move Date to 375 Beale is December, 2015 (Contingent Upon Drug Enforcement Agency (DEA) move-out in February, 2015)
- 2) Construction Schedule Revised to Account for DEA Relocation Delays
 - Tenant Move-out February 1, 2015
 - Agency Move-in December, 2015




Figure 4: Installation of suspension stairs in the atrium, connecting Levels 6, 7, and 8 of the agency floors.
















BACKGROUND

- May 21, 2014 Board approves reimbursement to the Bay Area Headquarters Authority for expected change orders and third party services in the development and operations of the Air District's space at the new Regional Agency Headquarters (RAHQ) in an amount not to exceed \$500,000.00 dollars.
- June 18, 2014 Board authorizes Executive Officer/APCO to hire a professional construction management contractor to assist the Air District staff with tenant improvements and construction oversight at 375 Beale Street in an amount not to exceed \$300,000.00.
- □ The combination of these allocations (\$800,000) represents the current budget for changes and consulting work for the RAHQ project.

- Approved final working and construction drawings for space in the new RAHQ
- Selected furniture for Air District staff
- Assigned staff office and cubicle spaces in the new building.

- Examined 30 separate business and IT functions to share at RAHQ
- Completing Network redesign
- Agreed a shared costs formula for shared services

Staff Recommendations

- Authorize the Executive Officer/APCO to reimburse the Bay Area Headquarters Authority an additional \$500,000; for building redesign and construction; furniture; network redesign and consulting work associated with the Air District's tenant improvements and shared services cost at 375 Beale Street; and
- Increase the Fiscal Year Ending 2015, Program 702 budget by a corresponding \$500,000, to be transferred from the Air District's Building and Facilities reserves.
