However, the Chairperson or other Board Member presiding at the meeting may limit the public comment for all speakers to fewer than three minutes per speaker, or make other rules to ensure that all speakers have an equal opportunity to be heard. The Chairperson or other Board Member presiding at the meeting may, with the consent of persons representing both sides of an issue, allocate a block of time (not to exceed six minutes) to each side to present their issue.

Director Zane requested that the District partners with her office so that her constituents can learn about the impacts of wood smoke, via town hall meetings. She suggested that the District reaches out to Tennis Wick, Sonoma County Permit & Resource Management Department, and David Gouin, Director of Housing and Community Services for the City of Santa Rosa.

23. **Report of the Executive Officer / APCO**

Mr. Broadbent announced the following:

- Former Manager of Executive Operations, Maricela Martinez, was promoted to Director of Executive and Administrative Resources Division, and former Acting Health Officer, Judy Cutino, was promoted to Health Officer.
- The District issued two Notices of Violation for the fire at Sims Metal Management in Richmond that occurred on January 30.
- Staff would like to discuss the details of recruitment for two Advisory Council vacancies at the next Board meeting.
- The dates and locations of public meetings to discuss refinery monitoring efforts of Rule 12-15.
- 19 Winter Spare the Air alerts were called in 2017, but there were only 8 days on which the Bay Area exceeded Federal Ambient Air Quality Standards.
- Director Zane was invited to speak at the *Metro Talks* speaker series on the topic of "Learning From the North Bay Wildfires", held at the Bay Area Metro Center on February 1. Secretary

Sinks commended Director Zane and District staff for their comments, and acknowledged the District's opportunity to educate the public on proactive public health measures when rebuilding the 5200 homes that were destroyed in Sonoma County.

24. Chairperson's Report

Chair Hudson announced the following:

- On January 31, he attended the District's first Community Health Protection Program (AB 617) Workshop. He noted that it will be the job of staff and the Board to educate the public about the content of this legislation, and added that, in his opinion, CARB's allocation of funds to the Bay Area will depend on community support of the District's efforts. He encouraged staff to monitor and correct any misinformation about AB 617 that disadvantaged communities receive, and continue to promote data that the District has been collecting.
- On February 1-3, he attended the Local Government Commission's Annual New Partners for Smart Growth Conference, which the District sponsored. He reported that he attended the Race Forward panel by the Center for Social Inclusion, and that he believes that the State should require such trainings of elected officials.
- On February 6, he attended the Rethink Methane Conference in Sacramento.
- On February 13, he attended the Special District Selection Committee meeting of the San Mateo County Local Agency Formation Commission, to help appoint members to the Commission's County Oversight Board.
- On February 16, he attended a Bay Area Regional Collaborative meeting, at which Greg Nudd, Deputy Air Pollution Control Officer on Policy, spoke about AB 617 implementation. He also said that he wished to monitor the progress of the Berkeley Energy Assurance Transformation Microgrid Project that was presented, a clean energy microgrid, powered by solar, in downtown Berkeley to provide power to key City facilities for daily use as well as when power is disrupted.
- He congratulated Directors Chavez and Kniss for being reappointed for another term to the District's Board of Directors.

SECTION 1 BOARD OF DIRECTORS, MEETINGS

1.1 MEETING DATES. (Revised 11/06/2002)

Regular meetings of the Bay Area Air Quality Management District Board of Directors shall be held on the first and third Wednesday of each month, beginning at the hour of <u>9:45 a.m.</u>, <u>9:30 a.m.</u>, with either meeting being subject to cancellation by the APCO with the concurrence of the Chairperson if there is insufficient District business to warrant such meeting. When the day, or the day preceding the day, fixed for a regular meeting of the District Board falls upon a legal holiday, that meeting shall be held at the same hour seven (7) days later not on a holiday.

1.2 A. COMPENSATION - MEETING ATTENDANCE. (Revised 4/5/2006)

Board members shall receive compensation of one hundred dollars (\$100) for each day attending meetings of the District Board and of Board Committees, or upon authorization of the Board while on official business of the District, but such compensation shall not exceed six thousand dollars (\$6,000) in any one fiscal year. Board members may receive compensation for attendance at the following types of meetings other than Board and Committee meetings:

- (a) educational seminars designed to improve officials' skill and information levels:
- (b) meetings of regional, state and national organizations whose activities affect the Air District's interest with a District staff member in attendance:
- (c) Air District events: and
- (d) meetings to discuss community and/or business concerns with regard to air quality in the region.

Board members shall not <u>receive compensation for attending</u> meetings of any type unless compensation for attendance at such meeting(s) is approved by the Chairperson in an open session prior to attendance at the meeting.

Report(s) on any meetings that members have attended at the Air District's expense will be given at the next regular board meeting.

To the extent a meeting for which compensation is available includes a meal, a Board member may be reimbursed for the meal expenditures as long as the Board member complies with the limits and reporting requirements of local, state and federal law and the meal expenditure is reasonable and necessary.

1.2 B. LIMITS ON COMPENSATION FOR MEETING ATTENDANCE. (Revised 4/5/2006)

Board members shall not receive compensation for attendance at meetings of any type held outside the State of California unless compensation for attendance at such meeting(s) is approved by the Board in an open session prior to attendance at the meeting.

Unless excused by the Chairperson, a Board member shall receive such compensation for attending meetings of the Board only if:

- (a) the Board member arrives for the meeting within 30 minutes of the scheduled beginning of the meeting; and
- (b) the Board member misses no more than 30 minutes of the meeting plus, in the event a meeting continues beyond noon, the time between noon and adjournment.

1.3 BOARD MEETING LOCATION.

All regular meetings of the Board of Directors and all regular meetings of Board Committees shall be held at the offices of the District located at 375 Beale Street, Suite 600, San Francisco, California, unless at a previous regular Board meeting or committee meeting some other place was designated.

1.4 SPECIAL MEETINGS.

Whenever the business of the District may require special meetings, in the opinion of the Chairperson of the Board of Directors or at the express written request of any three (3) members of the Board, such meetings shall be called. Whenever a special meeting shall be called, notice shall be given to each member of the Board of Directors at least twenty-four (24) hours in advance, and to others as required by law, stating the date and hour of the meeting and the purpose for which such meeting is called. No business shall be transacted thereat except such as is stated in the notice.

1.5 AGENDA.

All reports, communications, resolutions, contract documents or other matters to be submitted to the Directors shall be delivered to the APCO one (1) week prior to the Board meeting. The APCO shall thereupon arrange a list of such matters according to the order of business. The Clerk of the Boards shall furnish each Board Director with a copy of the same no later than the Friday prior to the meeting and as far in advance of the meeting as is feasible.

RECOMMENDED ACTION

The Board of Directors will consider recognizing an EPA Grant Award for \$321,000 and consider authorizing the Executive Officer/APCO to award a contract and issue a Purchase Order for FYE 2018 not to exceed \$250,000 to Ramboll Environ, Inc. to perform Community Scale Air Toxics Ambient Monitoring in the City of Richmond as outlined in the grant proposal submitted to EPA.

DISCUSSION

The EPA conducts periodic Community-Scale Air Toxics Ambient Monitoring grant competitions to support projects of one and a half to three years to identify and profile air toxics sources, characterize the degree and extent of local air toxics problems, and track progress of air toxics reduction activities. Expected outcomes of these projects are to characterize the sources and local-scale distribution of hazardous air pollutants (HAPs) and assess human exposure and risk at a local scale.

The Air District, along with partners from Ramboll Environ, the City of Richmond, and Argos Scientific submitted a proposal for this grant competition in order to leverage information being collected by the dense ambient air and fence line monitoring systems in and near Richmond. There are three main objectives for this project:

- 1) Use data analytics techniques on the existing large ambient air monitoring data set to determine if a HAP emissions signal from a refinery that is adjacent to an EJ community can be determined;
- 2) Evaluate whether there is covariation within the nearly 20 concentrations measured to allow a reduction in the parameters measured and a resulting reduction in costs without compromising the integrity of the program; and

3) Combine data analytics and dispersion modelling to evaluate whether the distinct sources of ambient air concentrations can be determined, potentially, on a real-time basis.

On January 16, 2018, the Air District received official notification that the grant had been awarded based on the proposal submitted by the partnership. The proposal includes \$71,000 to the Air District for project coordination and management and \$250,000 to the primary contractor, Ramboll Environ, that includes \$50,000 to both the City of Richmond and Argos Scientific as subcontractors.

BUDGET CONSIDERATION/FINANCIAL IMPACT

Staff recommends that the FYE 2018 Meteorology and Measurement Division Budget be increased by \$321,000 with the acceptance of the EPA grant and a contract be issued to Ramboll Environ with a Purchase Order not to exceed \$250,000. The project will not require any funding from the General Fund.

The Bay Area Air Quality Management District (Air District) has participated in the Carl Moyer Program (CMP), in cooperation with the California Air Resources Board (ARB), since the program began in fiscal year 1998-1999. The CMP provides grants to public and private entities to reduce emissions of oxides of nitrogen (NOx), reactive organic gases (ROG) and particulate matter (PM) from existing heavy-duty engines by either replacing or retrofitting them. Eligible heavy-duty diesel engine applications include on-road trucks and buses, off-road equipment, marine vessels, locomotives, and stationary agricultural pump engines.

Assembly Bill 923 (AB 923 - Firebaugh), enacted in 2004 (codified as Health and Safety Code Section 44225), authorized local air districts to increase their motor vehicle registration surcharge up to an additional \$2 per vehicle. The revenues from the additional \$2 surcharge are deposited in the Air District's Mobile Source Incentive Fund (MSIF). AB 923 stipulates that air districts may use the revenues generated by the additional \$2 surcharge for projects eligible under the CMP.

On March 1, 2017, the Board of Directors (Board) authorized Air District participation in Year 19 of the CMP, and authorized the Executive Officer/APCO to execute Grant Agreements and amendments for projects funded with CMP funds or MSIF revenues, with individual grant award amounts up to \$100,000.

In 1991, the California State Legislature authorized Air District to impose a \$4 surcharge on motor vehicles registered within the nine-county Bay Area to fund projects that reduce on-road motor vehicle emissions within the Air District's jurisdiction. The statutory authority for the Transportation Fund for Clean Air (TFCA) and requirements of the program are set forth in

California Health and Safety Code (HSC) Sections 44241 and 44242. Sixty percent of TFCA funds are awarded by the Air District to eligible projects and programs implemented directly by the Air District (e.g., Spare the Air, Plug-in Electric Vehicle Program) and to a program referred to as the TFCA Regional Fund. Each year, the Air District's Board allocates funding and adopts policies and evaluation criteria that govern the expenditure of TFCA funding.

On April 19, 2017, the Board allocated \$29.24 million in TFCA funding for eligible projects in Fiscal Year Ending (FYE) 2018, authorized cost-effectiveness limits for Air District-sponsored FYE 2018 programs, and authorized the Executive Officer/APCO to execute Grant Agreements and amendments for TFCA-revenue funded projects with individual grant award amounts up to \$100,000. On August 2, 2017, the Board adopted policies and evaluation criteria for the FYE 2018 TFCA Regional Fund program.

CMP and TFCA projects with grant award amounts over \$100,000, are brought to the Mobile Source Committee for consideration at least on a quarterly basis. Staff reviews and evaluates grant applications based upon the respective governing policies and guidelines established by the ARB and the Board. During this review period, there were no eligible TFCA projects over \$100,000 recommended for approval.

DISCUSSION

Carl Moyer Program:

The Air District started accepting project applications for the CMP Year 19 funding cycle on October 12, 2017. The Air District had more than \$16 million available for CMP school bus projects from a combination of MSIF and CMP funds for the Year 19 cycle. Project applications are accepted and evaluated on a first-come, first-served basis.

As of February 1, 2018, the Air District had received 111 project applications for the CMP Year 19 cycle. Of the applications that have been evaluated between January 4, 2018 and February 1, 2018, two eligible projects have proposed individual grant awards over \$100,000. These projects will replace three school buses, and reduce over 0.3 tons of NOx, ROG and PM per year. Staff recommends the allocation of \$495,000 for these projects from a combination of CMP funds and MSIF revenues. Attachment 1, Table 1, provides additional information on these projects.

Attachment 2, lists all of the eligible Year 19 projects that have been received by the Air District as of February 1, 2018, and summarizes the allocation of funding by equipment category, and county. Approximately 84% of the funds have been awarded to projects that reduce emissions in highly impacted Bay Area communities. Attachment 3 summarizes the cumulative allocation of CMP and MSIF funding since 2009 (more than \$147 million awarded to 830 projects).

Transportation Fund for Clean Air Program:

The Air District started accepting project applications for the TFCA on July 1, 2017. As of February 1, 2018, the Air District has received 65 project applications for TFCA funding. Of the

applications that were evaluated between November 17, 2017 and February 1, 2018, there were no eligible projects that proposed an individual grant award over \$100,000.

Attachment 4, lists the 46 eligible TFCA projects that were evaluated between July 1, 2017 and February 1, 2018. In total, these projects represent approximately \$7.67 million in funds awarded, and will annually reduce approximately 31.49 tons of NOx, ROG, and PM and 19,454 tons of tailpipe greenhouse gas emissions. Approximately 26% of the TFCA funding awarded to date will directly reduce emissions in highly impacted Bay Area communities.

Attachment 5, summarizes the allocation of TFCA funding for the 46 eligible projects that have between evaluated since July 1, 2017, by project category (Figure 1), and county (Figure 2).

BUDGET CONSIDERATION / FINANCIAL IMPACT

None. Through the CMP, MSIF and TFCA, the Air District distributes "pass-through" funds to public agencies and private entities on a reimbursement basis. Administrative costs for these programs are provided by each funding source.





Figure 1: CMP and MSIF Funding Distribution by Equipment Category as of 2/1/18










Figure 3: CMP and MSIF funding since 2009



BACKGROUND

In the Bay Area, mobile sources account for 53% of certain criteria air pollutants and 41% of the Green-House Gases (GHG) generated¹. Since on-road vehicles and other mobile source emissions contribute significantly to criteria pollutants and GHGs, emissions reductions from this sector is essential to helping the Bay Area attain State and Federal ambient air quality standards and meet its GHG reduction goals. For this reason, the Bay Area Air Quality Management District (Air District) has invested significant resources to reduce emissions from the light-duty fleet through incentivizes for vehicles, infrastructure, and services that enable mode-switch to alternatives to single-occupancy vehicle use.

With the first introduction of commercially available light-duty plug-in electric vehicles (EV), in 2010, the Air District began focusing on strategies and programs to accelerate the rate of adoption of the cleanest technology available: EVs. The Air District views wide-scale adoption of EVs and electrification of all sectors of transportation as essential to achieving local, State, and Federal emission reduction targets. Additionally, studies have shown that further emissions benefits will be realized over time as the regions' power grid shifts to higher reliance on renewable energy sources².

DISCUSSION

The Air District's EV efforts have included development and implementation of region-wide plans, outreach and awareness campaigns, and direct monetary incentives. These efforts, in combination with other initiatives, have contributed to the region's high per-capita adoption rate (13 registered light duty EVs per 1,000 people—the highest rate in the United States) with more than 100,000 light duty EVs (nearly 40% of the EVs registered in California) being registered to Bay Area residents and businesses³. The Air District's efforts in the planning, incentives and outreach area are described in greater detail below:

Current and Past Efforts

Planning and Financial Incentives

Beginning in 2010, to prepare the region for the influx of EVs, the Air District partnered with the Metropolitan Transportation Commission (MTC) and other electric vehicle stakeholders to develop the Bay Area Plug-In Electric Vehicle Readiness Plan (PEV Plan). Based on research, analysis, and public input, the final 2013 PEV Plan included:

- Projections for EV ownership and deployment; barriers to EV ownership, deployment, and steps to eliminate barriers in private and public fleets, including recommendations for future incentive programs;
- Key strategic zones/areas for deployment and types of charging stations for regional EV charging infrastructure;
- Best practice recommendations for local government regarding their EV readiness and friendliness with respect to permitting and inspection practices; zoning and parking rules, local ordinances; and building codes;
- Identification of strategies to attract EV manufacturing, production, infrastructure and services to the Bay Area and California; and
- Integration of the Regional PEV Plan into the Bay Area's Sustainable Communities Strategy (SCS) plan (Plan Bay Area 2040).


With the adoption of the PEV Plan, the Air District has focused its incentives to target the key barriers identified in the Plan. Since 2010, the Air District's Board of Directors has allocated over \$11 million for incentive programs and to leverage additional investments. This investment has directly resulted in the deployment of more than 1,500 passenger electric vehicles, 1,050 publicly available Level 2 and DC Fast chargers, and over 1,400 residential chargers. Early incentive programs, such as the Air District's participation in the Department of Energy's EV Project, were designed to demonstrate the viability of EV technology and to "jump-start" the market. More recently, the Air District has targeted its incentives to expand the region's charging network through the *Charge!* Program. *Charge!* has supported approximately 18% of the publicly available

charging stations in the Bay Area (Figure 1), making the Bay Area home to one of the most robust charging networks in the nation. Over the past seven years, over 4,400+ publicly available charging stations, including 150+ DC Fast Chargers, have been installed in the Bay Area to support the region's EVs.

Outreach and Partnerships

Since 2011, the Air District, in partnership with MTC, has also sponsored the EV Coordinating Council, a forum for EV stakeholders including local governments, businesses, research institutions and non-profits to collaborate. The EV Coordinating Council is convened quarterly and serves as a clearing house to cover topics such as: new plug-in vehicles and charging technologies on the market, EV-friendly ordinances adopted by local agencies, and grant opportunities. The Council is an



ongoing platform to discuss emerging trends, share best practices, and facilitate innovation to address barriers to EV adoption.

The Air District also sponsors local events and attends and shares information at regional conferences and meetings with local associations and government



agencies (e.g. transportation, environment, public works, school districts, chambers of commerce).

Future Efforts

Over the next decade, the rate of EV adoption will need to increase exponentially to meet the transportation electrification goal of 90%+ by 2050 established in the 2017 Clean Air Plan. The charging network will also need to continue to expand, both in density and geographical reach to accommodate the higher rates of EV adoption and access for drivers in more communities. In addition, the network will need to evolve, to accommodate the new faster-charging longer range EVs that will be available beginning in 2018.

Moving forward, the Air District will be focused on addressing barriers to adoption in communities that have been slower to adopt EV, providing incentives to help build out a fast charging network and fill in gaps in the existing network, and updating the region's EV plans to reflect current technologies and trends. These efforts are described in detail below:

Accelerating adoption in low-income communities

The California Air Resources Board (ARB) approved an expansion of its light duty EV rebate program for disadvantaged communities to the Bay Area. The Air District is currently working with ARB to accept funding that would provide qualifying low-income residents up to \$9,500 for a new light duty EV. The program, which will provide funding in a range based on the participants income level, will also include options to purchase used EVs and new and used hybrid vehicles, and an option to receive vouchers for transit and car-sharing. This program is scheduled to launch

later in 2018 and will include stakeholder engagement and outreach to disadvantaged communities, case managers to support participants through the application process, and partnerships with dealers, vehicle scrappers, and alternative transportation options (e.g. Clipper card).

Building out fast charging, and filling in gaps

Recognizing that the use-case for EVs are shifting due to the availability of new longer range (200+ miles) EV models, the Air District will be expanding its focus to install fast chargers along major highway corridors. These Ultra-fast (150+ kW) Direct Current Fast Chargers will be installed in "plazas" and will operate like gasoline refueling stations. These plazas will also address the needs of potential EV adopters who are looking for EVs to cover daily commuting and long-distance trips, more similar to what consumers are used to with gasoline vehicles.

EV uptake among residents of multi-dwelling units has lagged due to the lack of dedicated parking and the challenge of installing charging infrastructure in shared parking structures. In addition to incentivizing charging installations in multi-dwelling units, the Air District will also continue to target workplace charging. The combination of ultra-fast charging plazas and workplace charging is a viable solution for potential EV consumers who do not have access to home charging.

Expanding partnerships, outreach, and evaluation activities

In November 2017, the Air District's Board and MTC approved a funding partnership whereby MTC will provide \$5 million over the next 5 years to support the Air District's outreach, and evaluation activities, and to expand the Air District's light duty EV incentive programs. The Air District will be using these funds to provide additional technical support to local governments to help improve their EV readiness and to expand general outreach and education.

Leveraging other efforts in the region

The Air District's investments and efforts have, and will continue to, play a significant role in catalyzing the Bay Area's shift towards zero emission transportation. In recent years, other organizations have increased support and incentives for charging infrastructure and vehicles, such as Pacific Gas & Electric's EV Charge Program, Electrify America (Volkswagen subsidiary), ARB and the California Energy Commission. The California Building Standards Commission recently updated the CalGreen building codes to require new buildings to have a certain percentage of parking spaces be "EV Ready." To meet the region's aggressive EV adoption goals, these regulatory and incentive programs are all needed, and the efforts need to be coordinated to have maximum impact on driving adoption.

At the Mobile Source Committee, staff will provide an overview of light duty EV market, a summary of the results of the Air District's past light duty EV initiatives, and the Air District's next steps to further support the accelerated adoption of light duty EVs.

RECOMMENDATION

BACKGROUND

In the Bay Area, mobile sources account for 53% of certain criteria air pollutants and 41% of the Green-House Gases (GHG) generated¹. Since on-road vehicles and other mobile source emissions contribute significantly to criteria pollutants and GHGs, emissions reductions from this sector is essential to helping the Bay Area attain State and Federal ambient air quality standards and meet its GHG reduction goals. As part of its efforts to reduce emissions from mobile sources, the Bay Area Air Quality Management District (Air District) administers grant and incentive programs that offer funding to public agencies, private companies, and Bay Area residents to help offset a portion of the cost to implement eligible emissions reduction projects.

In calendar year 2017, the Air District awarded nearly \$57 million in funding to eligible projects. Approximately \$47.5 million of that funding was directly allocated by the Air District. The remaining \$9.4 million was distributed to the nine congestion management agencies in the Bay Area via the Transportation Fund for Clean Air (TFCA) County Program Manager program. The Air District allocated \$45.6 million from four primary funding sources, including the California Goods Movement Bond, TFCA Regional Fund, Mobile Source Incentive Fund, and the Carl Moyer Program. These programs accumulate annually via fees and bond sales that are distributed to the Air District, and constitute the Air District's primary grant programs.

In addition to these four primary funding sources, staff also seeks out additional funding opportunities (e.g., state and federal sources) to further reduce emissions from both mobile and stationary sources in the Bay Area. The remaining \$1.9 million of the \$47.5 million came from

the U.S. Environmental Protection Agency's National Clean Diesel Program for a locomotive project at the Port of Oakland, the Greenhouse Gas Reduction Grant Program (GGRGP) funded by the ConocoPhillips Carbon Offset Funds and the National Fish and Wildlife Foundation (NF&WF) for the Commercial Lawn and Garden Equipment Replacement Program, and the Air District's general fund for the Wood Smoke Emissions Reduction Incentive Program.

DISCUSSION

Each year the Committee receives an update summarizing prior year grant expenditures. The presentation to the Committee will include a discussion of the total incentive funds allocated in calendar year 2017 by funding source, project/equipment category, and county, and emissions reductions. Staff will also discuss with the Committee the projected funding for each of the Air District's primary grant programs in calendar year 2018 and present historical information showing how Air District funds have been allocated over the past five years.

RECOMMENDED ACTION

The Committee will consider recommending a 2018 Legislative Agenda to the Board of Directors.

BACKGROUND

Staff are recommending the Committee consider a legislative agenda for 2018, focused on securing state budget funding to cover the costs of the work the Air District has been assigned under AB 617.

DISCUSSION

In 2017, California extended its cap-and-trade program, a signature piece of the State's efforts to reduce greenhouse gas emissions. Integral to the deal extending the program was the passage of AB 617, authored by Assemblymember Christina Garcia. This imposes a wide variety of new requirements and obligations on local air districts. A partial list of this new workload includes development and installation of new community air monitoring programs, implementation of comprehensive community emission reduction plans, and significant new work regarding Best Available Retrofit Control Technology (BARCT), for certain cap-and-trade sources. While the specifics of the work to be done by air districts is still the topic of discussion with the Air Resources Board (ARB), local communities, and other interests, we expect that initial one-time costs may be in the range of \$15 to \$25 million dollars, and ongoing annual costs will start over \$10 million and potentially escalate over time.

The Air District adopted an 'oppose unless amended' position on AB 617 last year prior to its passage, in large part because the legislation did not include any funding for the required substantial workload increase. However, after passage, the Legislature included \$11 million for ARB to oversee AB 617 implementation, and \$27 million for all air districts statewide to implement the new requirements. These allocations have the cap-and-trade auction revenues as their source. The Air District's share of the \$27 million is \$4.8 million. As of the date of this memorandum, the Air District has yet to receive any of the allocated funds, although we expect to receive at least an initial payment relatively soon.

However, of far greater concern, the administration has allocated no funding for districts to implement AB 617 in its January proposed budget for the upcoming fiscal year. However, ARB is slated to receive \$14.6 million to oversee implementation. Staff believe our highest legislative priority for 2018, is to work to secure adequate funding to implement AB 617.

Re: Consideration of New Bills

RECOMMENDED ACTION

The Committee will discuss and review new bills and consider recommending positions on them to the Board of Directors.

BACKGROUND

2018 is the second year of the 2017-2018 Legislative Session. Relatively few new bills have been introduced as of the date of this memorandum, but staff expect that many bills relevant to the Air District will be in print as of the February 16, 2018, deadline. Staff may present some of these bills orally to the Committee at its February 22, 2018 meeting, in addition to the bills below. The Committee will consider more bills at its March meeting. All bills must be in print for 30 days before being heard in Policy Committee. In practice, the bulk of bills will have their first policy committee hearing in April. Bills with fiscal implications have an April 27, 2018, deadline to clear their policy committee or committees.

DISCUSSION

AB 1975 is authored by Assemblymember Kansen Chu (D-San Jose), and tackles ongoing odors in Milpitas and adjacent parts of the South Bay. The Assemblymember's district has long had odor impacts from such sources as the Newby Island landfill and composting operation, the San Jose/Santa Clara regional sewage treatment plant, Zero Waste Energy Development (an anaerobic digestion facility), adjacent bay lands, the Milpitas sewage pump station, and more. Generally, odor complaints to the District have been declining, as our efforts to improve practices at these facilities have been paying off. Total Milpitas odor complaints have declined from approximately 3,500 in 2015, to 2,800 in 2016, to 1,500 in 2017. Another positive development since 2015 is the ongoing collaboration of the South Bay Odor Stakeholders Group, a public/private partnership of regulators, local governments, and odor sources.

AB 1975 would codify the stakeholders group in statute, make some changes to it, and assign it some tasks. It is similar to AB 385 of 2015 by the same author, which died in the second house. This year's bill would have CalRecycle establish the South Bay Interagency Taskforce, which would have as members all local governments in the area, the District, the local enforcement agency (LEA), and all facilities it deems as odor sources in the region. The taskforce would have until July of 2020 to complete five assignments:

- 1. "Identify and quantify" sources of odor emissions;
- 2. "Develop and implement a protocol for joint inspections" by the Air District and the LEA;
- 3. "Identify best management practices that may be implemented to reduce odor emissions";
- 4. Make the taskforce's work available online; and
- 5. Allow public participation

Staff are recommending a "**Support if amended**" position on AB 1975. One limitation of the existing South Bay Odor Stakeholders Group is that a number of key entities are not participating, or participating only infrequently. Mandating a similar group in statute should help address this ongoing concern of the Air District, and we hope to get the more complete participation that the odor problems warrant. Staff support the third, fourth, and fifth of the taskforce's assignments. The first and second assignments are problematic as drafted, and staff are recommending some changes to address our concerns. Quantifying odor emissions is a well-intentioned but infeasible goal, so we suggest eliminating the quantification part of the first assignment while keeping the identification of odor emissions. The second goal we believe should be struck. District inspectors and LEA inspectors inspect the relevant facilities for compliance with completely different requirements. Thus we believe joint inspections are not appropriate. These are the amendments staff recommend the District seek.

AB 2008 is authored by Assemblymember Rudy Salas (D-Bakersfield). It would stipulate that taxpayers not count Moyer grants as gross income for state tax purposes. Today, these grants are taxable. If they become not taxable, staff believe that would encourage additional owners of older, dirtier diesel engines to seek grant funding to clean up their equipment. Less affluent taxpayers in particular might apply for non-taxable grants, and in general staff believe the bill is likely to increase the cost-effectiveness and emissions benefits from the Moyer program. Thus, staff recommend a "**Support**" position on the bill.

AB 2008 would decrease state income taxes, and thus will likely be opposed by the Department of Finance. A similar but more expansive measure was attempted by Senator Cannella in 2011. SB 358 of that year would have exempted all clean air grants from gross income. The bill failed to advance past its first policy committee.

Copies of AB 1975 and AB 2008 are attached. Staff may bring additional bills to the committee for its consideration on February 22, 2018, as well as a list of introduced bills with air quality implications.

ASSEMBLY BILL

No. 1975

Introduced by Assembly Member Chu

January 31, 2018

An act to add Section 43209.5 to the Public Resources Code, relating to solid waste.

LEGISLATIVE COUNSEL'S DIGEST

AB 1975, as introduced, Chu. Nuisance: odors.

(1) Existing law prohibits, with specified exceptions, the discharge of any air contaminant or other material that causes injury, detriment, nuisance, or annoyance to, or that endangers, the public. Existing law exempts from that prohibition, among other things, all odors emanating from agricultural operations necessary for the growing of crops or the raising of fowl or animals; odors emanating directly from a facility or operation that produces, manufactures, or handles compost, as defined; and odors emanating from operations that compost green material or animal waste products derived from agricultural operations, as specified.

Existing law also requires an air pollution control or air quality management district that receives a complaint regarding an odor emanating from an exempt composting operation to refer the complaint to an enforcement agency with jurisdiction pursuant to the California Integrated Waste Management Act of 1989, and requires that agency to take appropriate enforcement action.

This bill would require the Department of Resources Recycling and Recovery, no later than July 1, 2019, to establish the South Bay Interagency Odor Taskforce, with a specified membership, to identify sources of odor emissions and nuisance complaints based on odor emissions received by the Bay Area Air Quality Management District

and the City of Milpitas, the City of Fremont, the City of Santa Clara, and the City of San Jose. The bill would require the taskforce, no later than January 1, 2020, to take specified actions, including, among others, developing and implementing a protocol for joint inspections by the air district and the enforcement agency represented on the taskforce. By adding to the duties of local agencies, this bill would impose a state-mandated local program.

(2) This bill would make legislative findings and declarations as to the necessity of a special statute for certain cities in the County of Santa Clara.

(3) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

Vote: majority. Appropriation: no. Fiscal committee: yes. State-mandated local program: yes.

LEGISLATIVE COUNSEL'S DIGEST

AB 2008, as introduced, Salas. Income taxes: exclusion: Carl Moyer Memorial Air Quality Standards Attainment Programs grants.

The Personal Income Tax Law and the Corporation Tax Law define gross income as all income from whatever source derived, unless specifically excluded.

This bill would, under both laws, exclude from gross income any amount provided to a taxpayer pursuant to the Carl Moyer Memorial Air Quality Standards Attainment Program for the purchase of new zero or low-emission engines.

This bill would take effect immediately as a tax levy.

BACKGROUND

In July 2008, the Board of Directors adopted Regulation 6; Rule 3: Wood Burning Devices. The rule applies to wood-burning devices including fireplaces, fire pits, wood stoves, pellet stoves, and any other wood-fired heating device. The rule was amended by the Board of Directors on October 21, 2015, to further protect Bay Area residents from the public health impacts of fine particulates generated from burning wood or solid fuels as a source of primary or supplemental heat, or for ambiance. The year's wood smoke regulatory season ran from November 1, 2017 through February 28, 2018.

There are an estimated 1.4 million fireplaces and wood-burning devices in the Bay Area; and in the winter, more than 30% of PM_{2.5} air pollution is attributed to wood-burning. Although Rule 6-3, has successfully reduced wintertime PM_{2.5} emissions regionally by about 2,660 tons per year (tpy), wood smoke continues to cause unhealthy air, to exceed the PM_{2.5} federal health standard, and negatively impact local air quality.

The 2017-2018 Winter Spare the Air campaign featured the same strong message from last season and links the serious health impacts from wood smoke to those of cigarette smoke. Advertising that clearly illustrates this link has resonated so well with the public it will be refreshed for the 2018-19 winter season.

DISCUSSION

Staff will present an update on the 2017-2018 Winter Spare the Air Program including information about:

• Regulation 6, Rule 3 implementation.

- The Wood Smoke Reduction Incentive Program that was developed to help Bay Area homeowners and landlords replace their wood-burning heating devices with cleaner options.
- The Winter Spare the Air campaign which highlights changes to the wood burning rule, publicizes the benefits of replacing old fireplaces and continue to focus on the localized health impacts from wood smoke.
