Background

- July 2008 Air District's Board of Directors approve the establishment of an Air District foundation
- September 2008 Bay Area Clean Air Foundation (BACAF) created with the purpose to:
 - Provide financial, administrative, programmatic and other forms of support to the Air District; and
 - Engage in activities that further such purpose
- Directors of BACAF:
 - Damian Breen
 - Kraig Kurucz
 - Brian Bunger



Oakley Generating Station Mitigation Project

- Contra Costa Generating Station, LLC (CCGS)/Radback Energy, Inc. - Provided \$500,000 to BACAF to mitigate emissions from developing a 624 Megawatt (MW) generating station in Oakley, CA
- Funding was to be used to mitigate diesel emissions through projects located in nearby communities (Oakley, Antioch, Brentwood, and Pittsburg)



Oakley Generating Station Mitigation Project (Cont'd)

- September 5, 2018: Radback notified BACAF that the proposed project to build the Oakley Power Plant would not be proceeding
- October 5, 2018: BACAF returned the remaining mitigation funds to Radback



Reformulated Gas Settlement Fund Adoption of Zero – and Near-zero Emissions Equipment and Vehicles in and Around the Port of Oakland

- \$1.3+ million awarded to BACAF for projects that reduce petroleum use from equipment and vehicles operating in and around Port of Oakland and former Oakland Army Base
 - Target area includes West Oakland and surrounding communities along highway 880 corridor
 - Award includes funding to cover administrative costs

Bay Area Clean Air Foundation: Selection of Directors

- Pursuant to By-laws, Directors of the Bay Area Clean Air Foundation (BACAF) serve two-year terms
- BACAF Directors are limited to three consecutive two-year terms, but may serve again after taking a one-year hiatus
- Kraig Kucurz, BACAF Director, has reached the end of his second two-year term
- Brian Bunger, Legal Counsel with the Bay Area Air Quality Management District, has reached the end of his first twoyear term



Request the Board of Directors as Sole Member of the Bay Area Clean Air Foundation:

- Reappoint Kraig Kurucz to a third 2-year term as a Director of the Bay Area Clean Air Foundation; and
- Reappoint Brian Bunger for a second 2-year term as a Director of the Bay Area Clean Air Foundation
