4. BAY AREA SMOKE IMPACTS FROM WILDLAND FIRES AND LESSONS LEARNED

Jack P. Broadbent, Executive Officer/Air Pollution Control Officer, gave the staff presentation *Responding to our Wildfire Smoke Public Health Crisis: Lessons Learned on Protecting Our Future*, including: Bay Area smoke; Bay Area Particulate Matter (PM)_{2.5} exceedance trends; 2017/2018 Northern California wildfires; Sonoma/Napa Fires and Camp Fire; North Bay fires: Geostationary Operational Environmental Satellite (GOES) -16 imagery; hourly PM_{2.5} concentrations during North Bay fires; Northern California wildfires in October 2017; summer 2018 California fires; Camp Fire: GOES-16 imagery; Camp Fire impacts on November 16, 2018; PM_{2.5} concentrations; health messaging; health impacts; Emergency Room visits before and after the Tubbs Fire; Bay Area leadership; messaging; lessons learned; and next steps.

The Committee and staff discussed whether an additional air quality monitoring site in Sonoma County (other than in Sebastopol) is needed; how adequately remaining indoors and wearing respirators protects against inhaling PM during wildfire events; how the transport of wildfire smoke can fail to be captured in satellite images; the need for a consensus among county Public Health Departments on the efficacy of respirators, the request for research data on their effectiveness, and whether the Air District should let counties decide whether to have their own mask distribution program; the increase of public awareness and appreciation for the Air District's Spare the Air programs that result after a wildfire; the advantages and disadvantages of controlled/prescribed burn; and the suggestion of using microsatellite technology to identify wind patterns and airsheds.

5. APPROVAL OF CONTRACT TO FURTHER DEVELOP AN AIR QUALITY TECHNICAL ASSISTANCE CENTER FOR THE BAY AREA

Eric Stevenson, Director of Meteorology and Measurements, gave the staff presentation Approval of Contract to Further Develop an Air Quality Technical Assistance Center for the Bay Area, including: many needs to technical assistance; example - building capacity; Technical
