5. BAY AREA REGIONAL COLLABORATIVE (BARC) UPDATE

Allison Brooks, Executive Director of BARC, gave the presentation *BARC Executive Director's Update*, including: proposed BARC Work Plan 2020-2022, and areas for BARC/Air District collaboration; transportation – California's largest source of greenhouse gas (GHG) emissions and growing; Assembly Bill (AB) 617 implementation - focus on mobility; Berkeley's ban on natural gas; and building electrification.

Public Comments

Public comments were given by Jed Holtzman, 350 Bay Area.

Committee Comments

The committee and staff discussed how a chart of California's largest sources of GHG emissions would compare with that of the Bay Area's; contributing factors of high global warming potential, and whether the California Air Resource Board's (CARB) definition of "high global warming potential" specifically pertains to the Kyoto Protocol's six GHGs gases (Carbon dioxide, Methane, Nitrous oxide, Hydrofluorocarbons, Perfluorocarbons, and Sulphur hexafluoride); the suggestion that BARC gets involved with community choice aggregation agencies that are encouraging cities to adopt new reach codes containing more stringent environmental standards; what is attainable regarding electrification goals; the Committee's appreciation for BARC's help in collaborating agencies; and the suggestion that BARC shares success stories of projects and programs to encourage other jurisdictions to implement them.

6. STATUS UPDATE FOR THE PRODUCTION SYSTEM OFFICE

Blair Adams, Information Systems Officer, gave the staff presentation *My Air Online Status Update*, including: My Air Online 2019 status overview; conceptual shift - feature migration; invoice and permit revenue (Fiscal Year 2019); Permitting and Compliance system - current production features; "Air Pollution" web interface - before and after; "Air Quality Index" and "Meteorology" web interface; schedule overview - legacy transition; and budget and feature estimates.

Committee Comments

The Committee and staff discussed the number of views that the Air District's main website experienced during the 2018 Camp Fire; user interface of the Air District's production system, and whether the system provides a way in which the public can make comments or ask questions of Air District staff; whether facilities' permits are available for viewing on the Air District's website; current capabilities for mining data and researching the system's application programming interfacing trends; appreciation of the Production System Office for its assistance during wildfire incidents and subsequent high web traffic; the importance of the Air District's transparency and website expediency; how Assembly Bill (AB) 617 requirements may impact future Air District budgets, as budget estimates do not currently include AB 617 requirements; and ways to direct the public who are accessing the production system to information that encourages changes in consumer-demand behavior.

Wayne Kino, Deputy Air Pollution Control Officer of Operations, introduced Lisa Fasano, Communications Officer, who gave the staff presentation 2019 Summer Spare the Air Season Summary and Winter Spare the Air Season Overview, including: advertising; "Share the Ride" television advertisement; campaign highlights; social media; media relations; 2019-2020 Winter Spare the Air campaign overview; advertising; social media; door-to-door outreach; and Wood Smoke Reduction Grant program results.

The Committee and staff discussed the request for extra WSTA doorhangers for the City of San Ramon; the suggestion of incorporating electric bicycle and bicycle share program incentives into both STA programs; the suggestion of following STA advertisements with messaging about the Air District so that the public will connect the program with the agency; concerns that the number of the Air District's social media followers does not reflect the number of Bay Area residents; the public's feedback regarding the efficacy of Air District program outreach; and whether the Air District should support natural gas as a "bridge fuel" until electrification becomes the new standard.
