4. UPDATE ON IMPLEMENTATION OF RULE 11-18, REDUCTION OF RISK FROM AIR TOXIC EMISSIONS AT EXISTING FACILITIES

Damian Breen, Deputy Air Pollution Control Officer of Technology, introduced Carol Allen, Engineering Division Assistant Manager, who gave the staff presentation *Update on Implementation of Regulation 11, Rule 18: Reduction of Risk from Air Toxic Emissions at Existing Facilities,* including: outline; Rule 11-18 overview; requirements; implementation flow chart, process, and status; schedule for Phase I sites; actions to date; and next steps.

Committee Comments

The Committee and staff discussed the composition of Phase I and Phase II facilities and the prioritization difference between the two groups; which entities will be conducting health risk assessments (HRA) for the facilities, and, if third parties are hired to conduct any of the HRAs, whether the Air District or the facilities would do the hiring; the timeframe for refineries' implementation of this regulation; whether this regulation addresses mobile sources; how the Air District plans to publicize the HRA results in a way that is understandable to the public, via methods expanding beyond the internet; the number of Phase I facilities and a request that the names of those facilities and their HRA status be posted on the Air District's website; the Air District's definition of a "deferred" facility; the request that the Board members be given the list of affected facilities so that they may inform facilities adjacent to the affected facilities of Rule 11-18; whether fence line monitoring at refineries is part of Rule 11-18, the status of Air District fence line monitoring efforts at refineries, and a request for a staff report on fence line monitoring data the Air District is collecting; consequences for failing to meet regulation deadlines; the number of full-time equivalent Air District employees are assigned to carry out Rule 11-18, and whether this rule's implementation is fully-staffed; if and how Air District fees have been or will be affected by Rule 11-18; improvements to Bay Area air quality over the last two decades and ways to communicate that to the public; and a request for emission reductions pertaining to each completed Carl Moyer Memorial Air Quality Standards Attainment Program-funded project in the Bay Area.

5. **REFINERY AND FLARE OVERVIEW**

Jeff Gove, Director of Compliance and Enforcement, gave the staff presentation *Refinery and Flare Overview*, including: overview; Air District refineries; refinery overview; products of petroleum refining; refinery sources of emissions; refinery emissions; Air District refinery regulations; refinery flare systems; refinery maintenance; Regulation 12, Rule 11 and Regulation 12, Rule 12; frequency of flaring events; and amount of gas flared.

Public Comments

Public comments were given by Bob Brown, Western States Petroleum Association.

Committee Comments

The Committee and staff discussed the request for causal analyses of flaring events (power outages, process upsets, emergencies, start-up, shutdown, maintenance, etc.) and the posting of such analyses on the Air District's website; the number of ongoing flaring investigations that have been open since 2018 at Chevron; whether Chevron's hydrogen plant in Richmond causes flaring events and will continue additional flaring in the future; the request that in the future, Air District staff dedicates one slide per refinery when capturing the frequency of flaring events and the amount of gas flared; corrective measures to address flaring facilities; health impacts due to flaring; the lack of notification before and after flaring events; the need to educate the public about the difference between flaring and fires and explosions; tradeoffs of flaring; whether applications used by the public capture flaring incidents; and the fact that routine flaring at refineries is prohibited in the Bay Area.

7. COMMITTEE MEMBER COMMENTS

Regarding the California Department of Transportation's (Caltrans') proposal to partially lower, raise, replace, or reconstruct connectors in the MacArthur Maze at either Interstate 80, 580, or 880 to increase vertical clearance for freight vehicles in the City of Oakland, Director Bauters voiced his concern about inadequate noticing practices and anticipated impacts of the project (despite the claim that the project will not significantly affect the quality of the environment). As this project

is adjacent to West Oakland, a community identified as a first-year, priority community for the Air District's Community Health Protection Program, Director Bauters requested that the Air District demand a full Environmental Impact Report of this project and provide comments to Caltrans.

Chair Sinks informed the Committee members that they will receive (via email) a list of potential topics for the Committee's discussion for 2019. He also announced that the Committee will not meet in May, but in April.

RECOMMENDED ACTION

BACKGROUND

Monitoring of specific sources (in-stack monitors) and monitoring along fence lines has been in place at refineries for decades. This has allowed the Air District to determine compliance with emission limits at specific sources and reduce impacts to nearby residents and businesses.

On April 20, 2016, the Board of Directors (Board) adopted Regulation 12, Rule 15: Petroleum Refining Emissions Tracking (Rule 12-15), a first in the nation regulation, that required additional fence line monitoring, among other requirements such as requiring a more standardized approach to determine emissions inventories and documenting characteristics of crude oils being processed at a refinery. As part of this regulatory action, the Board directed staff to establish an additional air monitoring station in each of the five refinery communities to be operated by Air District staff.

DISCUSSION

The Air District uses in-stack Continuous Emission Monitors (CEMs) that must meet specific and stringent requirements to ensure accuracy to measure emissions directly from sources. The purpose of these monitors is to ensure that emission limits in permits and regulations are constantly met. The Air District also requires refineries to install fence line monitoring called Ground Level Monitors (GLMs) to ensure that concentrations of hydrogen sulfide (H₂S) and sulfur dioxide (SO₂) do not exceed regulatory limits. The purpose of these monitors is to measure ground level concentrations that may impact local populations.

Technological improvements in a measurement technique known as Open Path (OP) measurement, in which a beam of light is passed between two points and can measure specific compounds that pass through the length of the beam, has made this an attractive alternative to traditional GLM monitoring that measures at only a single point. While the goal of using this measurement technique is the same as that for GLMs, the technique allows for greater measurement coverage along the entire path of the light beam which can be as long as 1,000 meters.

However, populations living and working near refineries voiced concerns that ground level emissions from refineries were not being adequately measured and that general air quality in refinery communities was not represented by the current air monitoring network. Staff incorporated additional monitoring requirements into Rule 12-15 to address these concerns. Original drafts of Rule 12-15 required that refineries establish air monitoring stations in nearby communities in addition to requiring open path monitoring along the refinery fence line. However, due to concerns about having refineries operating these "community monitors," the Board directed staff to operate and maintain an additional air monitoring station in each refinery community.

The Air District's Board of Directors also adopted amendments to Regulation 3: Fees, to pay for review of fence line air monitoring and quality assurance plans, and for installation, operation and maintenance of air monitoring stations within the five Bay Area refinery communities.

Staff will provide the Committee with an update on progress in installing both fence line monitoring at refineries and establishment of air monitoring stations in refinery communities.

RECOMMENDED ACTION

BACKGROUND

Petroleum refineries are significant sources of pollutants on both the global (greenhouse gases) and regional/local scale (toxic air contaminants and criteria pollutants). Many Bay Area residents have expressed concern about the impact of this pollution on the climate, environment and public health.

Regulation 12, Rule 15 (Petroleum Refinery Emissions Tracking) and Regulation 6, Rule 5 (Particulate Emissions from Refinery Fluidized Catalytic Cracking Units) were adopted by the Board of Directors on December 2015 and later amended in December 2018. The purpose of Regulation 12, Rule 15 is to "Track air emissions and crude oil composition characteristics from Petroleum Refineries and Support Facilities over time..." while the purpose of Regulation 6, Rule 5 is to limit emissions of condensable particulate matter and precursors of secondary particulate matter from petroleum refinery fluidized catalytic cracking units.

DISCUSSION

Currently, there are five petroleum refineries and three support facilities located in the Bay Area within the jurisdiction of the Air District, these are as follows:

- 1. Chevron Products Company, Richmond (BAAQMD Plant #10)
- 2. Phillips 66 Company San Francisco Refinery, Rodeo (BAAQMD Plant #21359)
- 3. Shell Martinez Refinery, Martinez (BAAQMD Plant #11)
- 4. Tesoro Refining and Marketing Company, Martinez (BAAQMD Plant #14628)
- 5. Valero Refining Company California, Benicia (BAAQMD Plant #12626)
- 6. Chemtrade West US LLC Richmond (BAAQMD Plant # 23)
- 7. Air Liquide Large Industries US LP Rodeo (BAAQMD Plant # 17419)

8. Air Products & Chemicals, Inc. – Martinez (BAAQMD Plant # 10295)

The petroleum refineries process crude oil into a variety of products such as gasoline, aviation fuel, diesel and other fuel oils, lubricating oils, and feedstocks for the petrochemical industry. Four of the five petroleum refineries have fluidized catalytic cracking units.

The support facilities provide materials such as sulfuric acid or hydrogen that are needed in various petroleum refinery processes.

As part of this agenda item, staff will provide the committee an update on the implementation of Regulation 12, Rule 15 and Regulation 6, Rule 5.
