This meeting was conducted under procedures authorized by executive order N-29-20 issued by Governor Gavin Newsom. Members of the committee participated by teleconference.

#### 1. CALL TO ORDER – ROLL CALL

The Ad Hoc Committee (Committee) on Equity, Access, and Inclusion Chairperson, Davina Hurt, called the meeting to order at 9:30 a.m.

# 3. RESOLUTION REAFFIRMING THE BAY AREA AIR QUALITY MANAGEMENT DISTRICT'S (AIR DISTRICT) COMMITMENT TO DIVERSITY, EQUITY, ACCESS, AND INCLUSION

NOTED PRESENT: Directors Jue and Miley were noted present at 9:35 a.m.

Chair Hurt opened this item by acknowledging the current national movement for racial justice emphasizing the importance of listening to the community, especially those who have endured intolerance. On behalf of the Air District, she issued an official apology to Ladonna Williams for the disrespect she experienced from two Path to Clean Air Steering Committee members on July 29, 2020. Veronica Eady, Senior Deputy Executive Officer for Policy and Equity, gave the staff presentation *Resolution Reaffirming the Air District's Commitment to Diversity, Equity, Access, and Inclusion*, including: background and the resolution language, which included a formal apology from the Air District to Dr. Henry Clark, who was subjected to disrespectful and unacceptable treatment some years ago, while he was exercising his right to provide public testimony at a Board meeting.

#### **Committee Comments**

The Committee and staff discussed Dr. Clark's accomplishments and contributions to the Richmond community; and appreciation to Air District staff for reassuring the community that the Air District is listening.

The Committee and staff discussed the current application and selection process; the desire for representation of members of impacted communities on the Advisory Council, and the request for a new public announcement inviting those from impacted communities to apply, with less focus on academic or professional credential requirements; the number of current Advisory Council vacancies; the suggestion of extending the tentative recruitment schedule; desirable characteristics of applicants, and the suggestion of giving extra consideration for applicants who live in impacted communities and/or have health problems from air quality impacts; whether the Air District has assessed the deficiencies of the current Advisory Council; compensation for Advisory Council members; the number of mandated members for the Bay Area Air Quality Management District's Advisory Council, per the California Air Pollution Control Laws, not including the ex-officio member from the Board of Directors; the feasibility of conducting the recruitment for the newlyproposed Community Advisory Committee in parallel with the Advisory Council recruitment, the suggestion that the Community Advisory Committee appoints one of its members to the Advisory Council, and the suggestion that these two bodies have equal authority; the request for racial diversity among Advisory Council members; ways in which former Chairpersons of the Board of Directors have participated on the Advisory Council; and the Committee's desire to discuss this item with the Personnel Committee, which makes the recommendations of Advisory Council candidates to the Board.

#### **BACKGROUND**

In March 2020, the Ad Hoc Committee on Equity, Access, and Inclusion was formed to advise the Board of Directors on equitable and inclusive actions to create a healthy breathing environment for all people of the Bay Area, regardless of race, ethnicity, age, gender identity, national origin, or sexual orientation. In August 2020, Veronica Eady joined the Air District as the Senior Deputy Executive Officer for Policy and Equity. These two events crystalized the need for a Community Advisory Council to advise Air District staff and the Board of Directors on policies effecting impacted communities.

#### **DISCUSSION**

The Community Advisory Council would be responsible for providing guidance on topics, such as prioritizing communities for action under the Assembly Bill (AB) 617 program, implementation of a community benefits program, and modifying the Air District's permitting program to address inequitable impacts in communities.

Air District staff will present a proposed path forward for forming a Board-appointed Community Advisory Council. This discussion will include a proposal for the scope of the Council, a membership structure that will ensure broad geographic representation, draft criteria and/or qualifications for membership, and an estimated timeline for Council development and recruitment.

At its March 25, 2020 meeting, the Ad Hoc Committee on Equity, Access and Inclusion (Committee) received a staff proposal on key equity, access, and inclusion deliverables relative to internal and external programs at the Air District. The design of a Community Benefit Fund is one element of the workplan.

On July 15, 2020, the Board of Directors adopted the Committee's Charter. The Charter shapes the Committee's oversight ensuring the Air District applies an equity lens to internal and external operations, including addressing disparities to Air District programs, policies, practices, and procedures.

The Committee's charter prioritizes traditionally marginalized and disinvested communities for investment opportunities, to ensure communities that are disproportionately impacted by air pollution, receive program and policy prioritization. Communities need resources to appropriately address environmental health impacts and to implement community-led solutions.

#### **DISCUSSION**

The Air District has historically supported community-based projects that reduce emissions, improve energy efficiency, provide air quality education, and improve community health.

The proposed Community Benefit Fund would provide monetary resources for projects in impacted communities to reduce exposure to air pollution and address public health impacts. The Community Benefit Fund would be similar to the California Air Resources Board's Community Air Grants Program aimed at providing support for community-based organizations to participate in the Assembly Bill (AB) 617 process, and build capacity to become active partners of the government to identify, evaluate, and ultimately propose projects to reduce air pollution and exposure to harmful emissions in communities disproportionately impacted. Yet, these funds will not be restricted to AB 617 communities.

The overall structure and prioritization for the program would be developed by a Community Advisory Council expected to be established by the Board of Directors in early 2021. The Air District will fund the Community Benefit Fund with an initial one million dollars, after which an estimated \$500,000 per year will be directed to the Community Benefit Fund.

#### BUDGET CONSIDERATION/FINANCIAL IMPACT

Initial funding will be supported by the General Fund in Program 104 Budget, in the amount of \$1 million dollars.

#### **RECOMMENDED ACTION**

#### **BACKGROUND**

Assembly Bill (AB) 617 was passed in 2017 to improve local air quality and health in disproportionately impacted communities. The law requires the California Air Resources Board (CARB) work with community groups, air districts, and others to select locations from around the state where communities will work with local air districts to measure and reduce air pollution. Since the passage of AB 617, the Air District has been fully dedicated to its successful implementation. In 2018, we succeeded in meeting several implementation milestones. The most notable being the state's approval of the Air District's recommendation for West Oakland as a Community Emission Reduction Planning community, and the Richmond-San Pablo area as a Community Air Monitoring Planning community in year one of the state's Community Air Protection Program. At the same time, we received state approval on our nomination of six "high priority" communities; communities who would be prioritized for selection to do monitoring and/or emission reduction plans in future years of the program. The high-priority communities include: East Oakland/San Leandro, Eastern San Francisco, East (Contra Costa) County, San Jose, the Tri-Valley, and Vallejo.

#### **DISCUSSION**

Staff will be providing an update on AB 617 funding and will give status reports on the AB 617 related work in West Oakland and Richmond/San Pablo.
