#### 3. Overview of Governor's Executive Order N-79-20

Damian Breen, Deputy APCO of Technology, gave the staff presentation *Overview of Governor's Executive Order*, including: overview; highlights; other commitments worldwide; intersection with Air District programs; climate strategy – Bay Area greenhouse gas emissions; equity and Assembly Bill (AB) 617; grants and incentives; Technology Implementation Office; Permitting and Enforcement; strategic partnerships; market and technology status – regulations, battery costs, light-duty vehicles, trucks and buses, and off-road vehicles and equipment; results from 2011-2019; and challenges and opportunities.

Public comments were given by Jed Holtzman, 350 Bay Area; Tony Fisher, Clean Air Coalition; Bill Whitney, Contra Costa Building and Construction Trades Council; Che Timmons, Plumbers and Steamfitters Local Union 342; Greg Feere; Kevin Wright, International Union of Elevator Constructors Local Union 8; Mike Miller, United Steelworkers Local Union 326; Ted Wickers, United Steelworkers Local Union 326; Tom Hansen, International Brotherhood of Electrical Workers Local Union 302; Treston Shull, Laborers' Local Union 324; Tyson Bagley, United Steelworkers Local Union 326; James Poetzscher; and Constance Beutel, Air Watch: Bay Area.

#### **Board Comments**

The Board and staff discussed the types of sales (new or used) and vehicles that are specified in the Order; why electric vehicle (EV) sales increased in the Bay Area recently; how the Air District identifies which emerging technologies to pursue, and the businesses that will be featured in the Air District's upcoming Climate Tech Marketplace 2020 event; the suggestion of asking jurisdictions what their needs are regarding improvements to mobility; how soon electric vehicles and heavy-duty trucks will have 600 + mile range capability; how soon charging stations that charge up to 200 miles in 10 minutes will be available in California; how the renewable diesel fuel that will be manufactured by Phillips 66

will affect the Air District's Diesel Free by '33 initiative, how that initiative compares with the State's objectives within the Order, and whether the Air District's goals will be met by 2033; whether all makes and models of passenger vehicles will have to convert to electric; the concern that EVs are not prevalent in Community Air Risk Evaluation program areas of the Bay Area; the public's concern about EV range anxiety; how quickly California's authority to set more stringent vehicle emission rules could be restored if the Trump Administration is no longer in power; whether Governor Newsom has indicated how the elements of the Order will be funded, and whether the Air District's authority would be increased to achieve the Order's objectives; whether interim goals or targets were stated in the Order, prior to 2035 and 2045; battery storage decommissioning; the request for more information on hydrogen storage; difficulties presented by the fact that some jurisdictions do not make much progress quickly, nor plan more than ten years out; projections of energy demand by 2035 and how much will be produced in California: whether vehicle manufacturers will allow EV owners to supply their homes with energy from their EV battery (car to home interface) during power shutoffs; the desire for the Air District to be focused on the right things and not be blindsided by false promises from the State; the suggestion of forming a regional working group that focuses on energy, and which regional agency should oversee it; the suggestion for a carbon tax; and whether people care more about how much something costs or having to change their behavior.
