3. UPDATE ON OWNING OUR AIR: THE WEST OAKLAND COMMUNITY ACTION PLAN

Greg Nudd, Deputy Air Pollution Control Officer of Policy, introduced Allison Kirk, Principal Environmental Planner, gave the staff presentation *Owning Our Air: West Oakland Community Action Plan Update*, including: community-centered air planning; commitment to implementation; community leadership; implementing subcommittees; implementation criteria framework; equity at center; Land Use Subcommittee; Transit/Bike/Walk Subcommittee; Port and Freight Subcommittee; Health and Living Buffers Subcommittee; implementation in action; and annual progress report.

Ms. Margaret Gordon and Brian Beveridge of the West Oakland Environmental Indicators Project also gave remarks about the implementation of the West Oakland Action Plan, including the participation of Caltrans and the City of Oakland's Department of Transportation.

which were made virtually available to parents whose children attended schools within the Pittsburg Unified School District, be extended to parents whose children attend other Contra Costa County schools; and the need for a diverse set of voices when building community capacity for AB 617 programs.
