#### **DRAFT MINUTES**

Summary of Board of Directors Legislative Committee Meeting Wednesday, September 30, 2020

This meeting was conducted under procedures authorized by executive order N-29-20 issued by Governor Gavin Newsom. Members of the committee participated by teleconference.

#### 1. CALL TO ORDER - ROLL CALL

Legislative Committee (Committee) Chairperson, Margaret Abe-Koga, called the meeting to order at 11:30 a.m.

Present: Chairperson Margaret Abe-Koga; and Directors John Bauters, David Canepa,

Pauline Russo Cutter, John Gioia, Scott Haggerty, Davina Hurt, and Karen

Mitchoff.

Absent: Vice Chairperson Brad Wagenknecht; and Director Tyrone Jue.

Also Present: Board Chair Rod Sinks.

#### 2. APPROVAL OF THE MINUTES OF JUNE 25, 2020

#### **Public Comments**

No requests received.

#### **Committee Comments**

None.

#### **Committee Action**

Director Canepa made a motion, seconded by Director Mitchoff, to approve the Minutes of June 25, 2020; and the motion carried by the following vote of the Committee:

#### 3. RECAP OF THE 2020 LEGISLATIVE YEAR

Alan Abbs, Legislative Officer, gave the staff presentation *Recap of 2020 Legislative Year*, including: 2020 Legislative Session; Air District-sponsored bills; and Assembly Bill (AB) 617 funding. Mr. Abbs stated that the Governor has until September 30, 2020, to approve or veto legislation from the 2020 legislative session, and that the COVID-19 pandemic has resulted in the smallest number of bills ever to come before a California governor. Mr. Abbs explained that neither of the two bills sponsored by the Air District made it to the Governor. Those bills were AB 2882 (Chu) and AB 3211 (Bauer-Kahan). However, Mr. Abbs reported that AB 617 did maintain statewide implementation funding equivalent to last year's funding. Mr. Abbs added that such funding should not be anticipated in future years.

NOTED PRESENT: Director Gioia was noted present at 11:40 a.m.

#### **Public Comments**

No requests received.

#### **Committee Comments**

The Committee and staff discussed the suggestion that the Air District speak with the Department of Finance regarding long-term sustainable AB 617 implementation funding; whether AB 617 is a reimbursable mandate; the Air District's position on Governor's plan to phase out gas-powered vehicles, per Executive Order N-79-20, and how the California Air Resources Board is complying with the Order; and the observation that AB 617 has a history of being under-funded.

#### 4. FEDERAL LEGISLATIVE UPDATE

Mr. Abbs gave the staff presentation *Federal Legislative Update*, including: Clean Corridors (DeSaulnier); Smoke Planning and Research Act (Eshoo); Special Districts Provide Essential Services Act (Garamendi); and Energy Resilient Communities (Barragan).

#### **Public Comments**

No requests received.

#### **Committee Comments**

The Committee and staff discussed how his time serving as an Air District Board member may have helped shape Congressman DeSaulnier's current outlook on air pollution.

#### 5. CONSIDERATION OF PROPOSITION 16 (2020)

Mr. Abbs gave the staff presentation *Consideration of Proposition 16*, a constitutional amendment to repeal Proposition 209 (1996), which prohibits the state from discriminating against, or granting preferential treatment to, any individual or group on the basis of race, sex, color, ethnicity, or national origin in the operation of public employment, public education, or public contracting, and is the result of the passage of Assembly Constitutional Amendment 5. The Committee continued to consider a position on California Proposition 16, repeal of Proposition 209, appearing on the November 3, 2020 General Election Ballot.

#### **Public Comments**

No requests received.

#### **Committee Comments**

The Committee and staff discussed the need to dismantle systematic racism and gender inequality; and the fact that some politicians of color have felt conflicted about this issue.

#### Committee Action

Director Hurt made a motion, seconded by Director Bauters, to **adopt** a SUPPORT position on Proposition 16 (2020) to repeal Section 31 of Article 1 of the California Constitution; and the motion carried by the following vote of the Committee:

#### 6. 2021 LEGISLATIVE ACTIVITIES

Mr. Abbs gave the staff presentation 2021 Legislative Activities, including: previous Air District-sponsored bills; other legislative ideas; and potential other bills. Topics included: indirect source authority, meeting compensation for Air District's Board members, intellectual property authority, amending Assembly Bill 617 or the Community Air Protection program, composition of the Air District Board, and the reauthorization of existing air pollution funding sources whose fund are to expire in 2023.

#### **Public Comments**

Public comments were given by Jed Holtzman, 350 Bay Area; Steve Nadel, Sunflower Alliance; and Richard Gray, 350 Bay Area.

#### **Committee Comments**

The Committee and staff discussed whether the Air District should pursue legislation to change the composition of its membership to include a member from the environmental justice community; the suggestion of prioritizing the recruitment for an environmental justice community member on the Air District's Advisory Council, and how long it might take to change that provision in the Health and Safety Code to effect this change; the anticipated number of bills it may take to pursue changes to the composition of both the Air District's Board and Advisory Council, and the suggestion that the Legislative Committee first makes a recommendation to the Board before pursuing a legislative change; New Jersey's recently passed law (S232) which requires the state's Department of Environmental Protection to evaluate environmental and public health stressors of certain facilities on overburdened communities when reviewing certain permit applications; whether the Air District should prioritize the pursuit of reclaiming the authority to regulate carbon dioxide emissions from stationary sources already subject to the Cap-and-Trade program, currently prevented by AB 389; the importance of including health impacts from air pollution in socioeconomic analyses; the suggestion that the Air District keeps pursuing indirect source authority, despite the status of AB 3211 (Bauer-Kahan), and the suggestion of asking Nancy Skinner to champion a new bill; whether to prioritize the Air District's ability to increase fines or indoor air quality authority; the Air District's pursuit of a new author for its bill to prohibit an Environmental Impact Report or Negative Declaration from being approved for any project involving the purchase or construction of a new chartered elementary or secondary school; the date of the Committee's next meeting; and the need to keep pursuing AB 617 funding and Greenhouse Gas Reduction Fund programs.

#### 7. OVERVIEW OF GOVERNOR'S EXECUTIVE ORDER N-79-20

Mr. Abbs gave the staff presentation *Overview of Governors' Executive Order N-79-20*, focusing on vehicular emission reduction targets to address climate change.

The Committee and staff discussed the fact that car and truck regulations may require U. S. Environmental Protection Agency waivers.

Re: 2021 Legislative Activities

#### RECOMMENDED ACTION

The Legislative Committee (Committee) will receive a report from staff on potential legislative activities in 2021, providing direction as necessary.

#### **BACKGROUND**

The new 2021-2022 Legislative session is set to begin on December 7, 2020. Potential bills will need to be introduced by mid-February 2021, official date pending.

#### DISCUSSION

In addition to the usual work on the state budget, below is a list of potential legislative activities for 2021, including ideas for Air District-sponsored bills as well as other potential bill activity of interest.

#### **Previous Air District-Sponsored Bills**

Expansion of Indirect Source or Magnet Source Authority – In 2020, the Air District sponsored Assembly Bill (AB) 3211, authored by Assemblymember Bauer-Kahan, to expand indirect source authority to include air toxics in addition to pollutants in excess of state ambient air quality standards. This bill was an early casualty of the reduction in bills due to COVID-19 in March as it had been double-referred. Staff has asked Assemblymember Bauer-Kahan's office about authoring the bill in 2021.

Private/Charter School Requirements for Air Quality Review Under the California Environmental Quality Act (CEQA) – In 2020, the Air District sponsored AB 2882, authored by Assemblymember Chu, to require new private and charter schools to work with their local air district to identify nearby sources of air emissions that could have public health impacts to school students and employees. The bill easily passed the Assembly but did not receive a hearing in the Senate due to another round of bill hearing reductions in August. This bill is a good candidate for reintroduction but will need a new author as Assemblymember Chu is leaving office.

#### **Other Legislative Ideas**

Wildfire Smoke Public Health Response – Over 4 million acres burned this year in California and the District called over 50 Spare the Air days due to wildfire smoke. While the Air District has elevated our public health communication, smoke monitoring and modeling, and works closely with local health officers and organizations such as the Red Cross, we see gaps in an equitable public health response that could potentially be addressed through changes in policy. Ideas include either advocacy or legislation to 1) improved Title 24 standards for HVAC filtration in new residential or nonresidential construction, or in subsequent renovation work; 2) create a requirement and incentive program funding to improve filtration in existing rental housing; 3) expansion of funding for HVAC retrofits or filter replacements through programs such as Assemblymember Wicks' Clean Air Center Pilot Program.

#### **Potential Other Bills**

Carl Moyer/AB 923 (Firebaugh; Chapter 707, Statutes of 2004) Reauthorization or Other Program Changes – Authorization for the majority of Carl Moyer and AB 923 Mobile Source Incentive Fund (MSIF) funding expires at the end of 2023. Staff is aware of discussions among stakeholders about a possible reauthorization effort in 2021 that would include California Energy Commission (CEC) and CalRecycle programs also sunsetting in 2023. Should this type of bill be introduced, the Air District will likely be heavily involved.
