The Committee asked whether Mr. Monh could be appointed to the Alternate position in the Professional Engineer category, provided that Ms. Fortney was appointed to the Principal position, and that the Committee deemed Mr. Monh appropriate for the position. Air District staff said that Mr. Monh could be appointed to the Alternate position, under those circumstances.
