What is the CAC?

The CAC is the Community Advisory Council that was approved by the Board of Directors on November 17th, 2021.

The CAC advises and consults with the Board of Directors and the Executive Officer on community related matters and environmental justice issues.

The Council also exercises its own initiative in selecting areas for exploration and study.



Who is represented in the CAC?

- The CAC is composed of 17 members
- All 17 members represent the Bay Area
- The counties are: Solano, Contra Costa, San Francisco, Alameda, San Mateo, Santa Clara.
- We also have 2 members representing “at large” and 2 youth representatives.



Community Advisory Council Co-Chair Duties



Provide leadership, stewardship, and oversight of the Community Advisory Council (CAC)

Collaborate with Council Members to set meeting agendas

Oversee the activities of the CAC Ad Hoc Committees

Ensure decisions are made in a democratic, equitable and timely manner

Guide, prioritize, and oversee the activities of the CAC

Representing the CAC and liaising with the Board

The goal of the CAC

- One of the many goals the CAC Co-Chairs would like to accomplish is fulfilling the promise of selecting a Board member to serve as a liaison to the CAC.
- On March 3rd, 2022, The Community Equity, Health, & Justice Committee held a meeting and one of the agenda items was an update on the CAC.
- During this meeting, Suma Peesapati stressed the need for the CAC to establish a relationship with the Board.
- As part of that discussion, the question was posed if the CAC would like a liaison from the Board.



Who will serve as a Liaison from the Board?



- The importance of designating a liaison from the Board was a top priority.
- The liaison will be a progressive Board member who has excellent communication skills, showing genuine interest in resolving environmental justice issues and concerns within the community.
- Connecting the community with the Board to establish trust by conflict resolution and problem-solving.

Status of the Board Liaison

On September 19th, 2022, there was a meeting with Board Leadership.

I expressed to the leadership of the Board the importance of selecting a liaison for the CAC and why the role of the liaison is important to the community.

Since the meeting, there has not been any follow-ups from the Board nor an update about the process of selecting a Board member to serve as the CAC's liaison.



Next Steps

- We are awaiting a designated liaison from the Board.
- The CAC Co-Chairs request for a member of the Community, Health, and Justice Committee to serve as the liaison.
- Meet with the leadership of the Board to move forward with a liaison.
- The CAC would also like to select a member of our council to report updates to the Board during their meetings.

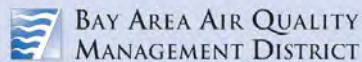

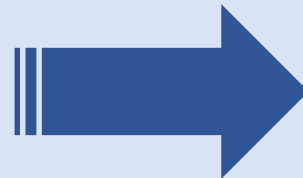

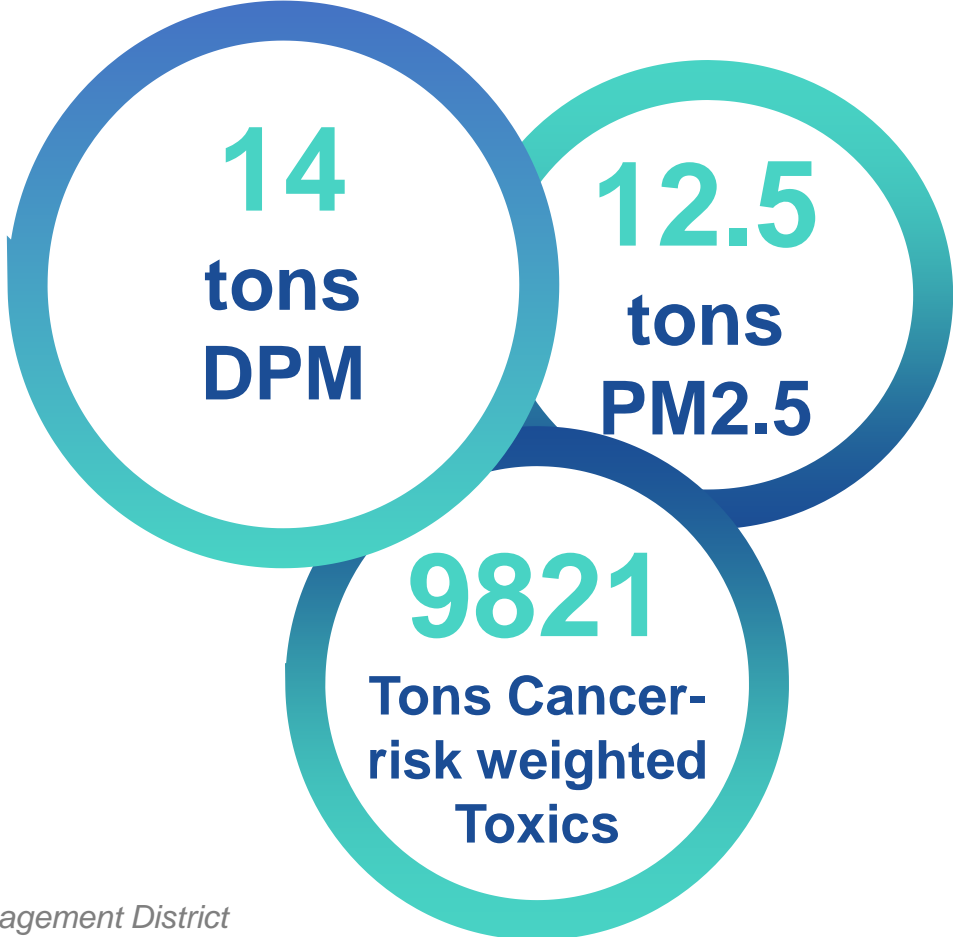
Emission Reductions 2018-2022

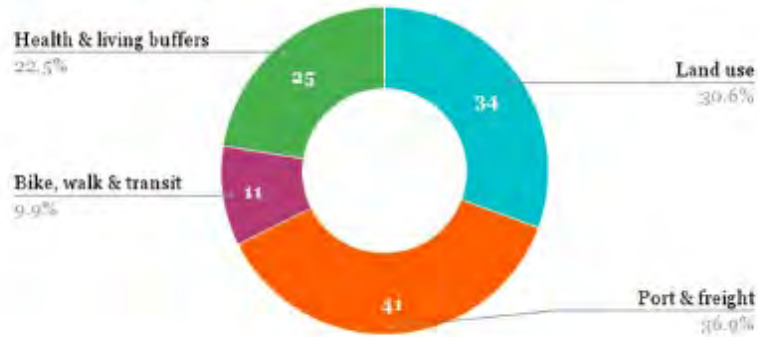

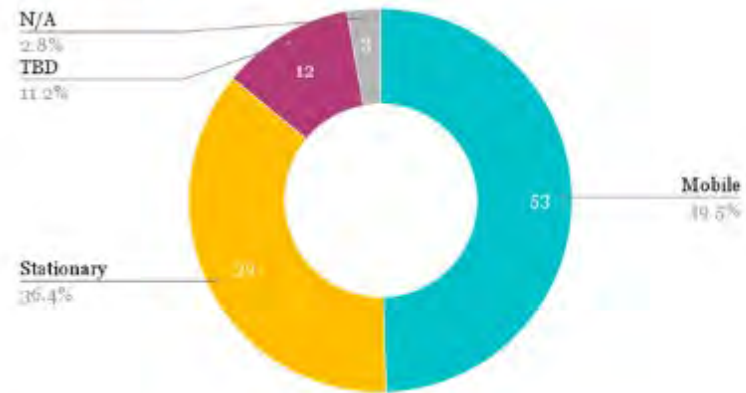

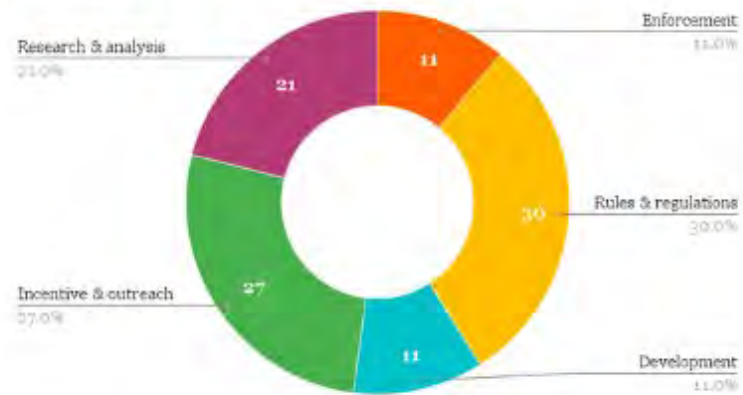
Total strategies by issue area



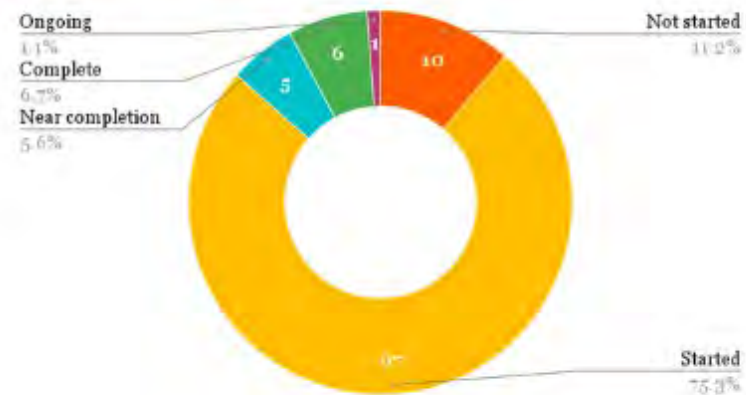
Total strategies by type of emissions source

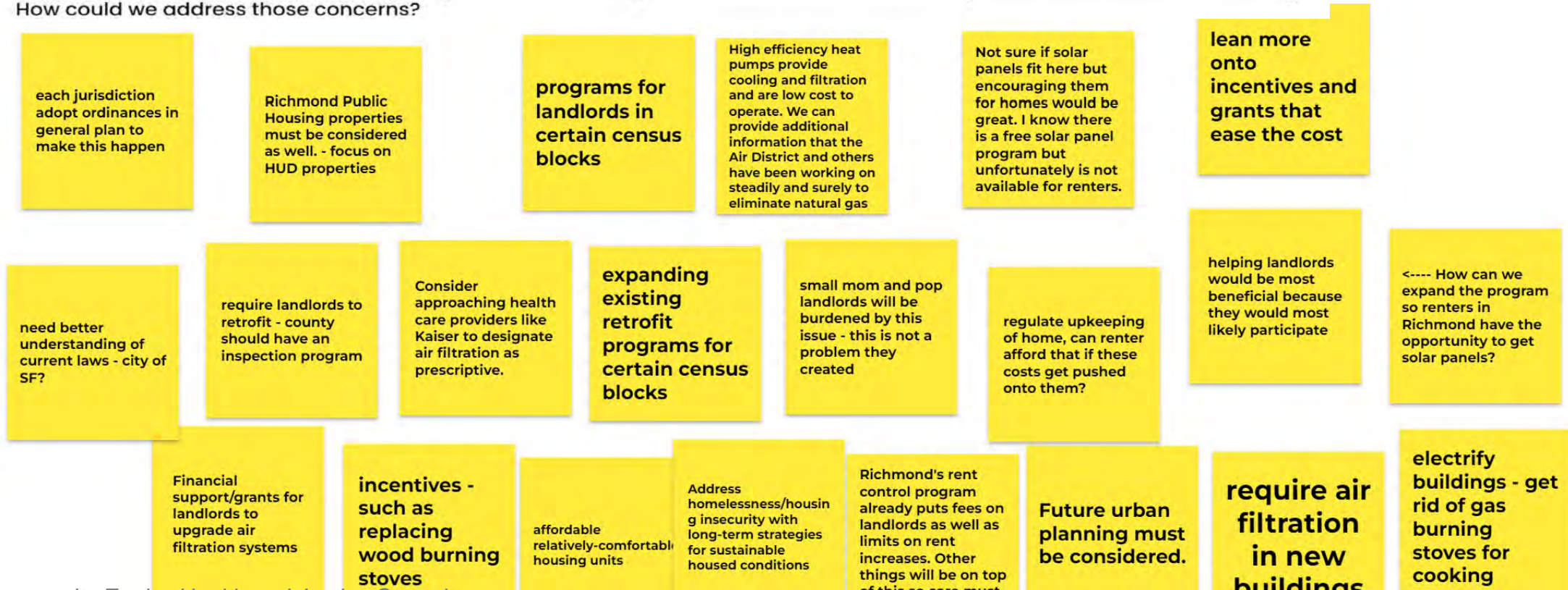

How could we address those concerns?



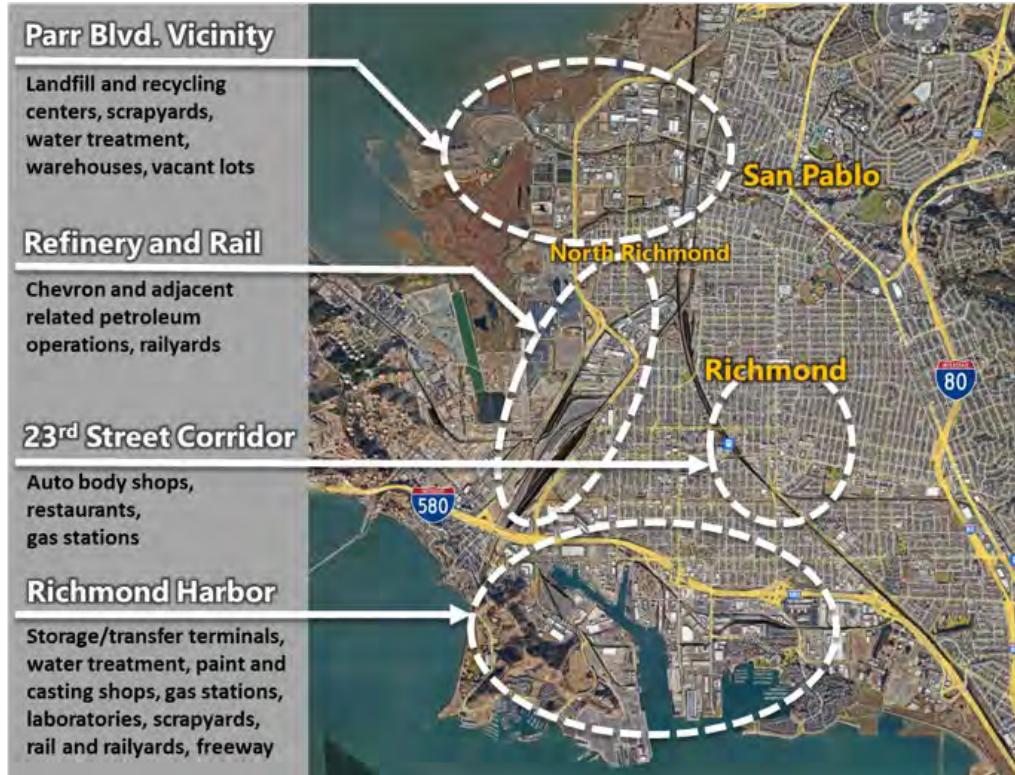
Path to Clean Air Timeline: Where Have We Been and Where Are We Headed

Path to Clean Air Community Air Monitoring Plan (CAMP)



- CAMP Community Steering Committee (CSC) selected an air toxics monitoring project and identified facilities of concern and nearby communities with high health burdens (July 2020)
- Completed data collection and initial analysis (October 2022)
- Monitoring Outreach Team, a subset CAMP CSC, reviewed results (October 2022)
- Results will be published as online story map (with language translation) and more detailed technical documents to follow
- Air District is reviewing results to identify actions for further investigation and/or to reduce emissions

East Oakland Community Emissions Reduction Plan



- East Oakland Community Emissions Reduction Plan (CERP)
 - Co-Lead Partner: Communities for a Better Environment (CBE)
 - Partnered to develop the successful nomination of East Oakland to CARB for a CERP process
 - Co-developed effort to outreach and establish an East Oakland Community Steering Committee (CSC) to guide CERP development
 - Co-Lead the CERP process and strategy development
 - Facilitator: Just Cities, LLC
 - With CBE's support, Just Cities contracted to provide administrative, logistical, and co-facilitation support to the East Oakland CSC, along with capacity-building training for Air District, CBE and CSC members

East Oakland Community Steering Committee



- Review Committee comprised of CBE and Air District staff
- Determined the composition of the East Oakland CSC (see table)
- Reviewed applications after two months of outreach and selected a 26-member CSC

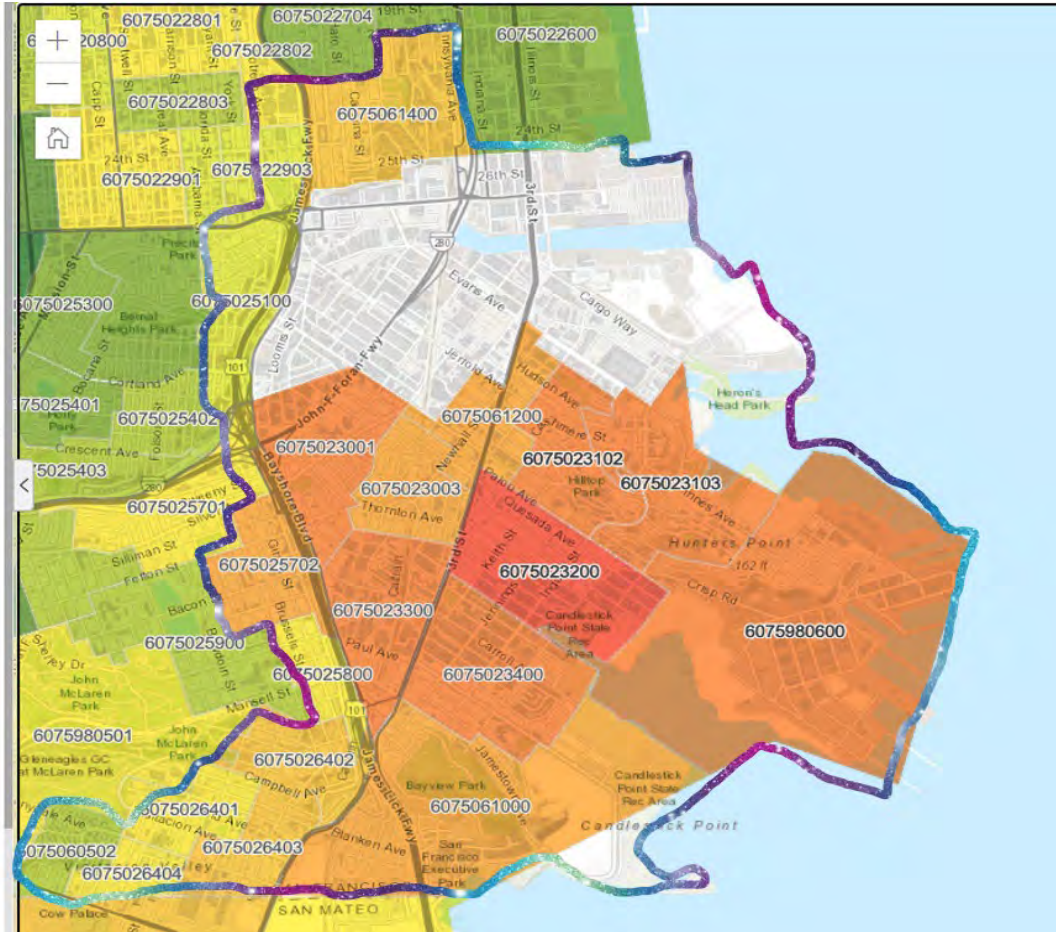

Proposed East Oakland CERP Timeline



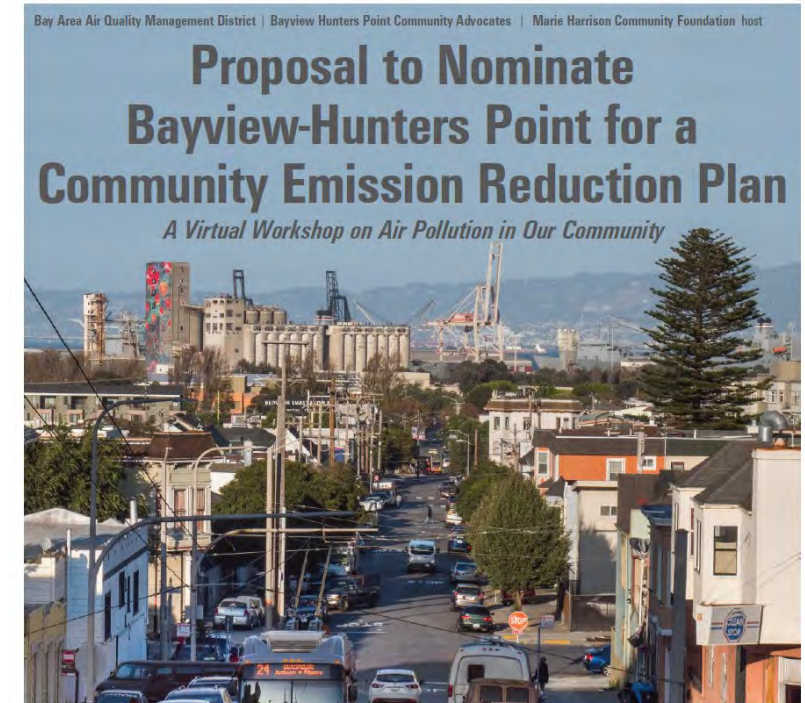

Bayview Hunters Point San Francisco Selection Timeline



- **September 15, 2022** - Co-leads hold BVHP community meetings on proposed self-nomination.
- **October 6, 2022** - Co-leads present to the Community, Equity, Health and Justice Committee on recommendation to select BVHP
- **October 27, 2022** – Air District and co-leads hold a Bayview Hunters Point AB 617 workshop
- **November 2, 2022** – Board of Directors support recommendation for a Bayview Hunters Point CERP Selection
- **December 6, 2022** – CARB statewide AB 617 workshop
- **February 22, 2023** - Air Resources Board votes on nomination
