5. CONSIDER RECOMMENDING THAT THE BOARD OF DIRECTORS DISSOLVE THE PATH TO CLEAN AIR COMMUNITY STEERING COMMITTEE (CSC) APPOINTED BY RESOLUTION NO. 2021-02 TO ALLOW FOR THE CREATION OF A NEW, NON-BOARD-APPOINTED STEERING COMMITTEE WITH A COMMUNITY-LED GOVERNANCE STRUCTURE

Dr. Wendy Goodfriend, Acting Climate Protection Manager, introduced two members of the Richmond Area Path to Clean Air CSC, Marisol Cantu and Alfredo Angulo, who gave the presentation *Vote to Dissolve the Path to Clean Air CSC Appointed by Resolution No. 2021-02 to Allow for the Creation of a New, Non-Board-Appointed Steering Committee with a Community-Led Governance Structure*. Slides included: outcome; outline; requested action; overview of CSC governance; CSC member concern; CSC votes to recommend dissolution; overview of plans for a community-governed CSC; process and timeline; reconfiguration of CSC; creating a new charter; approval of new charter; and feedback requested/prompt.

In addition, Deldi Reyes, Director of the Office of Community Air Protection at the California Air Resources Board, gave remarks regarding the governance styles of AB 617 CSCs in other parts of the state.

#### **Committee Comments**

The Committee and staff discussed how the reconfiguration of the CSC and its new governance structure would not involve the Board's authority, and what role Air District staff and the Board would have with the CSC after it is reconfigured; whether the meetings of the reconfigured CSC would be open to the public, broadcasted, and in person; the anticipated changes in membership after the transition of the CSC; the composition (students, industry representatives, other types of stakeholders) of the current configuration of the CSC; whether criteria to ensure diversity will be utilized when selecting members for the reconfigured CSC; how the current CSC's Governance Ad Hoc Committee is executing the application process for the CSC's new configuration; and concerns about evaluating conflicts of interest for the members of the reconfigured CSC.
