2024 Legislative Session



• January 3, 2024 – Legislature reconvenes.

Bill Introduction Deadlines for Members:

- January 19, 2024 Last day to submit bill requests to the Office of Legislative Counsel.
- February 16, 2024 Last day for bills to be introduced.

Green and Healthy Buildings



a. Disclosure Requirements for Sale of Property

Proposal would require disclosure of applicable state or local requirements that could potentially limit a future owner's ability to purchase appliances that do not meet zero-NO_x standards.

Staff Recommendation: Continue discussions with legislative offices and Sponsor/Co-Sponsor/Support any legislative efforts to address these concerns.

Green and Healthy Buildings (cont.)



b. Homeowner Association (HOA) Limitations

Proposal would limit the ability of HOAs to deny a homeowner the ability to replace an older appliance with a new appliance if the new appliance may result in an alteration to the exterior of the property.

Staff Recommendation: Continue discussions with legislative offices and Sponsor/Co-Sponsor/Support any legislative efforts to address these concerns.





c. State Housing and Community Development (HCD) Restrictions

Proposal would amend various existing statutes that may limit the ability of HCD to allow certain zero-NO_x appliances to be installed in mobile homes and manufactured homes

Staff Recommendation: Continue discussions with legislative offices and Sponsor/Co-Sponsor/Support any legislative efforts to address these concerns.

Refinery/Stationary Source Penalties



Assembly Bill (AB) 1465, introduced in 2023 by Assemblymember Wicks, was originally introduced to triple penalties at refineries for discharges of one or more toxic air contaminants and was later amended to increase penalties for all Title V stationary sources if the discharge includes one or more air contaminants, as specified.

Staff Recommendation: Continue working with Assemblymember Wicks on potential amendments to AB 1465.

F-Gas Recovery



F-Gas Recovery from Discarded Refrigerators, Freezers, and Air Conditioners

- Proposal could create a product stewardship model where manufacturers are required to create a program to properly recover refrigerants or develop an up-front fee on purchase of new appliances that fund an end-of-life program for discarded appliances.
- Proposal could require additional handling requirements for the network of solid waste handlers involved in various aspects of appliance recovery.

Staff Recommendation: Continue research, and if feasible, Sponsor/Co-Sponsor/Support any legislative efforts to address these concerns.

Brake Wear Particulate



Proposal would look at the potential to reduce brake wear dust from light-duty vehicles by limiting the purchase of metallic brake pads upon replacement, with replacement options limited to semi-metallic, organic, or ceramic.

Staff Recommendation: Continue research, and if feasible Sponsor/Co-Sponsor/Support any legislative efforts to address these concerns.

State Budget Process



Budget Deadlines:

- January 10, 2024 The Governor will release the proposed budget for the next fiscal year.
- May 14, 2024 The Governor will release the revised budget proposal ("May Revision" or "May Revise").
- June 15, 2024 The Legislature must pass a balanced budget.
- July 1, 2024 The Governor signs the budget package.
- After July 1st The Legislature may pass budget amendments and other changes to the adopted budget package.
