# 5. AIR MONITORING AND MODELING OF INCIDENTS: OPTIONS AND NEXT STEPS, FORMATION OF AN AD HOC COMMITTEE

Dr. Ranyee Chiang, Director of Meteorology and Measurement, gave the staff presentation *Air Monitoring and Modeling of Incidents: Options and Next Steps, Formation of Ad Hoc Committee,* including: action requested; outline; current Air District role during incidents; limitations to current Air District role during incidents; incident reports 2018-2022; summary of proposal – timeline; key components of incident monitoring/modeling; limitations and challenges; competing priorities/strategic opportunities; source of funds; and action requested.

#### **Public Comments**

Public comments were given by Kathy Kerridge, Benicia resident; Dr. Stephen Rosenblum, Climate Action California; and Jan Warren, Interfaith Climate Action Network of Contra Costa County.

#### **Committee Comments**

The Committee and staff discussed what type of emissions reports are circulated to the public by the Air District, county health officials, and refineries after an incident; the desire to see the proposed ad hoc committee be subject to the Ralph M. Brown Act, for the public's benefit; how to utilize the data from Contra Costa County Health Services' Hazardous Materials programs to improve onsite incident monitoring; the desire to the Air District enhance its involvement during and after incidents, even though the Air District is not a first responder in those situations; and the desire to know that the public is breathing during incidents, and the cumulative effect of incidents.

#### Committee Action

Director Ross made a motion, seconded by Director Gioia, to commend the Board **appoint** an ad hoc committee that is intended to help guide the development of a possible incident response monitoring and/or modeling program, and report back to the full Board. (If approved by the Board, the Board Chair will determine whether the ad hoc committee would be subject to the Ralph M. Brown Act.)

Re: Air District Comments on the Proposed EPA Revisions to the Particulate Matter

National Ambient Air Quality Standards

#### RECOMMENDED ACTION

None: receive and file.

#### **BACKGROUND**

The Clean Air Act (CAA) requires the United States Environmental Protection Agency (EPA) to set National Ambient Air Quality Standards (NAAQS) for each of the six criteria pollutants – carbon monoxide (CO), lead (Pb), particulate matter (PM), ozone (O<sub>3</sub>), nitrogen dioxide (NO<sub>x</sub>) and sulfur dioxide (SO<sub>x</sub>). After a new NAAQS or a revision to an existing NAAQS has been set, EPA is required to determine and designate areas of the country for attainment (meeting the standard) or nonattainment (not meeting the standard).

On January 6, 2023, EPA proposed revisions to the primary annual PM<sub>2.5</sub> NAAQS. Specifically, EPA proposed reducing the primary annual PM<sub>2.5</sub> NAAQS from 12  $\mu$ g/m<sup>3</sup> to a range between 9  $\mu$ g/m<sup>3</sup> and 10  $\mu$ g/m<sup>3</sup>. EPA is also proposing additional changes to the monitoring requirements and to the Air Quality Index breakpoints.

EPA is soliciting comments on the proposals and specifically requesting feedback on revising the primary annual PM<sub>2.5</sub> NAAQS to a range between 8.0  $\mu$ g/m<sup>3</sup> and 11  $\mu$ g/m<sup>3</sup>. And although EPA is proposing to retain the primary 24-hour PM<sub>2.5</sub> NAAQS, they are also soliciting feedback on revising this standard to as low as 25  $\mu$ g/m<sup>3</sup>.

#### **DISCUSSION**

Staff are reviewing the proposal and drafting written comments. Lowering the PM NAAQS protects public health. However, the San Francisco Bay Air Basin (Air Basin) may not meet attainment of the proposed revisions to the PM<sub>2.5</sub> NAAQS and be designated nonattainment.

Nonattainment areas are regions that do not meet the NAAQS. The CAA requires states to develop a plan to attain and maintain the NAAQS for each criteria pollutant and area that is designated nonattainment. These plans are known as State Implementation Plans (SIP) and are developed by state and local air quality agencies. In general elements of a SIP may include:

- Air quality monitoring
- Air quality modeling
- Emission inventories
- Emission control strategies
- Policies and rules implemented to attain and maintain the NAAOS

The California Air Resources Board (CARB) is the state agency with primary responsibility for coordinating and submitting the state's SIP to EPA. The Air District is responsible for developing the regional level elements of the SIP for the San Francisco Bay Area. Because the Air Basin is designated nonattainment for ozone and particulate matter, the Air District has developed and submitted an approved SIP. However, the development of an updated particulate matter SIP to meet the proposed NAAQS will be challenging as large sources of particulate matter emissions are related to mobile sources and woodsmoke in the Bay Area. There are also environmental justice and staff resource considerations.
