27. AMENDMENTS TO REGULATION 8: ORGANIC COMPOUNDS, RULE 18: EQUIPMENT LEAKS (RULE 8-18), AND ADOPTION OF A NEGATIVE DECLARATION FOR THE AMENDMENTS TO RULE 8-18 PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

The Board of Directors held a required public hearing to consider adoption of a Resolution to adopt proposed amendments to Regulation 8: Organic Compounds, Rule 18: Equipment Leaks (Rule 8-18) and adopt a Negative Declaration pursuant to the California Environmental Quality Act finding that the proposed amendments will not have any significant adverse environmental impacts.

Robert Cave, Senior Air Quality Engineer, gave the staff presentation *Proposed Amendments to Regulation 8: Organic Compounds, Rule 18: Equipment Leaks,* including: outcome; requested action; outline; background – rule purpose; valves, pumps, connections; previous rulemaking; heavy liquids study; rule development process; purpose of proposed amendments; proposed amendments; emission reductions; compliance costs; cost effectiveness analysis; incremental cost effectiveness analysis; socioeconomic impact analysis; CEQA impact analysis; Air District impacts; summary of comments received; cost effectiveness comparison using Western States Petroleum Association's recommended emission factors; statutory findings; and resolution and recommendation.

Chair Hurt opened the public hearing.

Public Comments

Public comments were given by Kevin Buchan, Western States Petroleum Association; Jan Warren, Interfaith Climate Action Network of Contra Costa County; Matt Diaz, Chevron; and Todd Osterberg, Chevron.

Board Comments

The Board and staff discussed the types of facilities that will experience emissions reductions as a result of this regulation amendment; the anticipated frequency of equipment inspections; the manner in which

the compliance cost was determined, and the historical values of cost effectiveness; concerns from industry regarding emission estimates; whether evaluating compliance cost relative to net income is prescribed by a statute; intended health benefits of this rule; whether the compliance cost of this rule can be compared to the cost per ton effectiveness of the Air District's Rule 6 -5 (Particulate Emissions from Petroleum Refinery Fluidized Catalytic Cracking Units); whether the Air District is in compliance with the stay litigation (enforcement agreement) brought by three refineries that challenged the Board's adopted amendments to Rule 8-18 in December 2015 (removing the monitoring exemption for equipment servicing heavy liquids); whether the Air District will be able to hire the staff necessary to implement this amended rule; the fact that this rulemaking is behind schedule (original deadline was December 2203); whether there are any practical impacts of postponing this rulemaking; the level of the Air District's engagement with industry prior to this public hearing, and whether creating a technical advisory committee would be helpful; concerns about using net income as a measure of burden; and the reasons for industry's opposition to the rule's amendments.

Chair Hurt closed the public hearing.

28. RECONSIDERATION OF BOARD-APPROVED POSITION FOR SENATE BILL (SB) 1298 (CORTESE)

Viet Tran, Deputy Executive Officer of Public Affairs, had planned to give a staff presentation that would have asked the Board to consider changing its position on SB 1298 (Cortese) from "Oppose Unless Amended" to "Neutral". (The context for doing so can be found on Page 725 of the <u>Board's the September 4, 2024 agenda packet.</u>) However, Mr. Tran waived his presentation and instead reported that SB 1298 (Cortese) was re-referred to the California Assembly's Committee on Rules on August 27, 2024, signaling there was an effort to make last-minute amendments before a final vote on the Assembly Floor. The bill remained in the Assembly Committee on Rules and was not referred back to the Assembly Floor for a vote; therefore, the bill did not meet the August 31, 2024 midnight deadline for bills to be passed by the Legislature. SB 1298 was dead by the time the Board would have considered a change in position at the September 4, 2024 Board meeting; therefore, no action was taken by the Board.

33. **REPORT OF THE EXECUTIVE OFFICER/APCO**

Dr. Fine reported the following:

— **AB 1465 (Wicks) Stationary source penalties-** This bill was sponsored by the Air District and triples the penalty ceiling for Title V stationary sources for violations of air quality law resulting in emissions of specified pollutants. *This bill passed in both houses 25 minutes before the end of the legislative session and has been sent to the Governor for signature.*

- **SB 674 (Gonzalez) Refinery monitoring-** This bill was not sponsored by the Air District, but we provided significant support to the sponsors, EarthJustice. *This bill passed the Legislature, but was vetoed by the Governor.*
- **SB 382 (Becker) Realtor disclosures** This bill was sponsored by the Air District and would require future single family residential transactions to include a disclosure related to any future state or local requirements that potentially limit future replacement of existing gas appliances with a similar gas appliance. *This bill passed and has been sent to the Governor for signature*.
- AB 2298 (Hart) Protecting Blue Whales and Blue Skies- This bill was co-sponsored by the Santa Barbara and Bay Area Air Districts and would have expanded the existing "Blue Whales and Blue Skies" program along the entire California Coast. Due to state fiscal concerns, *this bill was held in Senate Appropriations and died*.

The U.S. Department of Energy will provide \$1.26 billion dollars in funding to support the development of a regional clean hydrogen hub in northern California. ARCHES is the state's initiative to accelerate renewable hydrogen projects and develop the necessary infrastructure. This Hydrogen Hub will facilitate hydrogen's use as an energy source for electricity generation, vehicles, and manufacturing, with the only emissions being air and water.
- The Air District has launched its new Clean Air Talk series, featuring Air District Board Chair Davina Hurt, to be held in communities throughout the Bay Area. Chair Hurt wishes to hear from local communities about what their thoughts and concerns are regarding air quality in their
