Advancing an Equitable Transition To Clean and Healthy Buildings



- Climate Protection Program, Assistant Manager Dr. Idania Zamora presented an overview of the Air District's effort to transition to a zero-NO_X space and water heating in residential homes across the San Francisco Bay Area.
- CAC Council Members inquired on the feasibility of the project in relation to displacement of individuals, electricity cost, and outreach.
- Next steps:

Community Advisory Council September Retreat Next Steps



- Co-Chair Washington provided highlights of the September CAC Retreat and followed up on the equity statement discussion
- CAC requests the drafting of an equity definition based on proposed themes
- Next steps:

Election of a Third CAC Co-Chair



- Ms. Margaret Gordon stepped down as one of the three Co-Chairs of the CAC at the September CAC Retreat
- The CAC Charter states that the CAC has two meetings to re-elect a Co-Chair if a seat is vacated
- The CAC was notified of the election process and timeline, which included the submission of candidate essays by Dec. 28th
- Council Member Ken Szutu was the one candidate and was voted in as the third Co-Chair, effective immediately

Funding Community Benefits from Penalty Funds

- This will be covered in more depth by District staff in an additional presentation
- Greg Nudd, Deputy Executive Officer, presented an action item for the Council to consider recommending a proposal for creating a policy that automatically sets aside a portion of penalties for regional and local community benefits
- Next steps:
 - Bring the CAC's three recommendations to the CEHJ Committee of the Board of Directors
 - Provide CAC Members additional information for the co-development of a policy that automatically sets aside a portion of penalties for regional and local community benefits

Compliance and Enforcement Update



- Tanya Boyce, Executive Director of the Environmental Democracy Project, Brian Case, Assistant Counsel of the Air District's Legal Office, and Paul Grazzini, Supervising Air Quality Specialist of the Air District's Compliance and Enforcement Division, presented a retrospective review of the enforcement case related to the Green Sage Cannabis Cultivating Facility's illegal use of diesel generators in Oakland.
- CAC Members inquired on how the agency plans to implement lessons learned and improve how compliance staff confirm community complaints that are reported.



Consistently Nominated Communities

Community Air Grants - New Project Type

- Purpose: Technical assistance funding to community based non-profit organizations and California Native American Tribes
- A new CAG project type Local CERP will support grant recipients in prioritizing air quality concerns
- Learn from current examples/projects
- Public process in 2024 to refine the next cycle of CAG Request for Applications and provide requirements

Community Air Grants (CAG)

Cycle 3 – <u>\$10M</u> in funding to 39 projects – in progress
Cycle 4 – <u>\$10M</u> in funding to 42 projects – selection announced, grant agreements in development

Cycle 5 – <u>\$16M</u> in funding = \$10 M (FY22-23) + \$6M (FY23-24)

Cycle 6 – Gov. Jan 10 proposal (FY24-25) – <u>\$5M</u> in funding proposed



CAG Timeline

Cycle 4 – Upcoming Kick-off Meetings in Spring 2024 (~April/May 2024) Cycle 5 – Public engagement process RE: Request for Applications Update starting ~late Spring/Summer 2024 (starting ~May 2024)

- 2 public workshops
- Focused discussions with stakeholders
- 2 Pre-application assistance public workshops



Cycle 5 CAG Project Types

- Educational max \$300K/project ~ 2yr grant term
 - Ex. Educational related projects on variety of Community Air Protection air quality issues.
- Technical (i.e., monitoring) max \$500K/project-
 - ~2-2.5yr grant term
 - Ex. Monitoring related projects to inform, with technical data, the community on air quality issues.



Cycle 5 CAG Project Types Targeted:

- Emission Reduction Strategy Expansion (ERSE, can include monitoring) – Max \$500K/project ~ 3yr grant term
 - Ex. Projects to develop and identify successful strategies that can be applied across communities with similar sources of air pollution or adopted as a statewide effort.
- Local- Community Emission Reduction Plans (L-CERPs, can include monitoring) – Max \$500K/project ~ 3yr grant term
 - Ex. A multi-faceted approach project that could include community capacity building, development of a community air monitoring plan, and, or development of an emissions reduction strategy.



Community-Focused Enforcement

- Partner to understand issues not being addressed
- Concentrate on community-identified areas, some of which we have not traditionally enforced
- Co-develop enforcement plans
- Can be used in:
 - Currently selected communities
 - L-CERP developed by a CAG
 - Other community-led partnership


