#### 5. TRANSPORTATION FUND FOR CLEAN AIR COUNTY PROGRAM MANAGER FUND

Karen Schkolnick and Alona Davis, Director and Manager (respectively) in the Strategic Incentives Division, gave the staff presentation *Transportation Fund for Clean Air County Program Manager Fund, including*: outcome; outline; Bay Area Air Quality Management District mobile source grants; TFCA CPM Fund background; TFCA CPM allocation from July 2022 to July 2023; eligible project categories and applicants; key eligibility requirements; program timeline; how agencies used funding in 2022; examples of recent projects; and questions for the Council.

#### Public Comments

Public comments were given by Coire Reilly, 511 Contra Costa.

#### Council Comments

The Council and staff discussed concern about the perceived lack of public engagement by the CPMs in deciding how to allocate funds, and the desire for more transparency from the CPMs; to what extent the Council can shape the program criteria; whether program funding includes the cost of electrical upgrades to accommodate electric vehicle (EV) charging infrastructure (not just installation); lessons learned by the Air District over the past several years; how the Air District ensures that program funds are funding EV charging infrastructure in underserved communities; the suggestion that the CPMs engage with Assembly Bill (AB) 617 community steering committees to brainstorm ways in which clean air vehicle projects could specifically benefit disadvantaged communities; the request for a map of awarded projects and a list of entities targeted for program outreach; whether needs assessment reports that are collected by the Air District are utilized by the CPMs when scoring applications; the belief that the sales of EVs in disadvantaged communities is dependent on the installation of EV charging infrastructure being installed first; whether the CPM Fund Policies are the same, across all counties; whether the Metropolitan Transportation Commission could fund the projects being submitted to the program; the request

for a chart that shows the Air District's different mobile source grant funding sources; which Bay Area community-based organizations have already been awarded funds; concerns about the fact that the Air District and CPMs add their own legislative requirements on how funding may be used; program reporting requirements; whether funding is available to educate the overburdened communities about the program and for technical assistance; and when Air District staff plans to address these concerns and requests with the CMPs.

#### 6. **INTRODUCTION TO AIR DISTRICT RULE DEVELOPMENT**

Elizabeth Yura, Director of the Rules and Strategic Policy Division gave the staff presentation *Introduction to Air District Rule Development*, including: presentation for information only; outcome; outline; what are air quality regulations; stationary versus mobile sources; who writes air quality regulations; Air District authority; regulatory example: refineries; when are regulations created or amended; case study: impacts of community on regulations; what is the purpose of the Rules and Strategic Policy Division; case study: expectations versus reality; current rule development priorities; overview of rule development process; additional analyses: health impacts and benefits; and where can I find the Air District's regulations.

Public Comments

#### Council Comments

The Council and staff discussed the way in which the Air District measures the effectiveness of its adopted regulations; the request for the most recent amendments made to Chapter 6.5 (Regulations of Air Pollution Control and Air Quality Management Boards) of the Health & Safety Code; why the Air District amended Regulation 6 Rule 5: Particulate Emissions from Petroleum Refinery Fluidized Catalytic Cracking Units, in November 2021; the criteria of an Air District Heath Risk Assessment; whether the Health & Safety Code has been amended regarding AB 32 (Pavley & Nunez) - California Global Warming Solutions Act of 2006); the quantified cost of health recovery in impacted communities, and how Air District fines and monies from settlements are allocated to those communities; concerns about the differences/abilities between a Community Action Plan and Community Emissions Reduction Plan (within Assembly Bill 617); ways in which the public is engaged within the Air District's rulemaking process; what happens if a proposed regulation is not adopted by the Air District's Board of Directors; the request for rulemaking regarding leaded aviation fuel; the Air District's regulations regarding monitoring air quality; whether the Air District has regulations regarding cumulative impact; the types of fugitive dust that are included in Rules 6-1 and 6-6 (Particulate Matter, Prohibition of Trackout); whether the Air District has a regulation regarding the wastewater of the Port of Oakland; the Air District's definition of "enforceable," regarding regulations, and the suggestion of implementing an official level of community enforcement; concerns about facilities self-reporting and which entities are overseeing quality control of facilities' operations; concerns that fenceline monitoring data is not available to the public; and criminal penalties for non-compliance with regulations.

#### 9. **REPORT OF THE EXECUTIVE OFFICER / AIR POLLUTION CONTROL OFFICER (APCO)**

Dr. Philip M. Fine, Executive Officer/APCO, gave remarks on the following items:

- The following bills are still actively being considered by the California Legislature and are either sponsored or co-sponsored by the Air District: AB 1465 (Wicks) - Nonvehicular air pollution: civil penalties; and AB 953 (Connelly) - Coastal resources: voluntary vessel speed reduction and sustainable shipping program.
- The 2023-24 May Revision to the Governor's Budget includes promising funding for AB 617 implementation.
- The California Air Pollution Control Officers Association (CAPCOA) created an equity group which discusses air district equity programs in California.
- The National Association of Clean Air Agencies held its 2023 Hybrid Spring Membership Meeting on May 9-10, 2023 and Dr. Fine was a panelist discussing environmental justice and Title VI Civil Rights Complaints and Compliance Reviews.

#### 11. COUNCIL MEMBER COMMENTS / OTHER BUSINESS

Council Member Reed asked what existing law would be impacted by the adoption of AB 1465 (Wicks) - Nonvehicular air pollution: maximum civil penalties would impact.

Co-Chair Ms. Margaret Gordon expressed concern for a perceived lack of Air District enforcement between the hours of 5:00pm and 5:00am, as well as on weekends. She requested a workshop about the existing levels of Air District enforcement. She also requested that page numbers be added to future Council meeting agendas, and that a glossary of technical terms that are spoken during staff presentations be provided to the Council.

Council Member Szutu reiterated his request for the implementation of an official level of community enforcement.

Council Member Reed expressed his desire for community policing powers and reiterated his concern for facilities' self-reporting.

Council Member Ruano Hernandez announced that he received an environmental justice college scholarship.

#### BACKGROUND

The Air Quality Complaint Program is one of the Air District's key programs. The Compliance and Enforcement (C&E) Division is responsible for responding to and investigating air quality complaints and ongoing releases of air emissions. The Air District investigates every air pollution complaint received to achieve early intervention in resolving air quality problems and identifying violations of applicable Air District, State, or Federal regulations. Enforcement actions are taken in collaboration with other divisions across the Air District to help address noncompliance and reduce emissions that impact local communities.

#### DISCUSSION

The purpose of the Air Quality Complaint Data and Program Review presentation is to provide an overview of the complaint investigation process, a summary of the air quality complaint data across the Bay Area from 2018 to 2022, explain the factors and variables that influence complaint response and confirmation, and address community questions on how to increase complaint confirmation rates. Active discussion with the Community Advisory Council about the complaint program will be welcomed and encouraged.
