Air District asks public to not burn wood over the Christmas holiday *Wood burning strongly discouraged – burning wrapping paper is prohibited*

SAN FRANCISCO – The Bay Area Air Quality Management District is asking Bay Area residents to not burn wood in their fireplaces or woodstoves over the Christmas holiday to keep air quality from becoming unhealthy.

While air quality is expected to be good to moderate throughout the Bay Area, wood burning during the Christmas holiday can significantly impact localized areas and neighborhoods. Wood burning can also significantly impact indoor air quality.

“We are asking Bay Area residents to forego their fire this Christmas to reduce harmful woodsmoke pollution,” said Jack Broadbent, executive officer of the Air District. “After unprecedented levels of wildfire smoke and increasing Covid-19 health concerns this year, it’s important that the public not burn wood so we can all enjoy clean air and have a healthy holiday season.”

Decorative wrapping paper is manufactured using synthetic inks, plastic film, metallic finishes and other chemicals which release toxic and carcinogenic compounds into the air when burned. The smoke is released into your home and neighborhood where family and friends will breathe it in. **It is always illegal to burn trash, scrap wood and paper.**

A Spare the Air Alert is NOT in effect and wood burning is not illegal. However, wood burning is strongly discouraged at this time.

Like cigarette smoke, wood smoke contains fine particles and carcinogenic substances that make the air unhealthy to breathe. Wood smoke is the major source of air pollution in the Bay Area in the wintertime and is especially harmful to children, the elderly and people with respiratory conditions.
