The Bay Area Air Quality Management District (District) will conduct Compliance Assistance Schools to present and discuss new amendments to **Regulation 8, Rule 20:** *Graphic Arts Printing and Coating Operations*. The Compliance Assistance School is free and will be held from 4:00 pm to 6:30 pm, on Thursday, April 29, 2010 at the BAAQMD Office, 939 Ellis Street, San Francisco, CA 94109.

All graphic arts facilities attending the compliance school will receive a \$75 discount on the initial District Registration fee when completing the registration during the course. (See BACKGROUND for information on the facilities that must register.)

## BACKGROUND

Regulation 8, Rule 20: Graphic Arts Printing and Coating Operations was amended July 9, 2009. This rule regulates traditional printing, such as letterpress, lithographic, flexographic, gravure, screen printing AND now regulates <u>commercial digital printing</u> operations as a type of graphic arts operation. The amended rule includes recordkeeping requirements and also new VOC limits for coatings and solutions. These Compliance Assistance Schools are targeted to Graphic Arts Printing Operations, including commercial digital printing facilities that require registration with the Air District. The facilities required to register are lower volume operations that have monthly emissions of between 75 lbs and 400 lbs of Volatile Organic Compounds (VOC).

# COMPLIANCE ASSISTANCE SCHOOL DISCUSSION

This Compliance Assistance School will review the changes to Regulation 8, Rule 20 as they apply to graphic arts printing and coating facilities:

- New annual registration requirements for graphic arts operations
- Review of recordkeeping requirements
- New VOC limits for coatings and solvents

## **ONLINE REGISTRATION**

The District will have computers available and will provide assistance for attendees to comply with the new registration requirements. A \$75 discount off the initial \$215 registration fee will only be given to graphic arts operators attending and registering at the compliance school.
