Instructions: Dry Cleaner Registration Form

Introduction

Use the following instructions to help guide you through the *Dry Cleaner Registration form*. If you are a new facility (you do not have an existing permit with BAAQMD), please submit a *Facility Creation and Contacts form*.

Registration Qualification

This form should be submitted for all new or previously unregistered dry cleaning machines. To qualify for registration:

- > The dry cleaning machine must use only petroleum or non-halogenated solvent
- ➤ The gross usage of petroleum and non-halogenated solvent from all dry cleaning machines at this located must be less than 200 gallons in any consecutive 12-month period.

If you do not quality for Registration, we may require additional information.

Facility Information

BAAQMD Facility ID - If you are an existing facility, fill out this field so that BAAQMD can associate your changes to your facility. The facility ID is available on your current permit or invoice issued by BAAQMD. It may be referred as a Plant or Site number.

General Information

Device/Operation Name – This is the name you associate to your dry cleaning machine.

Device or Operation Description – This is your description of the device or operation. This field can be used to distinguish it with other similar devices (e.g. ID numbers, location), make, model and other similar information.

Date of Operation – Provide the operational status of your dry cleaning machine, including an initial operation date if currently in use.

Machine Information

Refer to your vendor or equipment documents.

Material Used

List all solvents used for the dry cleaning machine. Refer to your vendor or equipment documents. Most machines operate on one type of solvent.

Fees

To expedite your application, include payment of fees with your application. **The BAAQMD periodically updates fees on July 1st.** We will send you an invoice if fees need to be adjusted. See BAAQMD Regulation 3, Schedule R.
