# PUBLIC NOTICE

TO: Parents or guardians of children enrolled at the following school:  
**Woodside West School**

All residential and business neighbors located within 1,000 feet of the proposed new or modified sources of air pollution listed below.

FROM: Bay Area Air Quality Management District

RE: Permit Application #675165 for the following source of air pollution:

**Emergency Standby Diesel Engine  
Country Manor Lift Station SLS-10

The Bay Area Air Quality Management District (the “Air District”) is a local agency that regulates stationary sources of air pollution such as factories, industrial sites, and gasoline stations.

Whenever we receive a permit application for new or modified sources of toxic air contaminants located within 1,000 feet of a school site, State law requires that we notify the public. To comply with this requirement, we distribute or mail a Public Notice to the parents or guardians of students enrolled at schools located within ¼ mile, and all residents and businesses located within 1,000 feet, of the proposed sources.

You are receiving this Public Notice because a permit application has been filed with the District for the above referenced sources of air pollution. A description of the proposed project follows:

The City of Santa Rosa is proposing the installation of an emergency standby diesel engine at Country Manor Lift Station SLS-10. The proposed engine will power an emergency standby generator that will power pumps at the sewage lift station in the event of an emergency.

***PRELIMINARY EVALUATION***

The Air District has evaluated the permit application for the proposed project and has made a preliminary determination that the project is expected to comply with all applicable Air District, state, and federal air quality-related regulations, including the health risks resulting from toxic air contaminant emissions. The preliminary recommendation is to issue a permit for this project. After considering all comments received, the Air District will make a final determination.
