Emergency Standby Diesel Engine Country Manor Lift Station SLS-10 14261 Country Manor Drive, Santa Rosa, CA 95401

The Bay Area Air Quality Management District (the "Air District") is a local agency that regulates stationary sources of air pollution such as factories, industrial sites, and gasoline stations.

Whenever we receive a permit application for new or modified sources of toxic air contaminants located within 1,000 feet of a school site, State law requires that we notify the public. To comply with this requirement, we distribute or mail a Public Notice to the parents or guardians of students enrolled at schools located within ½ mile, and all residents and businesses located within 1,000 feet, of the proposed sources.

You are receiving this Public Notice because a permit application has been filed with the District for the above referenced sources of air pollution. A description of the proposed project follows:

The City of Santa Rosa is proposing the installation of an emergency standby diesel engine at Country Manor Lift Station SLS-10. The proposed engine will power an emergency standby generator that will power pumps at the sewage lift station in the event of an emergency.

PRELIMINARY EVALUATION

The Air District has evaluated the permit application for the proposed project and has made a preliminary determination that the project is expected to comply with all applicable Air District, state, and federal air quality-related regulations, including the health risks resulting from toxic air contaminant emissions. The preliminary recommendation is to issue a permit for this project. After considering all comments received, the Air District will make a final determination.
