This is to advise you that the Bay Area Air Quality Management District is issuing an administrative amendment to the Major Facility Review permit for the following facility.

The purpose of this amendment is to revise the permit to reflect the recent change of ownership of the refinery by changing the plant name to Martinez Refining Company LLC and changing the Responsible Official from Jeff Harris, General Manager to Jerry Forstell, Refinery Manager. In addition, references to "Shell Refinery" have been deleted from the permit and citations of the EPA consent decree in Table VII – FF have been replaced with citations of permit condition #23559, parts 2 and 3, as appropriate.
