Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. There have been no significant changes in emissions at this facility.

The initial Title V permit for this facility was issued on November 25, 2003. This proposed permit is the first renewal of the permit. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region 9, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of the 45-day US EPA review period, to reconsider the decision to not object to the permit.
