

## NOTICE INVITING WRITTEN PUBLIC COMMENT

**NOTICE** is hereby given that the Bay Area Air Quality Management District is proposing a significant revision to the Major Facility Review permit for the following Facility:

The purpose of the proposed permit revisions is to incorporate the retrofit of tanks S-38 (T-20106), S-40 (T-20108), S-42 (T-20110), S-43 (T-20111), and S-44 (T-3001) with new internal floating roofs. After the retrofit, these tanks will no longer be subject to the continuous monitoring requirement in Permit Condition 6185 because they will no longer be abated by A-421 and A-422 (Activated Carbon/Charcoal Adsorption). This relaxation of monitoring is considered a Significant Revision. The proposed permit revisions also include changes to permit conditions to clarify intent, render existing emissions limits and requirements explicit, and to allow for postponement of annual source testing at S-27 (Marine Loading Terminal) until the next vessel loading event. These revisions are considered Minor Revisions.

All proposed changes to the permit are clearly shown in "strikeout/underline format" and have been addressed in the statement of basis. The Air District invites comment on the proposed significant permit revision. All comments must be received by August 30, 2022. The public may also request a public hearing for this significant revision.

A Significant Revision to a Major Facility Review Permit is also subject to review by US EPA. If US EPA does not object to a proposed permit revision or a member of the public feels that the Air District has not addressed a public comment in a satisfactory manner, the public may, within 60 days after the end of the 45-day US EPA review period, petition US EPA to reconsider their decision to not object to the permit. Petitions shall be submitted to US EPA Region 9, Operating Permits Section, at 75 Hawthorne Street, San Francisco, CA 94105.

The proposed permit and statement of basis are available for public inspection by appointment at the Air District Headquarters, 375 Beale Street, Suite 600, San Francisco, CA, 94105.
