This is to advise you that the Bay Area Air Quality Management District is issuing a renewal of the Major Facility Review (Title V) Permit for Shore Terminals, LLC. (Facility # A0581) pursuant to Application #13149.

The District proposed a Notice Inviting Written Public Comments regarding the renewal MFR permit for this facility on January 10, 2007. No comments were received from EPA or the public.

Comments were received from the facility. In response to the comments, we made the following minor changes to the permit:

- The names of the responsible official and the facility contact.
- Correction to the number "60" instead of "63" in 40 CFR 60 Part XX - National Emission Standards for Bulk Gasoline Terminals from Table IV-D, S22 Gasoline Loading Racks.
