Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. There have been no significant changes in emissions at this facility.

The initial Title V permit for this facility was issued on July 1, 1997 and the permit was renewed on July 26, 2005. This proposed permit is the second renewal of the permit. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region 9, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of the 45-day US EPA review period, to reconsider the decision to not object to the permit.
