Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. There have been no significant changes in emissions at this facility since the current Title V permit was issued.
