NOTICE is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed Renewal of the Major Facility Review Permit for the following facility:

Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. Between 2003 and 2010, actual emissions from this facility increased as follows: 117.6 tons/year of PM10, 29.3 tons/year of CO, 18.3 tons/year of SO2, and 7.4 tons/year of NOx. The PM10 emission increases were primarily due to changes in the emission calculation methodology for the vehicle traffic and active landfilling operations at this site. The CO, SO2, and NOx emission increases were due to increases in the amount of landfill gas combusted at this site. Between 2003 and 2010, actual POC emissions decreased by 4.9 tons/year due to changes in the emission calculation methodology for the waste decomposition process at the landfill.

The initial Title V permit for this facility was issued on November 10, 2003. A description of any subsequent revisions to the permit can be found in Section X of the permit entitled "Revision History". All proposed changes to the current permit are shown in strikeout/underline format.

The Air Pollution Control Officer invites written comment on the proposed renewal Title V permit for the facility listed above. Comments must be received by March 15, 2012. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
