SEMI-ANNUAL MONITORING REPORT 2012 - MAJOR FACILITY REVIEW SUBJECT: **PERMIT - FACILITY 1403**

This report is intended to fulfill the semi annual monitoring requirements of the Major Facility Review Permit (MFRP) issued to the above referenced facility. In addition, the Authority to Construct (ATC), Plant Number: 1403; Application Number: 21686, was renewed before it expired. The renewed expiration date is September 22, 2014. The ATC is for yet to come on line new cogeneration internal combustion engine sources S-200, S-201, S-202 and S-203.

Emissions from three digester/natural gas fueled internal combustion engines; S-29, S-31 and S-35 (formerly S-30) listed in Table VII-C of the MFRP are subject to the monitoring requirements. Since June 1, 1998 at least 2 of the 3 sources have been in continuous operation.

An emissions test was performed on Engine #3 (S-31) on December 20, 2012 by Blue Sky. BAAQMD personnel performed a source test on Engine #1 (S-29) on July 26, 2012. We are pleased to report that emissions from these sources remain below the new 2012 limits imposed by the District on the discharge of regulated air contaminants as listed in the MFRP.

During the reporting period from July 1, 2012 through December 30, 2012 Facility #1403 has experienced no instances of non compliance with any of the applicable regulations, standards or limits as specified in the facility's MFRP. This includes applicable regulations contained in the Authority to Construct for Plant Number: 1403; Application Number: 21686. . .
