Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. There have been no significant changes in emissions at this facility.

The initial Title V permit for this facility was issued on May 11, 1998 and the permit was renewed on August 24, 2005. This proposed permit is the second renewal of the permit.
