The District proposed a minor revision of the Title V permit for facility # A1840 on March 15, 2017. The purpose of this minor revision was to revise the Title V permit to reflect equipment modifications and permit condition revisions that were previously approved under the following NSR applications: 17593, 18127, 18128, 20621, 21424, 21826, and 23888. The Statement of Basis and the proposed Title V minor revision for application #18135 contain a detailed discussion of the proposed revisions to the Title V permit.

The Air District received comments on this proposed minor revision from the facility. The Air District did not receive any comments from EPA or ARB.

The Air District is making the following administrative changes to the Title V permit in response to comments from the facility:

- The responsible official name was changed
- The address of the site was changed
- Table IIA: S-15 - provided a better description of source
- Section VI: page 69, changed allowable decommission of vertical wells from 27 to 26
- Section VI; page 77 for Condition #25293 part 14e: removed "the" from first sentence

The Air District is making the following additional administrative or editorial revisions to the Title V permit:

- Sections IA and III - updated amendment date for Regulation 2 Rule 5 New Source Review of Toxic Air Contaminants - as rule was amended on 12/7/2016
- Corrected the list of sources controlled by A-20 and A-21 in Table II-B, pursuant to Condition # 23220, Part 2
- Updated titles of Tables IV-G and IV-H for consistency with Tables VII-G and VII-H.
