## NOTICE INVITING WRITTEN PUBLIC COMMENTS

**NOTICE** is hereby given that the Executive Officer/Air Pollution Control Officer of the Bay Area Air Quality Management District invites interested persons to submit written public comments on the proposed Renewal of the Major Facility Review Permit for the following facility:

Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility.

The initial Title V permit for this facility was issued on June 13, 2003. The permit was revised on October 7, 2003; this proposed permit renewal represents the second revision. Details of the previous revision can be found in Section X of the permit "Revision History". All changes to the most recent version of the permit are clearly shown in strikeout/underline format.

All emission increases at this facility were discussed in the Statement of Basis for the previous Title V permit revision. The current facility wide maximum permitted emission rates are: 3.2 tons/yr of CO, 2.1 tons/yr of NOx, 0.3 tons/yr of PM10, 0.2 tons/yr of SO2, and 0.1 tons/yr of POC. This proposed permit renewal will not result in any emission increases.

The Executive Officer/Air Pollution Control Officer invites written comment on the above proposed permit renewal. Comments must be received by April 3, 2009. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed significant revision and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the issuance of the permit.
