Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. There have been no significant changes in emissions at this facility.

The initial Title V permit for this facility was issued on March 22, 2000 and the permit was renewed on September 22, 2005. This proposed permit is the second renewal of the permit. A description of any subsequent revisions to the permit can be found in Section X of the permit entitled "Revision History". All proposed changes to the current permit are shown in strikeout/underline format.

The Air Pollution Control Officer invites written comment on the proposed renewal Title V permit for the facility listed above. Comments must be received by August 30, 2012. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region 9, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of the 45-day US EPA review period, to reconsider the decision to not object to the permit.
