Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility.

The Russell City Energy Company, LLC is a major facility because it has the potential to emit more than 100 tons per year each of nitrogen oxides and carbon monoxide.

The Air Pollution Control Officer invites written comment on the proposed initial Title V permit for the facility listed above. Comments must be received by October 7, 2016. Any interested person may also request a public hearing for this permit.

Major Facility Review Permits are also subject to review and approval by US EPA.
