Major facilities are required to obtain operating permits under Title V of the 1990 Clean Air Act Amendments, the Federal Operating Permit Program and the District's Regulation 2, Rule 6 - Major Facility Review. The permits summarize all air-related requirements that apply to each source of emissions at each facility. Major Facilities have the potential to emit pollutants at rates in excess of the Major source thresholds.
