The **Community Air Risk Evaluation (CARE)** program estimates health risks associated with exposure to outdoor toxic air contaminants in the Bay Area and implements programs to reduce emissions and exposure.

The **Bay Area 2009 Clean Air Plan** will identify control measures to continue to improve air quality and public health. The existing air quality plan will be updated to reduce ground-level ozone, particulate matter, air toxics and greenhouse gases.
