**SUBJECT: NOTICE OF INTENT TO ADOPT NEGATIVE DECLARATION PURSUANT TO SECTION 21092 AND 21092.3 OF THE PUBLIC RESOURCES CODE AND CEQA GUIDELINES SECTION 15072**

**Project Title:** BAAQMD Regulation 12, Rule 15: Petroleum Refining Emissions Tracking

**Project Location:** The proposed rule applies within the Bay Area Air Quality Management District ("District"), which includes all of Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, and Santa Clara counties, and the southern portions of Solano and Sonoma counties.

**Project Description:** The District has regulatory authority over stationary sources of air pollution in the San Francisco Bay Area. The proposed project is a new rule to enhance the tracking of petroleum refinery emissions with enhanced emission inventories, help to determine the relationship between crude oil composition and effects on emissions, require additional air monitoring at refinery boundaries and in the surrounding communities, and require that refineries provide certain information related to energy utilization.

Pursuant to the California Environmental Quality Act (Public Resources Code § 21000 et seq.), an initial study for the proposed new rules and amendments has been conducted, concluding that the proposed rules and amendments would not have significant adverse environmental impacts. Notice is hereby given that the Air District intends to adopt a negative declaration for each of the proposed new rules pursuant to Public Resources Code section 21080(c) and CEQA Guidelines section 15070 et seq.

**Public Hearing:** On Wednesday, March 16, 2016 at 9:45 a.m., the Board of Directors of the Bay Area Air Quality Management District will conduct a public hearing to consider adoption of the new rule and the adoption of a Negative Declaration pursuant to the California Environmental Quality Act (CEQA). The hearing will be held in the 7th floor Board Room of the District Office, 939 Ellis Street, San Francisco.
